**PROPOSED RESOLUTION**

**CALLING ON COOK COUNTY TO ASSESS ITS LACTATION ROOMS AND LACTATION ROOM POLICIES IN AN EFFORT TO BEST MEET THE NEEDS OF NURSING MOTHERS IN ITS FACILITIES**

**WHEREAS**, breastfeeding offers proven health benefits for babies and mothers, but women often find it difficult to continue breastfeeding once they return to the workplace; and

**WHEREAS**, according to the Centers for Disease Control and Prevention (CDC), among employed women with children under age 3, approximately 70 percent work full time and one-third of mothers return to work within 3 months after giving birth, and two-thirds return within 6 months; and

**WHEREAS**, challenges to breastfeeding mothers include lack of break time and inadequate facilities for pumping and storing human milk; and

**WHEREAS**, providing accommodations for breastfeeding offers numerous rewards for the employer, in cost savings for health care, reduced absenteeism, employee morale, and employee retention; and

**WHEREAS**, Cook County and its facilities owned or rented are unique in that they must accommodate county employees, workers who are not employed by Cook County but who perform some of their job duties in county facilities, as well as members of the general public; and

**WHEREAS**, many of the challenges facing breastfeeding mothers can be reduced with a small investment of time, money, and flexibility; and

**WHEREAS**, some Cook County buildings and courthouses owned or rented currently have space reserved for breastfeeding mothers, but some challenges remain, and it is incumbent upon this body to evaluate existing resources and see where there is opportunity for improvement;

**NOW, THEREFORE, BE IT RESOLVED** by the Cook County Board of Commissioners that the county shall undertake an evaluation of its current lactation rooms and policies for those rooms, with the goal of having all public buildings owned, ~~and~~ operated or rented by Cook County with a designated private room, other than a restroom, for persons seeking privacy to nurse or express milk, including members of the public where appropriate; and

**BE IT FURTHER RESOLVED**, that the private room shall at a minimum include an electrical outlet, a chair, and a lockable door. Windows, if any, in the private room must have a window treatment appropriate to ensure privacy; and

**BE IT FURTHER RESOLVED**, that the management of each building shall make all building staff aware of the room(s) that have been designated for the use of nursing mothers and what the procedure is should a member of the public request use of the room(s); and

**BE IT FURTHER RESOLVED**, that all public buildings owned, ~~and~~ operated or rented by Cook County post a sign at the building entrance and outside the public restrooms indicating the availability of the designated room and the procedure for accessing it; and

**BE IT FURTHER RESOLVED**, that where a private room cannot be designated without displacing staff or having to construct a new room within the facility, and where another option that would reasonably meet the intent of this resolution cannot be identified, an exception to the requirements of this resolution will be made.

Effective Date. This resolution shall take effect immediately upon adoption.

**PROPOSED RESOLUTION**

**REQUESTING A HEARING OF THE LEGISLATIVE AND INTERGOVERNMENTAL RELATIONS COMMITTEE TO DISCUSS MANDATORY E-FILING AT THE CIRCUIT COURT OF COOK COUNTY**

**WHEREAS**, the Supreme Court of Illinois ordered that Illinois Circuit Courts create an Electronic Filing system (“e-filing”) on January 22, 2016; and

**WHEREAS**, Illinois Circuit Courts were to implement their e-filing system by January 1, 2018; and

**WHEREAS**, the Clerk of the Circuit Court of Cook County entered into a contract with On-Line Information Services in June of 2016 to provide e-filing services; and

**WHEREAS**, in April of 2017, Tyler Technologies signed a \$36 million contract with Cook County to provide court docketing services that would include matters filed through e-filing in the Circuit Court of Cook County; and

**WHEREAS**, to monitor the court docketing services contract, Cook County entered into an agreement with PriceWaterhouseCooper; and

**WHEREAS**, Tyler Technologies informed the Clerk, under a different contract with the Illinois Supreme court, that it would be unable to complete the payment component of the e-filing system by the deadline; and

**WHEREAS**, in a November 25, 2017 article in the Chicago Tribune, Circuit Court Clerk Dorothy Brown stated that her office was prepared for e-filing; and

**WHEREAS**, on December 13, 2017, Cook County Circuit Court Clerk Dorothy Brown petitioned the Illinois Supreme Court to extend the deadline for the implementation of e-filing until January 1, 2018 and to allow permissive e-filing until that time; and

**WHEREAS**, in her petition to the Illinois Supreme Court, Clerk Brown stated that Tyler Technologies has been unable to integrate its e-filing software with currently existing proprietary software in place at the Court and there have been problems with the system's ability to set dates for case management and with bulk filing; and

**WHEREAS**, in response, the Supreme Court gave the Circuit Court an extension of six months until June 30, 2018 to implement the e-filing system and included a number of benchmarks, standards and requirements to be met during the extension period; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Circuit Court Clerk of Cook County and representatives of On-Line Information Services, Tyler Technologies and PriceWaterhouseCooper appear before the Legislative and Intergovernmental Relations Committee of the Cook County Board of Commissioner to review the implementation of e-filing in the Circuit Court of Cook County; and

**BE IT FURTHER RESOLVED**, that the Clerk of the Circuit Court of Cook County be prepared to explain the confusion set forth by the office by initialing indicating that the office would meet the January 1, 2018 deadline for e-filing, only to file for an extension approximately three weeks later.


