**RESOLUTION HONORING THE REMARKABLE LIFE AND LEGACY OF MYLES LEE
REED SR.**

WHEREAS, it is both fitting and proper that the Cook County Board of Commissioners pauses to recognize and celebrate the extraordinary life and enduring contributions of Myles Lee Reed Sr., who was born on January 26, 1925, in Lorman, Mississippi - a man distinguished by an unshakable faith, a profound commitment to community, and a tireless devotion to the uplift of his fellow citizens; and

WHEREAS, Myles Lee Reed Sr., the devoted husband of the late Barbara Nell Wilkerson Reed, was also the loving and guiding patriarch to his children - Myles Lee Jr., Frank, Darryl, Brenda, Ronald, and Claude - exemplifying the virtues of steadfast fatherhood and principled leadership within his family and beyond; and

WHEREAS, as a young man, Mr. Reed migrated to Omaha, Nebraska, where he would embark on the foundational chapters of a life characterized by purpose, resilience, and service. In his formative years, he nobly answered the call of duty, serving in the United States Army, and upon completing his service, availed himself of the GI Bill to pursue higher education. At the University of Nebraska, he pledged the esteemed Kappa Alpha Psi Fraternity, Inc. and earned a Bachelor of Science degree in Physical Education - a testament to his unwavering belief in the power of education and fraternity; and

WHEREAS, in the late 1950s, Mr. Reed relocated to the great city of Chicago, Illinois, where he raised his growing family and continued his dedication to professional and civic advancement. He distinguished himself as a Job Development Specialist and Equal Employment Opportunity Commission (EEOC) Officer, and furthered his advocacy through instrumental roles at institutions such as the Olivet Institute, Jobs Now Project, and the Borg-Warner Corporation - where, notably, he served as one of the first Black executives in the 1960s; and

WHEREAS, Mr. Reed's professional acumen was matched only by his civic engagement, as he worked closely with organizations like the Chicago Urban League and the Ada S. McKinley Foundation to dismantle barriers to opportunity and promote economic empowerment throughout the South Side of Chicago; and

WHEREAS, profoundly civic-minded and deeply invested in the betterment of his community, Mr. Reed twice campaigned for the position of Alderman in Chicago's 21st Ward - a reflection of his enduring commitment to equitable representation and the democratic process; and

WHEREAS, a man of both intellect and athletic prowess, Mr. Reed played semi-professional baseball with the Dukes of the Washington Park Baseball League well into his early forties, and generously shared his expertise and mentorship as a coach of the Orioles of the Jackie Robinson West Little League - nurturing the athletic and personal growth of countless youth in Brainard Park; and

WHEREAS, as a current resident of Chicago's Fifth Ward, Mr. Reed is not only celebrated for the longevity of his life, now having surpassed the remarkable milestone of 100 years, but also for the indelible impact he has made on generations of Chicagoans through his wisdom, moral clarity, and enduring acts of service; and

WHEREAS, his century-long journey through American life bears witness to the transformative power of perseverance, education, family, faith, and public service - qualities that define a legacy which continues to inspire those who have the privilege of knowing him.

HONORING THE LIFE AND LEGACY OF REVEREND DAVID BIGSBY

WHEREAS, David Bigsby was born in Marietta, Georgia, in 1945, and his father was a preacher and a “giver,”; and

WHEREAS, from 1963 to 1967, Mr. Bigsby attended Morehouse College before entering the U.S. Army, where he was a paratrooper serving in Vietnam during the Vietnam War and was awarded a Bronze Star and honorably discharged in 1969 at the rank of staff sergeant; and

WHEREAS, Pastor Bigsby earned a bachelor’s degree in psychology from Northwest Missouri State University in 1975, and after college after college he worked in the insurance field, earning a CLU (Chartered Life Underwriter) designation from American College in 1979; and

WHEREAS, eventually he accepted his calling to preach, something he was born to do, and in 1985, Reverend Bigsby preached his first professional sermon during service on Thanksgiving morning at Calvary Baptist Church in Glenwood, IL and about a decade later, in 1994, he became pastor of the church; and

WHEREAS, Reverend Bigsby would go on to found and lead In the Upper Room Ministries (ITURM) missionary Baptist Church in Lansing, IL; and

WHEREAS, in Lansing, the Reverend may be best known for his involvement in helping to develop a memorandum of understanding (MOU) between the Village of Lansing, Lansing Police Department, Lansing Community Coalition, and the NAACP Chicago Far South Suburban Branch when the Village and police leadership were at odds with community members over an incident in which an off-duty white police officer physically pinned a 15-year-old Black teen to the ground for trespassing on his lawn; and

WHEREAS, Reverend Bigsby fought for social justice in many ways, travelling to the state and national capitols to lobby for legislation and funding that could engender equity in schools and the local community, and he fought against racial profiling and systemic racism; and

WHEREAS, for many years until 2009, Reverend Bigsby served as the president of South Suburban Action Conference, actively pursuing and involved in social, civic, and educational parity in the south suburbs, pushing for issues such as the proposed airport in Peotone; and

WHEREAS, Reverend Bigsby served at some time as president or vice president of the following organizations: South Suburban Action Council, African American Leadership Commission, a national organization dedicated to development of clergy in social justice advocacy, Gamaliel National Clergy Caucus and several other branches of the Gamaliel organization, PEACE “People Engaged in Advancing Community Enrichment” in the South Suburbs, Lansing Ministers Alliance, and the Lansing Community Coalition; and

WHEREAS, for all of his work, in 2023 Reverend Bigsby received the President’s Award from the NAACP Chicago Far South Suburban Branch; and

WHEREAS, Reverend Bigsby enjoyed spending time with his family over the holidays, loved soul food, and was passionate about his Cadillacs, keeping his Eldorado or DeVille in pristine condition; and

WHEREAS, Reverend Bigsby was a good man, a loved man and faithful in his ministry and his church and humble man of God; and

WHEREAS, Reverend Bigsby transitioned into eternity on April 22, 2025. He was married for 53 years to Gloria Bigsby before her death in 2023. He is survived by his son, David Maurice Bigsby (Natasha Bigsby), and his daughter, Ingrid Nicole Colon (John Colon), and four grandchildren and will truly be missed by all.

HONORING THE LIFE AND LEGACY OF DR. CHERYL F. GREEN

WHEREAS, Almighty God in His infinite wisdom called from our midst, Dr. Cheryl F. Green, Governors State University's sixth President, on Wednesday, April 23, 2025, following a lengthy illness; and

WHEREAS, at a young age, Dr. Green learned her life's purpose when she served as a literacy tutor and saw firsthand the disparities in education. She earned her Ph.D. in Psychology and later went on to fulfill her dream of impacting communities by serving students in higher education across several states, including Indiana, Tennessee, and Wisconsin; and

WHEREAS, Dr. Green was passionate about community, education, and student success. For more than thirty years, she devoted her time and talent to transforming lives through the power of higher education and removing barriers to marginalized communities; and

WHEREAS, never one to shy away from a challenge, Dr. Green took the reins as President of Governors State University at the height of the pandemic in July of 2020. As the University's first African American president, she made historic moves elevating the visibility of the institution, while creating opportunities and removing barriers to education; and

WHEREAS, a native of Chicago's South Side, Dr. Green considered the president's role at Governors State University a dream come true and often said it was the culmination of all her life's work. She was

committed to cementing the University's reputation as the "jewel of the Southland" and was known to engage staff and students with humor and candor, empathy and compassion. It was not uncommon for her to use personal funds to assist a student in need; and

WHEREAS, she led the effort to ensure the University established a free-standing Social Justice Initiative to address barriers to social mobility, equity, and justice. The Latinx Resource Center was established under her direction to support and nurture the growing Latinx student population; and

WHEREAS, Dr. Green secured the University's largest private donation in history; created the Honors College and the College of Graduate Studies at Governors State University; and brought the Illinois Black Hall of Fame to Governors State University; and

WHEREAS, the legacy of Dr. Green, a member of Alpha Kappa Alpha Sorority, Incorporated®, will forever live on through her work to establish institutions on campus, including the first Greek-lettered organizations on campus; and

WHEREAS, Dr. Green was committed to making a difference and education was her priority. She also was committed to serving her community through work on several corporate and community boards across the nation; and

WHEREAS, off campus, Dr. Green embraced her passion for the arts and reading that was instilled in her as a child. Dr. Green loved history and often infused speeches with historical references to Black history and Latin American history, as well as quotes from historical giants such as Dr. Martin Luther King, Jr., Nelson Mandela, and Confucius. She was tremendously proud of her two adult children and often spoke fondly of her extensive family; and

WHEREAS, Dr. Green, was a beloved child, sister, mother, friend and has left a lasting legacy of service. She will truly be missed by all.

NOW, THEREFORE, BE IT RESOLVED, that the President and Members of the Cook County Board of Commissioners does hereby honor the life of Dr. Cheryl F. Green as a distinguished member of the community; and

HONORING MICHELLE HARRIS ON THE OCCASION OF HER RETIREMENT

WHEREAS, Michelle Harris has served with distinction as Executive Assistant to Commissioner Donna Miller since the Commissioner assumed office in December 2018, playing a vital role in ensuring the efficient, compassionate, and professional operation of the 6th District office; and

WHEREAS, Michelle's journey in public service began immediately after graduating high school in the 1970s, when a local precinct captain encouraged her to apply for a position at the Cook County Medical Examiner's Office. She accepted the opportunity and began working at the Cook County Morgue, located at 2121 W. Harrison Street in Chicago-a facility later named the Robert J. Stein Institute of Forensic Medicine. Under the leadership of Chief Toxicologist Dr. Michael Schaffer, Michelle served for approximately three years, embracing the role with courage, diligence, and grace; and

WHEREAS, Michelle's career reflects a deep commitment to the public good and civic leadership. Over the years, she has served and supported numerous prominent leaders in government, transportation, and the nonprofit sector, including her work under the Office of the Governor from 2003 to 2007; at Amtrak, where she contributed to State & Local Government Affairs; at the Chicago Urban League from 2007 to 2010, supporting then-President and CEO Cheryl Jackson; and later at AAR from 2010 to 2017, assisting senior leadership in Global Business Development. Her behind-the-scenes excellence and ability to carry out complex responsibilities with precision made her an indispensable asset in every role she held; and

RECOGNIZING "INTERNATIONAL COMPOST AWARENESS WEEK"

WHEREAS, sustainable communities begin with composting, which serves as an effective method of waste reduction, reuse and recycling, helping divert waste from landfills; and

WHEREAS, in 2018, according to the United States Environmental Protection Agency (EPA), only 2.6 million tons of food scraps were composted, compared to 35 million tons that were landfilled; and

WHEREAS, organic materials like yard trimmings, food scraps, pizza boxes and spent coffee grounds can be composted and converted into a beneficial product known as compost; and

WHEREAS, returning organic resources to the soil reduces water consumption across all soil types, decreases reliance on chemical fertilizers and pesticides, lowers greenhouse gas emissions, and diverts waste from landfills; and

WHEREAS, globally and domestically, approximately one-third of all food goes uneaten. In the United States, much of this uneaten food ends up in landfills or sewers, where it decomposes in the absence of oxygen, producing methane; and

WHEREAS, methane is 28 times more effective than carbon dioxide (CO₂) at trapping heat in the atmosphere. Over the last two centuries, methane concentrations in the atmosphere have more than doubled, largely due to human-related activities. Methane is responsible for approximately 30% of the increase in the global temperature since the Industrial Revolution; and

WHEREAS, according to the U.S. EPA, municipal solid waste (MSW) landfills are the third-largest source of methane emissions from human activities in the United States. Food waste makes up 24% of solid waste in landfills, but causes 58% of resulting methane emissions; and

WHEREAS, nationally, greenhouse gas emissions from landfilled food waste are equivalent to the annual emissions of 15 coal-fired power plants, or equal to the energy use of seven million homes; and

WHEREAS, according to the 2023 Illinois EPA report on Landfill Disposal Capacity, the Chicago Metropolitan Region landfills have a lifetime expectancy of eight more years, with 9,763,412 cubic yards of waste reported at the landfills' gates in 2023 alone. When the Chicago region's landfills reach capacity, waste will be hauled to landfills further afield, increasing net diesel fuel emissions from the garbage trucks; and

WHEREAS, composting is a fundamentally local process, as food waste is typically collected and processed near the point of generation. Composting strengthens local economies, reduces methane emissions, and diverts waste from landfills; and

WHEREAS, Cook County supports composting and waste diversion efforts through its Solid Waste Management Plan, which aims to divert 45% of waste from regional landfills by 2030, while advancing a circular economy that keeps materials and products in use for as long as possible; and

WHEREAS, composting supports the creation of green jobs and infrastructure, and enhances community gardens, fostering green spaces that provide fresh produce, recreational opportunities, and community gathering places; and

WHEREAS, May 4th through 10th, 2025, is International Compost Awareness Week (ICAW), an annual educational campaign supported by compost industry organizations around the world, including the Illinois Food Scrap and Composting Coalition. Moreover, State Senator Laura Fine has introduced a resolution in the Illinois State Senate (SR0100) recognizing "Compost Awareness Week" in the State of Illinois.

WHEREAS, he was made a cardinal in 2023 by Pope Francis; and

WHEREAS, Pope Leo XIV has expressed a vision for a Church that is inclusive, led by servant leadership, and unafraid to confront the poverty, conflict, inequality that are all too rampant in our world; and

WHEREAS, according to the National Alliance on Mental Illness (NAMI) 1 in 5 U.S. adults experience mental illness each year; 1 in 20 U.S. adults experience serious mental illness; 1 in 6 youth ages 6-17 experience a mental disorder each year; 50% of all lifetime illness began by age 14 and 75% by age 24; and suicide is the 2nd leading cause of death of children ages 10-14; and

WHEREAS, historic and ongoing disinvestment in Black and Brown communities contributes to disproportionate health outcomes due to factors including lack of access to adequate and affordable mental health services, higher rates of crime, violence and incarceration that result from systemic disinvestment; and

WHEREAS, people with mental health disorders are over-represented in the justice system with the federal Substance Abuse and Mental Health Services Administration reporting 18% of the general population

having a mental illness with 44% of individuals in jails and 37% of individuals in prisons having a mental illness; and

WHEREAS, a broad scope of behavioral health services is needed to support the mental health of our residents, including prevention and early intervention, treatment, recovery and support services, and crisis care; and

WHEREAS, to achieve mental health parity, systems-level collaborative efforts are necessary to improve service coordination across behavioral health, housing and criminal legal systems; and

WHEREAS, Cook County is committed to improving the health and well-being of all residents; and

WHEREAS, the Healthy Communities pillar of the Cook County Policy Roadmap reiterates our commitment to reducing residents' barriers to accessing health services, including a commitment to a public health approach to supporting healthy communities that emphasizes trauma-informed strategies for mental health and community safety, and a commitment to advancing policies and programs that encourage healthy, active living and overall wellbeing through collaboration and partnership with government agencies, community-based organizations, and healthcare providers; and

WHEREAS, Cook County's commitments to strengthening ecosystem of mental health services they have most recently included awarding \$24 million to 31 awardees for the Building Healthier Communities: Behavioral Health Initiative in 2022 and 2023, awarding over \$44 million in grants to 53 organizations for the initiative Stronger Together: Building a More Equitable Behavioral Health System in Cook County in 2024, opening the Mental Health Triage and Stabilization Center at Provident Hospital and the Bronzeville Health Center in 2025, and partnering with the National Alliance for Mental Illness to sustain a Mental Health Hotline for Suburban residents; and

WHEREAS, Cook County remains committed to supporting improved access to mental health services through qualified health care provider agencies and cross-agency collaborations; and

WHEREAS, anyone experiencing mental health challenges, feeling overwhelmed, or just needing someone to talk to can call, text or chat 988, the Nationwide Suicide and Crisis Lifeline.

NOW, THEREFORE, BE IT RESOLVED, the Month of May is recognized as Mental Health Awareness Month in Cook County; and

WHEREAS, anti-Asian policies, from exclusionary immigration policies to the internment of Japanese Americans during World War II, have been prevalent throughout the history of this country including the recent rise in anti-Asian hate has caused great pain, fear and loss; and

WHEREAS, Asian American representation in elected office across Illinois has grown exponentially in the last decade, bringing greater participation and visibility for Asian Americans in government; and

WHEREAS, the Illinois General Assembly, led by the Asian American Caucus, passed the Teaching Asian American Community History (TEAACH) Act in 2021, making Illinois the first state in the nation to require a unit of Asian American history in all public schools; and

WHEREAS, the Cook County Board of Commissioners unanimously passed a Resolution to Stop the Violence against Asian Americans and Pacific Islanders in 2021, the Asian American Data Inclusion Resolution in 2024 and recognized the role of Asian American employees in 2025.


