Re: Proposed Board Item 13-1938 / A Resolution Approving Extension to Previously Authorized Line of Credit

Dear Madam President and Cook County Commissioners:

The Bureau of Finance respectfully submits the attached Resolution, through which the Board would approve an extension on the previously authorized Line of Credit to November 30, 2015 and a reduction in the Line of Credit's draw-cap by \$100,000,000.

RATIONALE: Very competitive market rates present a real advantage to us, in terms of ensuring liquidity in the event of unforeseen or contingent circumstances for an additional year. At the same time, the County's structurally balanced budget, and improved financial practices enable us to reduce the draw-cap, thereby reducing the cost of the Line of Credit itself. The County used the Line of Credit to provide greater flexibility for instance to fund the costs of the Young lawsuit settlement and to prepay those costs rapidly as budget conditions warranted. The extension will allow us to continue to maintain flexibility, while locking in favorable credit costs in today's market.
