**WHEREAS**, Chicago's own Blaq Ice, born De'Andre Hawthorne, is an international, award-winning spoken word poet, cultural icon, and trailblazer whose illustrious career spans more than three decades, during which he has redefined the spoken word genre by fusing poetic expression with neo-soul, jazz, hip-hop, and rhythm and blues; and

**WHEREAS**, Blaq Ice's visionary artistry and dedication to elevating spoken word poetry have captivated audiences across the globe, and in 2025, he achieved an unprecedented milestone by becoming the first poet in history to win both the Chicago Music Awards and the 312 Music Awards in the same year, cementing his legacy as a transformative force in the arts; and

**WHEREAS**, Blaq Ice is the founder of the Chicago Poet Laureate initiative and the CEO and Founder of the National Spoken Word Awards and Festival, held annually in Chicago during the Labor Day weekend,

which draws artists and audiences from across the nation and affirms Cook County as a national hub for spoken word excellence; and

**WHEREAS**, since 2015, Blaq Ice has been a tireless advocate for the national recognition of spoken word as a distinct and vital art form, championing the establishment of Spoken Word Month every September, and is widely regarded as the Father of Spoken Word Month in America; and

**WHEREAS**, through his work with People of Extraordinary Talent (P.O.E.T.), Blaq Ice has made significant contributions to community empowerment by mentoring youth in public schools, establishing transformative spoken word programs in correctional facilities, feeding the hungry, and coordinating clothing drives for individuals experiencing homelessness-demonstrating his steadfast commitment to social justice, youth empowerment, and artistic excellence; and

**WHEREAS**, Blaq Ice has emphasized that while April is recognized nationally as Poetry Month, it predominantly celebrates traditional literary poetry, often excluding the performance-driven, urban-rooted art of spoken word which amplifies the voices of Black, Brown, and underrepresented poets from inner-city communities; and

**WHEREAS**, initiatives such as *Louder Than a Bomb* and *P.O.E.T.* have utilized spoken word poetry to engage at-risk youth in schools, transforming lives through mentorship, creative expression, and community building, offering alternatives to violence and fostering healing through storytelling; and

**WHEREAS**, the formal designation of Spoken Word Month in September will offer Cook County a platform to honor and institutionalize the cultural, educational, and societal value of spoken word, while encouraging intergenerational participation, amplifying local talent, and inspiring civic pride.

**NOW, THEREFORE, BE IT RESOLVED**, we, Bill Lowry, Cook County Commissioner of the 3rd district, and Toni Preckwinkle, President of the Cook County Board of Commissioners, does hereby designate the month of September as Spoken Word Month in the County of Cook; and

**WHEREAS**, in each of America's past wars, our Prisoners of War have represented a special sacrifice. An added burden of loneliness, trauma and hardship has fallen on them. Their burden becomes double where there is inhumane treatment by the enemy in violation of common human compassion, ethical standards and international obligation; and

**RECOGNIZING BLOOD CANCER AND SICKLE CELL AWARENESS MONTH IN COOK  
COUNTY**

**WHEREAS**, the month of September is National Blood Cancer and Sickle Cell Awareness Month, a month-long initiative designated by Congress to help focus attention on the need for research and treatment of blood cancer and sickle cell diseases; and

**WHEREAS**, Sickle cell disease (SCD) is the most common inherited blood disorder in the United States in which red blood cells may become sickle-shaped and harden. For a baby to be born with sickle cell disease, both parents must carry a sickle cell trait or genes. Sickle cell disease is not contagious, and there is no universal cure; and

**WHEREAS**, about 1 in 13 African Americans carry the sickle cell trait, and many do not know they have it, and an estimated 100,000 people in the U.S. have SCD, with approximately 2,000 babies born with SCD annually in the United States; and

**WHEREAS**, people of many ethnic backgrounds can have SCD, but it disproportionately affects Black and Brown Americans, with more than 90% non-Hispanic Black or African American, and an estimated 3%-9% are Hispanic or Latino, suffering from SCD; and

**WHEREAS**, Sickle Cell disease leads to complications including chronic severe and unpredictable pain, anemia, frequent infections, swelling in extremities, fatigue, delayed growth and is one of the underlying medical conditions that causes increased risk for severe illness from the virus that causes COVID-19, defined as hospitalization, admission to the ICU, intubation or mechanical ventilation, or death; and

**WHEREAS**, this national focus is essential and reinforces the National Institutes of Health (NIH) continued support of SCD research, education, and capacity building, including the “Cure Sickle Cell Initiative” to accelerate safe, effective, and scalable gene therapies to cure the disease; and

**WHEREAS**, because of the many advances and medical breakthroughs in genetic therapies and research, we are now closer to finding a cure for all SCD patients in fact a new genetic treatment that was shown in clinical trials to cure 88% of people of the hallmark symptoms of sickle cell disease, has started to be used outside the clinical trial setting; and

**WHEREAS**, the FDA approved new gene therapies in December of 2023. Previously, the only options for people with sickle cell were treatments to manage symptoms or donor stem cell transplants that carry serious risks; and

**WHEREAS**, in July of 2025, the Centers for Medicare and Medicaid Services (CMS) has selected 35 participants for its new, voluntary Cell and Gene Therapy Access Model including the State of Illinois, whereby the federal government has negotiated “outcomes-based agreements” with cell and gene therapy manufacturers for state Medicaid agencies to deliver cutting-edge treatments for people on Medicaid living with sickle cell disease; and

**WHEREAS**, a recent international trial introduced another curative option for sickle cell disease; The therapy, haploidentical bone marrow transplant with thioguanine and posttransplant cyclophosphamide, is as safe and more affordable than the FDA-approved myeloablative gene therapy and gene editing treatments; and

**WHEREAS**, results from the 10-year trial, published June 20<sup>th</sup>, 2024, in the American Society of Hematology journal Blood, show a two-year overall survival rate of 94.1% with no difference between children and adults; and

**WHEREAS**, individuals can still help be part of the solution by donating blood, which is still one of the most valuable treatments for sickle cell patients, but less than 10% of Americans donate blood. Additionally, sickle cell patients benefit most from blood transfusions from people of the same race or similar ethnicity, but only 5% of blood donors are of African ancestry; and

**WHEREAS**, education and research, educating others about sickle cell disease and sickle cell trait, and getting tested for sickle cell trait if you are of African descent and do not know your status are other ways to contribute to this important cause; and

**WHEREAS**, blood cancers include leukemia, lymphoma, myeloma and Hodgkin's disease are one of the world's most prevalent and dangerous cancers, and every 3 minutes, someone in the U.S. is diagnosed with a blood cancer; more than 1.3 million Americans are living with or in remission from a blood cancer; and

**WHEREAS**, blood cancers are the 3rd leading cause of cancer deaths in the U.S., but many people don't know the impact of the blood cancers such as leukemia, lymphoma and myeloma, and despite progress, more than 1/3 of blood cancer patients still do not survive five years after diagnosis; and

**WHEREAS**, giving blood is also important for blood cancer patients, although blood transfusions do not treat the blood cancer itself, they do provide healthy blood cells if your body isn't producing its own, which can help relieve symptoms and side effects; and

**WHEREAS**, additionally for patients diagnosed with leukemia, lymphoma and other life-threatening diseases, a bone marrow or cord blood transplant may be their best or only hope for a cure. However, 70% of patients who need a transplant do not have a fully matched donor in their family, which is why it's important to encourage people to sign up to be a potential donor; and

**WHEREAS**, the disparities faced by blood cancer patients are very similar to the disparities faced in general in the United States with minority groups disproportionately impacted across different blood cancer diseases, including having a higher incident rate. For example, Black Americans have at least double the incidence of myeloma compared to any other race or ethnicity; and

**WHEREAS**, among people under the age of 20, Hispanics have the highest rate of leukemias of all ethnicities and in children, by more than 20%; and

**WHEREAS**, this Honorable Body wishes to promote and raise awareness of Blood Cancer and Sickle Cell Diseases in Cook County and encourage everyone to be a part of this national effort to increase awareness about blood cancer and sickle cell diseases during the month of September and stand united to improve the health of those living with them.

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners, on behalf of the more than 5.2 million residents of Cook County, do hereby take this opportunity to acknowledge Blood Cancer and Sickle Cell Awareness Month; and

**WHEREAS**, DCD has scaled from an early community fridge to a county-wide engine for health equity, with program components including Dream Deliveries (direct home delivery) and the Dream Vault—an Amazon-style locker that allows recipients to retrieve a full produce box using a unique code, extending access and reach of last-mile logistics; and

**WHEREAS**, The Dream Vault earned one of the region's highest honors for innovation—the 2023 Chicago Innovation Award—and has been highlighted by civic and community institutions for modernizing food access infrastructure; and

**WHEREAS**, The organization's measurable impact includes millions of pounds of fresh produce delivered across the Chicago region since 2020 (with more than 5.1 million pounds publicly documented by mid-2025) and sustained service coverage across more than half of Cook County ZIP codes (180+), evidence of county-scale logistics capacity that meets households where they are; and

**WHEREAS**, Chief Dreamer Dion Dawson has been recognized as a TED Fellow, Echoing Green Fellow, Aspen Food Leaders Fellow, and by the Rockefeller Foundation, reflecting national and global acknowledgment of Chicago-born innovation that blends logistics, data, and resident-informed design to transform food access; and he has been tapped by leading institutions for thought leadership and systems change; and

**HONORING FAMILY FOCUS ON ITS 175th ANNIVERSARY**

**WHEREAS**, Family Focus's history of promoting children's well-being by supporting families dates back to 1849; and

**WHEREAS**, Family Focus's rich history is the result of a 2021 merger between Chicago Child Care Society (founded in 1849) and Family Focus (founded in 1976). This merger is the most significant accomplishment of the new Family Focus over the past five years; and

**WHEREAS**, this merger united CCCS and Family Focus' strengths, creating one organization dedicated to early childhood education, youth development, and family support services in under-resourced communities across Northeast Illinois; and

**WHEREAS**, founded more than 175 years ago, Chicago Child Care Society (CCCS) was the longest standing social service agency in Illinois. CCCS first opened its doors as the Chicago Orphan Asylum in 1849, when children were left homeless after their parents lost their lives to a cholera epidemic. Since then, CCCS has served Chicago's children throughout our country's historic events that shaped family needs - the Civil War, the Great Chicago Fire, WWI and WWII, the Korean and Vietnam Wars and the more recent wars in Afghanistan and Iraq; and

**WHEREAS**, in the mid-to-late 20th century, CCCS became well known for its adoption and foster care work and was a highly regarded authority and partner in establishing policies and regulations in the field. In 1974, CCCS celebrated its 125th anniversary by changing its name from Chicago Orphan Asylum to Chicago Child Care Society, better encompassing its responsive and community-centered programming designed to support the needs of the children and families; and

**WHEREAS**, in 1976, from her studies at the University of Chicago, University of Illinois, and Northwestern University, Bernice Weissbourd knew that parent support was key to early childhood development. With funding from her husband, Bernard Weissbourd, and Chicago businessman and philanthropist, Irving Harris, Family Focus opened a space for parent support in a room at the Miller School in Evanston; and

**WHEREAS**, former Evanston Alderman Delores Holmes joined Bernice as the first center director, and Family Focus became a drop-in center for parents with young children to gather. Word quickly spread about a woman who was developing the family support model, which started a pilgrimage of more than 80 other agencies and organizations from across the country sending representatives to Evanston to witness the family support movement in action; and

**WHEREAS**, over the years as needs grew, more centers were founded. Today, the Principles of Family Support are not only a pillar of Family Focus services, but also the field of early childhood development; and

**WHEREAS**, the late 20th century also marked a shift in services from adoption and foster care to early childhood education (ECE) programs, for which Family Focus remains a leader among Chicago agencies in the ECE field; and

**WHEREAS**, currently, Family Focus's 11 centers serve nearly 20,000 mostly low-income participants each year throughout the Chicago neighborhoods of Englewood, Hermosa, Humboldt Park, Hyde Park, South Shore, and Lawndale, and the suburban communities of Aurora, DuPage County, Cicero, Evanston, South Holland, Highland Park, and Highwood; and

**WHEREAS**, Family Focus runs programs designated as Family Advocacy Centers (FACs) in partnership with the Illinois Department of Children and Family Services (DCFS). These centers provide support to parents facing neglect or abuse referrals, offering skills-based parenting classes, parent coaching, and supervised visitation; and

**WHEREAS**, the Family Focus Englewood center has licensed counselors on staff who support families through trauma-informed interventions; and

**WHEREAS**, the organization recognizes the importance of play for children's development, creativity, and social-emotional growth. Family Focus programs use play to help children build a foundation for lifelong learning; and

**WHEREAS**, at its Evanston location, Family Focus collaborates with The Evanston Food Exchange on the Foster Street Urban Agriculture Program. Children in this program learn how to plant, harvest, and sell produce at local farmers' markets; and

**WHEREAS**, Family Focus centers in Aurora, Belmont Cragin, Cicero and Evanston operate as Illinois Welcoming Centers, providing bilingual case management, crisis intervention, referral and follow-up, emergency resource support, and other support services; and

**WHEREAS**, Family Focus centers in Aurora and Cicero serve immigrant and refugee populations in need of citizenship, DACA, and other legal services; and

**WHEREAS**, Family Focus centers in Evanston and Aurora operate as Illinois Welcoming Centers, providing bilingual case management, legal assistance for citizenship and DACA renewal, and other support services; and

**WHEREAS**, the founding philosophy of Family Focus was that parents need a place to connect with others and that all parents can benefit from support. This was evidenced by the demand from both low-income and middle-to-upper-income parents at its first center; and

**WHEREAS**, Family Focus believes in helping parents gain confidence and competence as the primary educators of their children. The organization's approach centers on parents learning for themselves, rather than being "taught"; and

**WHEREAS**, Family Focus officially added "advocacy" to its values in recognition that its work cannot be separate from fighting for social justice and equality for all families.

**NOW, THEREFORE, BE IT RESOLVED**, that Family Focus has made an invaluable impact in the lives of children, their families, and the communities they serve; and

**RECOGNIZING SEPTEMBER AS OVARIAN CANCER AWARENESS MONTH IN COOK  
COUNTY**

**WHEREAS**, ovarian cancer is the fifth leading cause of cancer deaths among women in the United States and causes more deaths than any other gynecologic cancer; and

**WHEREAS**, in the United States, a woman's lifetime risk of being diagnosed with ovarian cancer is approximately 1 in 78; and

**WHEREAS**, the American Cancer Society estimates 20,890 cases of ovarian cancer will be newly diagnosed in 2025 and 12,730 individuals will die from the disease nationwide; and

**WHEREAS**, ovarian cancer is the deadliest of all female reproductive system cancers; and

**WHEREAS**, the five-year survival rate for ovarian cancer is over 90 percent for individuals diagnosed in early stages; and

**WHEREAS**, while mammograms can detect breast cancer and Pap smears may detect cervical cancer, there is no reliable early detection test for ovarian cancer; and

**WHEREAS**, in June 2007, the first national consensus statement on ovarian cancer symptoms was developed to provide consistency in describing symptoms to make it easier for women to learn and remember those symptoms; and

**WHEREAS**, Black women with ovarian cancer are more likely to have late-stage diagnoses, receive lower quality clinical services, and have lower five-year survival rates than non-Black women; and

**WHEREAS**, women of color, low-income women, and women living in rural areas face more barriers to accessing standard quality of care and are more likely to receive care at a facility that has poorer adherence to National Comprehensive Cancer Network (NCCN) treatment guidelines; and

**WHEREAS**, too many people remain unaware that the symptoms of ovarian cancer often include bloating, pelvic or abdominal pain, difficulty eating or feeling full quickly, urinary symptoms, and several other vague symptoms that are often easily confused with other diseases; and

**WHEREAS**, improved awareness of the symptoms of ovarian cancer by the public and healthcare providers may lead to quicker diagnoses; and

**WHEREAS**, half of the women who are diagnosed with ovarian cancer are 63 years or older according to the American Cancer Society; and

**WHEREAS**, the lack of an early detection test for ovarian cancer, combined with its vague symptoms, means that approximately 80 percent of cases of ovarian cancer are detected at an advanced stage; and

**WHEREAS**, persistent issues collecting and reporting data related to ovarian cancer risk, treatment, and outcomes are particularly pronounced and impede the development of effective policy; and

**WHEREAS**, all women are at risk for ovarian cancer, but approximately 20% of women who are diagnosed with ovarian cancer have a hereditary predisposition to ovarian cancer, which places them at higher risk; and

**WHEREAS**, scientists and physicians have uncovered changes in the BRCA genes that some women inherit from their parents, which may make those women 30 times more likely to develop ovarian cancer; and

**WHEREAS**, family history has been found to play an important role in accurately assessing the risk of developing ovarian cancer and medical experts believe that family history should be taken into consideration during an annual physician's visits; and

**WHEREAS**, women who are at risk of ovarian cancer may undertake prophylactic measures, such as opportunistic salpingectomy, to help reduce the risk of developing this disease; and

**WHEREAS**, guidelines issued by the National Comprehensive Cancer Network and Society of Gynecologic Oncology recommend that individuals diagnosed with ovarian cancer receive genetic counseling and genetic testing regardless of their family history; and

**WHEREAS**, studies consistently show that compliance with these guidelines is alarmingly low, with recently published National Cancer Institute-funded research finding that in 2013 and 2014, only one-third of ovarian cancer survivors have undergone testing; and

**WHEREAS**, according to a 2016 consensus report by the National Academy of Medicine, "there remain surprising gaps in the fundamental knowledge about and understanding of ovarian cancer" across all aspects of the disease; and

**WHEREAS**, ongoing investments in ovarian cancer research and education and awareness efforts are critical to closing these gaps and improving survivorship for women with ovarian cancer; and

**WHEREAS**, annually in September, Ovarian Cancer Research Alliance (OCRA) and community partner organizations such as the National Ovarian Cancer Coalition, hold a number of events to increase public awareness of ovarian cancer and its symptoms.

**RECOGNIZING THE ACCOMPLISHMENTS OF WOMEN AS LEADERS AND NATIONAL  
WOMEN'S EQUALITY DAY**

**WHEREAS**, the 19th amendment to the United States Constitution, granting women the right to vote, was ratified on August 18, 1920; and

**WHEREAS**, the fight for electoral equality continued after the 19<sup>th</sup> amendment was ratified, as women of color faced extraordinary barriers to suffrage. African American, Latina, Native American and Asian American women fought for enfranchisement throughout the 20<sup>th</sup> century; and

**WHEREAS**, African American women played an active and pivotal role in the struggle for universal suffrage despite their exclusion from many national suffrage activities and groups. Black women like Maria Stewart, Sojourner Truth, Frances Ellen Watkins Harper, Mary Ann Shadd Cary, Ida B. Wells-Barnett, and many more fought for equal rights for all African Americans throughout the 19<sup>th</sup> and 20<sup>th</sup> centuries. The 1965 Voting Rights Act prohibited racial discrimination in voting, culminating a centuries long effort for suffrage in the African American community; and

**WHEREAS**, Latina women, particularly in New Mexico, were key advocates during the women's suffrage movement. Hispanic suffragists worked with the National Woman's Party (NWP) and other suffragists to champion Spanish-speaking and bilingual women. Discrimination against language minority citizens was still a major barrier for Hispanic women exercising their right to vote. The 1975 extension of the Voting Rights Act prohibited such discrimination; and

**WHEREAS**, historically, Native Americans were not allowed United States citizenship, yet Native American activists like Zitkála-Šá organized and advocated for women's suffrage in the 1920s. In 1924, the Snyder Act gave American-born Native women citizenship, but individual states continued to prevent Native American women from voting as late as 1962; and

**WHEREAS**, first generation Asian Americans were excluded from voting until the Immigration and Nationality Act of 1952 passed, creating a path to citizenship. Asian American suffragists like Dr. Mabel Ping-Hua Lee worked alongside white suffragists in the years leading up to 1920; and

**WHEREAS**, the women's suffrage movement was marked by white supremacy and ignored the intersectionality and compounding oppressions faced by women of color; and

**WHEREAS**, although women have made important gains towards equal opportunity over the last 105 years; sexism, misogyny, and racism have continued to impede progress towards equality; and

**WHEREAS**, women comprise almost half of the U.S. labor force and outnumber men earning bachelor's and master's degrees. However, women are significantly underrepresented in leadership roles in the public and private sectors; and

**WHEREAS**, according to the American Psychological Association, decades of research shows that women in leadership roles increase productivity, collaboration, innovation, and overall fairness. Women in leadership roles help mitigate deep-rooted stereotypes and uphold inclusive spaces; and

**WHEREAS**, today, women constitute just 24% of U.S. Senators, 29.2% of U.S. Representatives, 24% of state governors, and 32.8% of total state legislatures; and

**WHEREAS**, according to research from Harvard University, women make up over 50% of the population in US counties, yet just 27% of county legislators are women; and

**WHEREAS**, Cook County celebrates 105 years of women's suffrage while also acknowledging and uplifting the work of women of color who fought for the same rights for decades after the 19<sup>th</sup> amendment was ratified; and

**WHEREAS**, National Women's Equality Day is celebrated annually on August 26<sup>th</sup>, commemorating the 1920 ratification of the 19th amendment. It also serves to highlight ongoing efforts for gender equality, recognizing both the historic achievements of women and the continuing challenges they face worldwide; and

**WHEREAS**, on Sunday, May 4, 2025, the Cook County Board of Commissioners became a women-majority board for the first time in its history after Commissioner Jessica Vásquez was sworn in as Commissioner of the Eighth District; and

**WHEREAS**, Cook County recognizes the extraordinary perseverance of women leaders and honors the current nine women Commissioners on the Cook County Board: Commissioner of the 1st District, Tara Stamps, Commissioner of the 5th District, Dr. Kisha E. McCaskill, Commissioner of the 6th District, Donna Miller, Commissioner of the 7th District, Alma E. Anaya, Commissioner of the 8th District, Jessica Vásquez, Commissioner of the 9th District, Maggie Trevor, Commissioner of the 10th District, Bridget Gainer, Commissioner of the 12th District, Bridget Degnen, and Commissioner of the 13th District, Josina Morita, and Board President Toni Preckwinkle; and

**WHEREAS**, Cook County recognizes the twenty-three women who historically served on the Board: Anna Bemis, Anna Nowak, Mildred Fleming, Mary McEnerney, Marie Coyle, Amelia Sears, Elizabeth A. Conkey, Lucy Palermo, Lillian Piotrowski, Ruby Ryan, Josephine B. Sneed, Irene C. Hernandez, Mildred Casey Mary Mix McDonald, Rose-Marie Love, Bobbie L. Steele, Maria Pappas, Darlena Williams-Burnett, Earlean Collins, Deborah Sims, Patricia Joan Murphy, and Elizabeth "Liz" Gorman.

**WHEREAS**, the Honorable Daniel Kendrick Davis, born September 6, 1941, in Parkdale, Arkansas, has served the people of Illinois with unwavering distinction, compassion, and intellectual rigor throughout his decades of public service; and

**WHEREAS**, Congressman Davis has maintained a steadfast commitment to education, earning a Bachelor of Arts in History from the University of Arkansas at Pine Bluff, a Master of Science in Guidance from Chicago State University, and a Doctorate in Public Administration from the Union Institute in Cincinnati, thereby laying a foundation of academic excellence that would inform his future in public leadership; and

**WHEREAS**, Congressman Davis began his service to the public as a teacher, community organizer, and health center administrator before rising to elected office, where he served with integrity and vision as a member of the Chicago City Council representing the 29th Ward from 1979 to 1990, and later as a Commissioner on the Cook County Board from 1990 to 1996; and


