Jessica Hooper, Project Director of Reimagining Juvenile Detention and Dr. Kisha Roberts-Tabb, Deputy Chief Probation Officer, Cook County Juvenile Probation will appear remotely to answer questions and follow up on issues raised at the October 7th meeting.

Speaker Biographies: Jessica Hooper Project Director, Reimagining Juvenile Detention

Jessica Hooper recently graduated from The University of Chicago, Harris School of Public Policy with a Master's in Public Policy. During her time at U of C she led The Institute of Politics' Bridge Program, where she oversaw writing workshops within Cook County Jail and IYC St.Charles. Additionally, she oversaw the civic education portion of the program which provided civic education workshops to incarcerated people at Cook County Jail. Off-campus, Jessica worked with the Policy and Strategy Section of the Civil Rights Division at The Department of Justice. While there, she conducted research on police use of AI and advised DOJ officials on her findings. Additionally, she analyzed data on hate crimes committed by youth in the United States. Jessica also has experience working with non-profits, including Illinois Prison Project and Chicago Votes.

Dr. Kisha Roberts-Tabb, Ph.D. Deputy Chief Probation Officer Cook County Juvenile Probation

Community Psychologist Dr. Roberts-Tabb has created and implemented programs while bringing awareness to the Cook County Juvenile Court, including supportive services, gender responsive issues (specifically domestic human trafficking), by developing and implementing mandatory training. As the first Human Trafficking/ Gender Responsive/LGBTQ Specialist and Special Population Program Manager for Cook County Juvenile Probation Department, Dr. Tabb has worked alongside every branch of government, including law enforcement. As a member of Chicago Coalition on Urban Girls, Cook County Human Trafficking Task Force, Cook County Multi-Disciplinary Team, Human Trafficking Housing Pilot with the Administration for Children and Families in partnership with Housing and Urban Development, Dr. Tabb has collaborated on both policy and legislation. Dr.Tabb's knowledge and passion have impacted service providers nationally, sitting before the Congressional Caucus for Black Women and Girls in Washington DC and Chicago Illinois, Cook County Human Trafficking Task Force Conference, Impact Youth, Illinois Department of Juvenile Justice, Cook County Court Clinic, and Illinois Court Judicial Education Conference.
