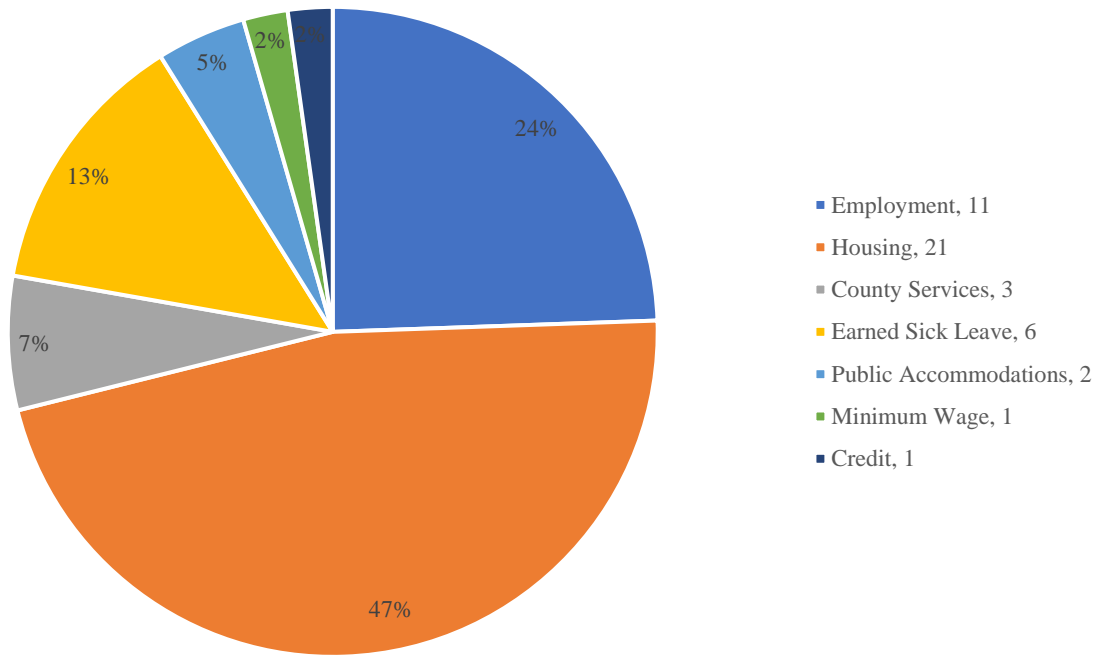

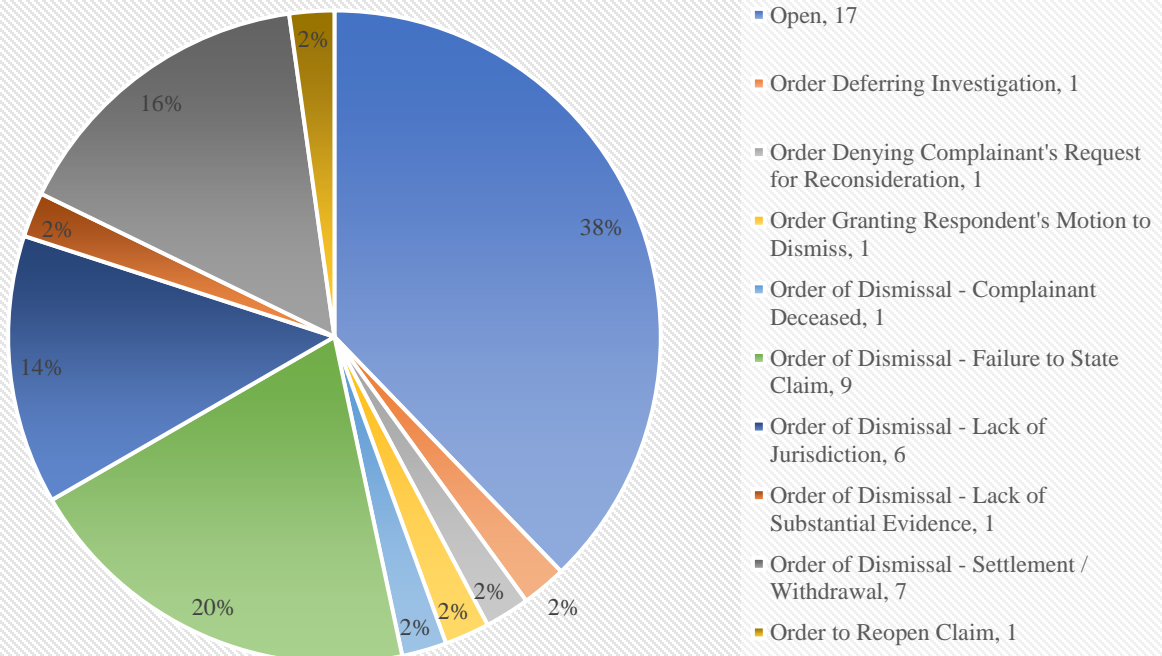
Between March 1, 2023 and May 31, 2023, the Commission facilitated settlements between parties. Settlement amounts were not reported to the Commission.
