WHEREAS, in addition to the jeweler shop, the couple became very active in civic and religious affairs, as lifelong members of St. Philip Neri Catholic Church (St. Josephine Bakhita) and Doris was known for her graciousness; and

## A RESOLUTION TO COMMEMORATE THE VILLAGE OF BERKLEY'S CENTENNIAL ANNIVERSARY

WHEREAS, In 1835 the area that was to become Berkeley was home to farmers, most of German and Dutch Ancestry; and

WHEREAS, In 1836 St. Charles Road, a stretch of roadway from St. Charles to Chicago, was built; and

WHEREAS, In 1845 Peter Bohlander donated land at the southeast corner of St. Charles Road and Taft Avenue for the purpose of burying family, friends and neighbors, and is now known as Old Settler's Cemetery; and

**WHEREAS,** A small group of farm families established a one-room school called Sunnyside in 1848. Now housed in a larger and newer building, Sunnyside Elementary School still operates today; and

WHEREAS, The 1902 completion of the Chicago, Aurora & Elgin Railroad gave the area its first passenger rail service at a stop called Berkeley; and

WHEREAS, The first subdivided plots of land for residential building were advertised for sale in 1908; and

WHEREAS, Residential construction brought new residents, many of whom were English, to the area; and

WHEREAS, Berkeley residents chose to incorporate their community of about 800 citizens by one vote, despite fierce opposition from residents living east of Hillside Avenue, becoming official on May 20, 1924; and

WHEREAS, The village population tripled between 1950 and 1960; and

WHEREAS, The Chicago, Aurora & Elgin Railway ceased passenger service in 1957, however, its route through the village remains as the "Illinois Prairie Path" multi- use nature trail; and

WHEREAS, The picturesque Illinois Prairie Path goes right through Berkeley for those who enjoy hiking or biking; and

**WHEREAS,** Berkeley's land purchase from the railroad in the 1960s extended its northern boundary, allowing for the addition of a small industrial park; and

WHEREAS, Having been based there since 1950, Berkeley boasts a global leader among its small base of industries: World Dryer Corporation, one of the largest manufacturers of the hand dryers used in public restrooms worldwide; and

WHEREAS, Berkeley has remained predominantly a residential community and a convenient place to live in terms of transportation; and

**WHEREAS,** The transportation corridors that make Berkeley accessible to distant places also serve to separate the village from its nearest neighbors, creating a small-town atmosphere; and

**WHEREAS,** The Village of Berkeley is a great place to live with safe, well-maintained neighborhoods, enriching activities, entertainment, and a diverse group of people to call neighbors; and

WHEREAS, These traits continue to help Berkeley strive for A Bright Future; and

WHEREAS, The Village of Berkeley is proud to celebrate its Centennial Anniversary in 2024.

**NOW, THEREFORE BE IT RESOLVED,** that Cook County Commissioner Sean M. Morrison and the entire Cook County Board extends its heartiest congratulations and well-wishes to the Village of Berkeley on their 100th year of incorporation, wishing them continued success and "A Bright Future" in all the years to come; and

**WHEREAS,** the SOS's commitment extended beyond housing advocacy, as they fought for quality education for Chicago students, particularly those from blighted communities, leading to the establishment of the Sojourner Truth School; and,

**WHEREAS**, the Sisters of the Struggle collaborated with diverse groups from all parts of the city, including Uptown and Humboldt Park, fostering unity and solidarity in the pursuit of social justice; and,

**WHEREAS**, the SOS's enduring legacy continues to inspire current and future generations to advocate for equity, justice, and the betterment of their communities; and,

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners, on behalf of the residents of Cook County, honor and celebrate the impactful legacy of the SOS, recognizing their pivotal role in shaping a more equitable, just, and compassionate Cook County; and,

#### **PROPOSED RESOLUTION**

#### ACKNOWLEDGING LUPUS AWARENESS MONTH

WHERAS, in 1851 Lupus was defined as an autoimmune disease. Documented research leads to the advancement of the understanding and diagnosis of lupus as an autoimmune disease. There is no known cause of lupus, and;

WHERAS, women ages 15 to 44 of certain racial or ethnic groups including people who are African American, Asian American, Hispanic/Latino, Native American, or Pacific Islander People who have a family member with lupus or another autoimmune disease are gravely impacted, and;

WHERAS, this inflammatory disease is caused when the immune system attacks its own tissues and affects the overall well-being of the person in many ways. It also impacts the physical, emotional, and economic aspects of a person's life, and;

**WHERAS**, the history of lupus, although dating back at least to the Middle Ages, has experienced an explosion in this century, especially during the modern era over the past 60 years. It is hoped that this growth of new knowledge will allow a better understanding of immunopathogenesis of the disease and the development of more effective treatments, and;

WHERAS, over the last decade or so, there have been significant advances in the understanding of the genetic basis of lupus, and of the immunological derangements which lead to the clinical manifestations of the disease, and;

**WHERAS,** advances have been made in the assessment of the impact of the disease in general, and in minority population groups, in particular and efforts are being made towards defining lupus biomarkers which may help both to predict disease outcome and to guide treatments, and;

WHERAS, during the month of May the lupus community join together annually to raise awareness of the physical, emotional and economic impact of lupus, while raising funds to support lupus research, care, support services, and educational resources and programs, and;

WHERAS, purple is a combination of red and blue - the color red represents passion/motivation, and the color blue evokes a sense of calmness. Thus, purple is the color for lupus as it is the perfect blend of colors that represent the characteristics required to fight lupus. A purple butterfly is also the symbol for lupus, and;

WHERAS, Ms. Patricia Ann Betts had a very strong faith in God and shared a special bond with her family and friends. She cared deeply for people and expressed and immerse willingness to care for others, and;

WHERAS, Ms. Betts lost her battle with lupus on January 19, 2024, at the age of 53. Her life and legacy are a testimony of resilience and endurance, and;

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners, on behalf of the residents of Cook County, does hereby acknowledge May as National Lupus Awareness Month and honors those in search of a cure and live with disease every day, and;

**BE IT FURTHER RESOLVED**, that a copy of this Resolution be archived as a token of the esteem held by the President of the Cook County Board of Commissioners and the Cook County Board of Commissioners.
