Neighbors for Affordable Housing proudly stands with 60+ organizations in support of the Residential Tenant Landlord Ordinance.

This ordinance is critical to ensure that all tenants in Cook County have procedures in place to protect themselves, including from harmful conditions in their homes. Some of the most important protections are those that protect tenant safety and health, especially in communities of color. This includes encouraging landlords to make repairs and fix harmful conditions.

Sadly, we've heard complaints from renters that they have experienced retaliation such as rent increases or even eviction notices when asking their landlord for basic repairs or to address code violations. This is unacceptable, and the Cook County RTLO will prohibit retaliatory conduct against a tenant who is asserting their rights.

It's also important to consider that this ordinance is not a new, unknown, or unfamiliar set of protections. Renters have had these rights for over 30 years in Chicago and the Chicago RTLO has been proven to protect them. We've had three decades of guidance and direction to support landlords' compliance. Questions about the law have been tested in the courts. We know it works. We've seen the benefits. We've seen firsthand how it helps people navigate the system, and enable healthy and thriving communities. It's clear that Chicago's RLTO has not held back the housing market, and housing providers have not been driven away. The Chicago RLTO did not spell doom for the city, and an RTLO for suburban Cook County will not be any different.

And so the moment is here to take action to care for our communities. And let's remember that equity is one of Cook County's core values, and a strong RTLO is what equity looks like. It's what housing justice looks like. We make those words real when we pass ordinances like this.

For equity and justice in Cook County means consistent access to stable and secure housing. It means resources, rights and protections for everyone, but especially those most in need and who are most vulnerable.

That is why we need this ordinance. And we need it now. Thank you.

renter households live in Cook County communities that lack comprehensive landlordtenant laws. They lack protections to prevent:

- Taking away basic rights, such as the right to termination notices and jury trials
- Unreasonable fees, such as fees of \$100 per month for late rent payments
- · Illegal lock-outs
- Retaliation

For thirty years, renters living in Chicago, Evanston, and Mount Prospect have benefited from municipal ordinances defining basic landlord-tenant rights and responsibilities, and the rental markets in these communities have thrived.

South Suburban Housing Center (SSHC) is the regional fair housing and HUD-approved counseling agency serving the south and southwest suburbs of Chicago. I am writing you on behalf of our agency to ask for your support of the Cook County Residential Tenant Landlord Ordinance (RTLO, Item #20-3562), introduced by Commissioners Scott Britton and Kevin Morrison.

Our organization provides legal support to people experiencing discrimination and other forms of mistreatment in the housing realm. Currently, there is no comprehensive tenant-landlord ordinance covering our Cook County service area. Passing a strong countywide ordinance will increase stability for both renters and landlords by clarifying their roles and responsibilities to make the rental process easier and fairer to navigate.

We are also experiencing an influx of calls from renters in distressed housing situations because of COVID-19 income disruptions. These tenants require additional protections to allow them to sustain their housing threatened by pandemic circumstances beyond their control. The proposed ordinance will:

- Prohibit lease terms that waive the basic tenant right to notices, require renters to "confess judgment" without a trial, or allow landlords to charge exorbitant interest rates on late payment of rent
- Improve on procedures for renters to withhold rent until building condition problems are addressed
- Create a course of action to enforce renters' rights not to be locked out and provide guidance on when landlord entry is permitted
- Require security deposits to be maintained separately and returned to renters, prohibit excessive security deposits, prevent landlords from renaming security deposits "move-in fees" so as to keep them, and set up penalties when security deposits are not returned

This law will also help further racial equity in Cook County. Black, indigenous, and people of color are disproportionately impacted by a lack of regulatory protections for tenant landlord engagement. The RTLO will be a positive step for racial justice, as well as strengthen our agency's work towards achieving a unitary housing market that eliminates discrimination and fosters stable, long-term diverse communities.

To the Board of Commissioners of Cook County,

My name is Donald Gross. I am a resident of Midlothian, and a member of the Party for Socialism and Liberation.

Safe and sanitary housing is a human right.

In Cook County, we have apartment buildings with access stairs to front doors that have collapsed. Landlords refuse to answer the phone calls of tenants asking about the lack of heat. Pests such as rats or cockroaches are a common occurrence. I have relatives who have walked away from leases because they were overwhelmed by late fees their landlord imposed. These conditions make it obvious that Cook County is a long way from having secure housing as a human right.

The Residential Tenant and Landlord Ordinance will help clarify the rights and protections of tenants in Cook County, and it should be passed and implemented as soon as possible. Even when passed it will take tenants organizing together to actually get landlords to acknowledge the rights and protections in the ordinance.

The RTLO will not make housing a human right in Cook County, but it'll give working and poor people in the county a new tool with which to organize. It's a shameful indictment of

our current political and economic system that it took a devastating pandemic to get an ordinance like this seriously considered. Even in these circumstances, it has been watered down to appear real estate interests.

The struggle for housing is larger than the Cook County Board can completely address. Right now, we need the state or federal government to step in and cancel rents and mortgages for the duration of the pandemic. Ultimately, making housing a human right will require ending commodified housing, and the extraction of profit from people just trying to have a place to live.

Everyone deserves a safe and clean home to live in, and I hope the Cook County Board begins to recognize that right today.
