

### 2. Inquiries by Subject Matter - Fourth Quarter FY2025







Between September 1, 2025, through November 30, 2025, the Commission facilitated settlements between parties. \$2,802.00 in settlement was reported to the Commission.

No complaints resolved during this quarter were Just Housing Amendment complaints.

The Cook County Department of Human Rights and Ethics (DHRE) was unable to discover or develop information on any denials of housing based upon demonstrable risk to personal safety/property of others pursuant to Cook County Ordinance 42-38(e) and 42-34(e) during this time.
