Report Title: FY2020 Preliminary Forecast

**Report Period:** 6/1/2019 -11/30/2019

**Summary:** For Fiscal Year 2019, DBMS anticipates a budget surplus of \$14.9 million in the County' General Fund. The Health Fund anticipates a \$103.1 million shortfall.

The Fiscal Year 2020 outlook includes a \$11.9 million shortfall projected in the General Fund and a \$6.8 million shortfall in the Health Fund, creating a total operating funds projected deficit of \$18.7 million.
