# HONORING THE LIFE AND CONTRIBUTIONS OF GOV. JIM EDGAR

WHEREAS, As the 38th Governor of Illinois, Jim Edgar inherited what was then the largest deficit in the state's history. He eliminated a backlog of \$1 billion of unpaid health care bills. He provided income tax relief and left an unprecedented \$1.5 billion in the treasury for his successor;

WHEREAS, Edgar started his state government career in 1968 as a top aide to leaders in the Illinois House and Senate. From 1975 until 1976, he was director of state services for the National Conference of State Legislatures in Denver. He was then elected to the Illinois House from Charleston in 1976 and 1978. In 1979 and 1980, he was director of legislative affairs for Gov. Jim Thompson, who appointed him as secretary of state when a vacancy occurred. Edgar was elected in 1982 and re-elected in 1986 by the largest plurality ever amassed by a statewide candidate;

WHEREAS, Edgar was elected governor in 1990 and re-elected by the widest plurality of any incumbent Illinois chief executive has received, carrying 101 of the state's 102 counties, including Cook. His announcement that he would not seek a third term surprised the Illinois media and political insiders who cited poll numbers that indicated he had earned the highest approval rating of any Illinois chief executive and was in a strong position to win again;

WHEREAS, his record as governor built on his accomplishments as secretary of state, where he led a crackdown on drunk drivers, developed an adult literacy program that became a national model and won a hard-fought battle to win General Assembly approval of legislation requiring motorists to carry insurance;

WHEREAS, Edgar also reformed welfare through innovative initiatives to move recipients from dependence to independence. He saved homeowners billions of dollars by proposing and winning legislative approval for caps on property taxes. He fought for - and won -- legislation to establish an adequate funding level for each school child in Illinois. He and First Lady Brenda Edgar won national recognition for their adoption initiative that took Illinois from the bottom to the top among states in placing children in loving homes;

WHEREAS, after retiring from elective office, Edgar was a resident fellow at the John F. Kennedy School of Government at Harvard in 1999. Since then, he continued his commitment to responsible and responsive government as a distinguished fellow at the University of Illinois' Institute of Government and Public Affairs. He spearheaded the Edgar Fellow program, which brings together emerging leaders from all parts of Illinois to foster the statesmanship that will address major challenges across regional, partisan and ethnic lines;

WHEREAS, Edgar also lectured students at the U of I and in colleges and universities throughout the state and serves on several corporate and non-profit boards. He is president emeritus of the Abraham Lincoln Presidential Library Foundation;

WHEREAS, in human services, Edgar revolutionized the delivery of programs to families by reorganizing the functions of six agencies, by initiating a program to provide medical coverage to children of the working poor and by establishing sweeping welfare reforms long before Washington acted. As a result, caseloads fell and nearly 200,000 families moved from welfare rolls to payrolls, a 50 percent reduction;

WHEREAS, his economic development strategies helped the state through the recession of the early 1990s and positioned Illinois as a national leader in economic recovery. During his administration, the number of Illinoisans working rose by 600,000 and the Illinois unemployment rate reached it lowest level in nearly three decades;

WHEREAS, his environmental record was unparalleled in Illinois history. The state acquired more acres of land for open space and recreational use than ever before. For his efforts, which led many to call him the "conservation governor," Edgar received the Nature Conservancy of Illinois' Lifetime Achievement Award in 1998. While steadfastly seeking a healthy environment, Edgar sought to balance that goal with the need for a healthy economy. Under Edgar's leadership, Illinois became a national trendsetter in solving environmental problems at less cost to businesses and taxpayers;

WHEREAS, he served in a variety of national leadership roles -- president of the Council of State Governments, chairman of the Education Commission of the States and chair of committees on economic development and education in the National Governors' Association. Edgar also served on the executive committee of the National Governors' Association and chaired the Midwest Governors' Association;

WHEREAS, Edgar was born July 22, 1946, in Vinita, Oklahoma, and moved to Illinois as a youngster. He was educated in Charleston public schools and graduated from Eastern Illinois University, where he majored in history and was elected student body president. He and the former Brenda Smith of Anna have two children, Elizabeth and Brad. Elizabeth is the parent of grandchildren Jake Lowe, who just graduated from George Washington University, and Cecilia Lowe, who is a student at the University of Puget Sound. Brad and his wife, Stacey, are the parents of the other three grandchildren, Dakota and Cali Ann, who graduated from the University of Colorado, and Ellie, who graduated from the University of Wyoming; and

**NOW, THEREFORE, BE IT RESOLVED**, that the President and the Cook County Board of Commissioners do hereby honor the life and legacy of Gov. Jim Edgar for his immeasurable contributions to the State of Illinois

**WHEREAS**, studies indicate that 44-72 percent of service members experience high levels of stress during transition from military to civilian life; and

WHEREAS, active military service members transitioning from military service are at a high risk for suicide during their first year after military service; and

WHEREAS, the National Association of Counties encourages all counties, parishes and boroughs to recognize Operation Green Light for Veterans; and

WHEREAS, Cook County appreciates the sacrifices of our United States military personnel and believes specific recognition should be granted; and

**NOW, THEREFORE, BE IT RESOLVED,** that the President and the Cook County Board of Commissioners do hereby declare from November 4th through November 11th, 2025, as a time to salute and honor the service and sacrifices of our men and women in uniform transitioning from active service; and

**BE IT FURTHER RESOLVED**, that in observance of Operation Green Light, Cook County encourages its citizens in patriotic tradition to recognize the importance of honoring all those who made immeasurable sacrifices to preserve freedom by displaying green lights in a window of their place of business or residence from November 4th through November 11th, 2025.

# **COOK COUNTY RECOGNIZES VETERANS DAY ON NOVEMBER 11, 2025**

**WHEREAS,** Veterans Day, formerly known as Armistice Day, was originally proclaimed a holiday on November 11, 1919 by President Woodrow Wilson to honor the end of World War I; and

WHEREAS, November 11, subsequently declared a legal holiday in 1938, was "dedicated to the cause of world peace and to be hereafter celebrated and known as "Armistice Day". In 1954, at the urging of veterans' organizations, the 1938 Act was amended by replacing Armistice Day with Veterans Day; and

WHEREAS, from the Revolutionary War to the present day, the contributions made to the United States of America by her citizen soldiers, sailors, marines and airmen who stand in our place to defend the freedoms we enjoy cannot be calculated; and

WHEREAS, Cook County has the largest veteran population in this state with over 137,000 veterans; and

WHEREAS, Cook County has always honored the immeasurable wartime and peacetime contributions and sacrifice of the men and women of the United States Armed Forces; and

WHEREAS, Americans still give thanks to veterans for their service on Veterans Day with ceremonies and speeches and at 11 a.m. many Americans observe a moment of silence in remembrance of those who fought and for those who gave their lives to preserve the freedom we now enjoy; and

WHEREAS, the willingness of our citizens who have answered the call to duty to give freely and unselfishly of themselves, in defense of our democratic principles, gives this great nation continued strength and vitality; and

WHEREAS, even today, members of the military are stationed throughout the world, while their families remain in our communities; and

WHEREAS, families praying for the safe return of loved ones experience everyday life in a very different way than others, as their everyday thoughts and feelings never stray far from those they honor and are proud of for serving this great nation; and

WHEREAS, the willingness of our citizens who have answered the call to duty to give freely and unselfishly of themselves, in defense of our democratic principles; and

WHEREAS, Veterans Day is a day set aside to thank and honor living veterans who served honorably in the military for their service - in wartime or peacetime; and

WHEREAS, the commemoration of this day is a matter of historic and patriotic significance to all American citizens; and

**NOW, THEREFORE, BE IT RESOLVED,** that the President and the Cook County Board of Commissioners do hereby recognize November 11, 2025, as Veterans Day and ask that on this day of honor all citizens express their gratitude to our veterans; and

**BE IT FURTHER RESOLVED,** with respect and gratitude, we salute all our veterans, remembering "all gave some and some gave all" and devote special attention to those veterans who are sick and disabled, and show them through our actions that we remember and honor them.

# RECOGNITION OF OCTOBER 2025 AS MANUFACTURING APPRECIATION MONTH IN COOK COUNTY ILLINOIS

WHEREAS, Cook County utilizes a sector driven economic development strategy and prioritizes and invests in sectors like manufacturing that offer relatively low barriers to entry and good jobs with strong career pathways; and

WHEREAS, Cook County proudly recognizes that Chicagoland has the second largest manufacturing sector in the nation and has been recognized for its strength in metals fabrication, machinery and equipment manufacturing, casting and forging along with food processing, plastics and chemicals manufacturing; and

WHEREAS, In 2022, the Department of Defense recognized northeastern Illinois as the nation's leader in the production of forged and stamped parts with the greatest business density and largest forging and stamping workforce of any US metro area in the nation; and

WHEREAS, Cook County participates in The Illinois Defense Manufacturing Consortium (ILDMC) which brings together stakeholders from industry, community, government, and academia to strengthen the casting and forging sectors in northeastern Illinois; and

WHEREAS, Cook County has prioritized promoting and supporting the manufacturing sector, working to expand the support, resources, and benefits these businesses receive from the county through M3 Chicago, which advances equitable and sustainable development by helping manufacturers expand, collaborate, network, innovate and hire; and

**WHEREAS,** Cook County recognizes that manufacturing provides quality jobs and positive economic impact and has committed nearly \$7 million in ARPA funding to help manufacturers thrive, expand, innovate as well as access and develop needed talent; and

WHEREAS, some of Cook County's manufacturing programs include Manufacturing Reinvented that reimbursed manufacturers countywide up to \$25,000 in eligible expenses toward the implementation of projects designed to improve productivity, develop future leaders, provide workforce training, and support business growth; and

WHEREAS, additionally, the Metals Hub is a Cook County collaborative created in partnership with the Southland Development Authority to help the metals, machinery, and equipment (MM&E) industry diversify, grow and innovate; and

WHEREAS, Cook County's Elk Grove Village is home to the largest industrial park in the United States with over 62,000,000 square feet of inventory, 5,600+ businesses, 22 data centers, and over 400 manufacturers who specialize in plastic, metal, food, tech, and more; and

**WHEREAS**, the National Association of Manufacturers has designated October 3, 2025, as National Manufacturing Day and October as Manufacturing Awareness and Appreciation month; and

WHEREAS, as manufacturers seek to fill 4 million high-skill, high-tech and high-paying jobs over the next decade, MFG Month empowers manufacturers to come together to address their collective challenges and build excitement about manufacturing careers so they can help their communities and future generations thrive; and

WHEREAS, Cook County's manufacturers, educational institutions, training providers and organizations furthering manufacturing research and innovation in Cook County will host events throughout the month of October to showcase the skilled and well-paying jobs afforded by a career in manufacturing, to ensure the continued growth of the manufacturing industry; and to celebrate our regional strength, our collaboration and partnerships benefiting this critical sector.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby declare October 2025 Manufacturing Month in recognition of all the major contributions manufactures give to our communities every day.

**WHEREAS**, Stanley D. Moore will be remembered in history as the Godfather of the census, an impressive 60 years in census leadership in the United States Department of Commerce.

WHEREAS, Stanley D. Moore is a native of Washington DC; and

WHEREAS, Stanley D. Moore began his life's work for the United States Census Bureau on July 24, 1960, as a systems computer analyst. As a young computer programmer, he was one of the first in the country to work on the historic UNIVAC Mainframe computer. He served as District Office Manager, Special Assistant to the Chief, Assistant Regional Director, Associate Director for Field Operations, Regional Director and finally National Advisor to the Director; and

WHEREAS, Stanley D. Moore was instrumental in developing the Topologically Integrated Geographic Encoding and Referencing system (TIGER), a technologically advanced database system that is used nationwide for mapping geographic data. TIGER has become an essential component in the compilation and tabulation of census data. It is the very tool that gave us the ability to create Global Positioning Systems also known as GPS; and

WHEREAS, Stanley D. Moore was appointed Regional Director of the Chicago Regional Office of the U.S. Census Bureau in 1974. As Regional Director, he was responsible for overseeing all census operations in Arkansas, Iowa, Illinois, Indiana, Michigan, Minnesota, Missouri, and Wisconsin; and

WHEREAS, Stanley D. Moore was instrumental, in the 1970's, in the desegregation of Chicago housing. He fought a successful four-year legal battle against racial discrimination. In recognition of this fact, he was selected as a Most Valuable Community Player by the Leadership Council of Metropolitan Open Communities; and

WHEREAS, Stanley D. Moore, along with his wife, raised their children and have lived in Beverly for 42 years. Because of his contributions to the community, the street in which he lives was renamed, "Stanley D. Moore Way"; and

WHEREAS, Stanley D. Moore has received numerous awards for his service at the Census Bureau including the U.S Department of Commerce bronze medal for superior services, The U.S Department of Commerce silver medal award for meritorious service, the U.S Department of Commerce gold medal

award for exceptional service, and the national partnership for re-inventing government Hammer Award; and

WHEREAS, Stanley D. Moore, through his talents and efforts have helped our success with the census, and together, we take pride in your accomplishments and your commitment to excellence; and

**BE IT RESOLVED** by the Board of Commissioners of Cook County that the Board does hereby extend its congratulations to Stanley D. Moore on his 90th Birthday, and extends its gratitude on behalf of Cook County for his outstanding service over the years, and

Their Spring Concert on May 8, featuring collaborations with the Drum Line and beginning music classes, drew a festive and enthusiastic audience despite ongoing renovations to the Leo Auditorium. Days later, their resonant voices enhanced the grandeur of Leo's 89th Commencement at St. Margaret of Scotland, followed by spirited appearances at community programs in Ukrainian Village and Auburn Gresham. Their work not only uplifts audiences but also sustains the cultural life of neighborhoods across Chicago; and

WHEREAS, the Leo Choir's prominence grew through headline performances at venues such as Holy Name Cathedral, the Four Seasons Hotel Scholarship Benefit, and corporate and civic celebrations, as well as their tradition of inspiring Christmas concerts that fill the Leo Auditorium to capacity bringing hope and joy to countless families. Residents enjoyed the Leo Choir's music at Wrigley Field, Guaranteed Rate Field, and even before Pope Leo XIV's Mass, solidifying their reputation as cultural emissaries of Chicago's South Side; and

WHEREAS, what began as affectionate hyperbole in calling them "world renowned", through the dedication of its student vocalists and the visionary leadership of Ms. Hill, became an increasingly accurate description. Averaging more than sixty public performances annually, the Choir became one of the most in-demand youth ensembles in the region; and

WHEREAS, in 2024 the Choir's reputation reached new heights when their local performances caught the attention of national producers, ultimately earning them an invitation to audition for NBC's *America's Got Talent*. Their March performance, broadcast to millions in June 2025, captivated the show's celebrity judges, including the famously exacting Simon Cowell, who responded with uncharacteristic delight at the Choir's stirring harmonies; and

WHEREAS, building upon their national success, the Leo High School Choir advanced through the rigorous stages of the *America's Got Talent* competition, ultimately reaching the finals and achieving a distinguished 4th place finish, an accomplishment bringing immense pride to Leo Catholic High School, the South Side of Chicago, and Cook County as a whole; and

WHEREAS, this ensemble of twenty-two young men from Chicago's South Side not only earned a coveted spot in the quarterfinals of *America's Got Talent*, but also demonstrated to the nation the extraordinary cultural talent nurtured within Cook County's schools. Their artistry is not merely entertainment, it is testimony to the transformative power of music, the resilience of Leo's young men, and the leadership of mentors like Ms. LaDonna Hill and Coordinator Yolanda Sandifer Horton; and

WHEREAS, the Leo Choir's ascent from neighborhood concerts to a national stage represents a triumph of dedication, talent, and community support. In their journey, they carry the legacy of Leo Catholic High School and the hopes of their families and neighborhoods, inspiring others with the reminder that greatness can spring from humble beginnings and resonate on the world stage.

#### PROPOSED RESOLUTION

#### RECOGNIZING SOCIAL MEDIA SAFETY DAY IN COOK COUNTY

WHEREAS, social media can be a force for the greater public good, providing a means for beneficial entertainment, education, socialization, and advocacy; and

WHEREAS, social media has also demonstrably caused significant and widespread harm to the public, especially children; and

WHEREAS, the U.S. Surgeon General issued a warning on May 23, 2023, stating that "there are increasing concerns among researchers, parents and caregivers, young people, healthcare experts, and others about the impact of social media on youth mental health" with such concerns including anxiety, eating disorders, depression, and suicide; and

WHEREAS, social media is used to facilitate cyberbullying, privacy invasion, fraud, human trafficking, sexual harassment, sexual predation, hate, and disinformation; and

WHEREAS, additionally, social media platforms are routinely used to facilitate the sale of illegal narcotics which has resulted in multiple deaths nationwide, and

WHEREAS, other segments of society such as domestic violence survivors are also at increased risk of social media-related harms; and

WHEREAS, a University of Chicago Crime Law Report noted that teachers and school administrators report that a large share of in-school conflicts originate in social media disputes; and

WHEREAS, studies have found that hate groups, terrorist organizations both domestic and foreign, leftand right-wing extremists, and street gangs are using social media platforms to recruit new members, threaten and harass individuals, incite violence and post violent videos; and

WHEREAS, studies have further found that such groups utilize social media as a way to communicate about and organize their activities including flash mobs and organized retail thefts which are significantly and adversely impacting businesses and communities, and

WHEREAS, about 88% of social media-using teens have witnessed other people being mean or cruel on social networking sites and approximately 34% of students report experiencing cyberbullying; and

WHEREAS, nearly 21% of women ages 18 to 29 report being sexually harassed online; teens using social media more than 5 hours daily were 70% more likely to have suicidal thoughts or actions than those who reported one hour of daily use; and about 64% of U.S. teens have encountered hate speech online; and

WHEREAS, a comprehensive approach on social media that promotes best practices across education, public policy, and technology increases our ability to protect families from these threats; and

WHEREAS, Cook County should continue to undertake efforts to mitigate and prevent current and emerging social media-related threats, provide guidance to those at risk, and bring awareness to the benefits and challenges of social media; and

**WHEREAS,** in 2024, the Cook County Board of Commissioners established Social Media Safety Day in Cook County on the 2nd Thursday of November each year;

**NOW, THEREFORE, BE IT RESOLVED,** that the Members of the Cook County Board of Commissioners recognize November 13, 2025 as Social Media Safety Day in Cook County; and

**BE IT FURTHER RESOLVED,** that this text be spread upon the official proceedings of this Honorable Body.

# HONORING THE LIFE AND LEGACY OF KENT DOUGLAS WONG

**WHEREAS**, Kent Douglas Wong was born in Los Angeles, California, the son of Los Angeles Superior Court Judge Delbert Wong, the first Chinese American judge in the United States, and Dolores Wong, a psychiatric social worker and community leader who helped establish the Chinatown Public Library; and

WHEREAS, Mr. Wong grew up in the Silver Lake neighborhood of Los Angeles, graduated from Marshall High School, and went on to attend the University of California, Berkeley, and the People's College of Law, where his passion for social justice and advocacy for workers' rights began to take shape; and

WHEREAS, while attending the University of California, Berkeley, Mr. Wong met his future wife, Jai Lee, who shared his love for politics, travel, and community building. They married and together raised two sons, Ryan (engaged to Larissa Pham) and Robin; and

WHEREAS, early in his professional career, Mr. Wong served as a staff attorney for the Service Employees International Union, where he advocated for the fair treatment of workers and equitable labor practices; and

WHEREAS, Mr. Wong was the founding president of the Asian Pacific American Labor Alliance, the founding president of the United Association for Labor Education, and a vice president of the California Federation of Teachers, through which he built coalitions to advance labor rights and education across communities; and

WHEREAS, as Director of the UCLA Labor Center for more than 30 years, Mr. Wong transformed the Center into a national and international leader in labor research, education, and advocacy, fostering a generation of organizers, educators, and policymakers dedicated to equity and justice; and

WHEREAS, under his leadership, the University of California established labor centers at all nine campuses, expanding labor education throughout the state. Mr. Wong also led efforts to create similar centers at three universities in Mexico and forged relationships with labor education programs in China, Vietnam, and the Philippines; and

WHEREAS, Mr. Wong oversaw the expansion and renovation of the UCLA Labor Center's new headquarters near MacArthur Park, named in honor of his mentor, the Rev. James Lawson Jr., a leader of the nonviolent civil rights movement; and

WHEREAS, as an educator, Mr. Wong taught in UCLA's Asian American Studies and Labor Studies programs, where he mentored generations of students and activists. He was a leading advocate for undocumented students' rights on campus and nationally, and his mentorship helped empower the DREAMer movement; and

WHEREAS, Mr. Wong served on the Board of the New World Foundation and as a member of the Kellogg Foundation Solidarity Council on Racial Equity, continuing his lifelong commitment to community, justice, and solidarity; and

WHEREAS, Mr. Wong was the author and co-author of several books, including *Dreams Deported:* Immigrant Youth and Families Resist Deportation and Nonviolence and Social Movements: The Teachings of Rev. James Lawson Jr.. His final major public appearance was at the Los Angeles Convention Center, where he led a workshop for more than 1,400 attendees on nonviolent resistance; and

WHEREAS, Mr. Wong often reflected on his family's legacy as fifth-generation Chinese Americans, recognizing the deep connection between his family's history and the ongoing struggles of immigrants in America. "My great-great-grandfather came to California during the Gold Rush," he once said. "But even after 170 years, people still question whether I belong. That's the legacy of white supremacy, even though immigrants built modern-day America."; and

WHEREAS, Mr. Wong inspired a generation of labor organizers and Asian American activists and leaders including his niece, Cook County Commissioner Josina Wing Morita; and

WHEREAS, Mr. Wong is survived by his wife, Jai Lee; his sons, Ryan and Robin; his sister, Shelley Wong Pitts; and his brother, Marshall Wong. He was preceded in death by his brother, Duane "Pudgy" Wong; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Cook County Board of Commissioners, on behalf of the residents of Cook County, does hereby honor and celebrate the extraordinary life and legacy of Kent Douglas Wong, whose decades of leadership in labor, education, and social justice uplifted communities locally, nationally, and internationally; and

**BE IT FURTHER RESOLVED,** that a suitable copy of this resolution be presented to the family of Kent Douglas Wong as a symbol of our deepest respect, gratitude, and admiration.
