

## AMENDMENT NO. 2

This Amendment modifies Contract No. 2217-05270, for B-Scan Body Scanners by and between the County of Cook, Illinois, herein referred to as "County" and Command Sourcing, Inc., authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

### RECITALS

Whereas, the County and Contractor have entered into a Contract approved by the County Board on September 22, 2022, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide B-Scan Body Scanners (hereinafter referred to as the "Supplies") from September 26, 2022 through September 25, 2025, in an amount not to exceed \$679,600.00, with two (2), one (1) year renewal options; and

Whereas, Amendment No. 1 was authorized by the County Board on May 15, 2025, to renew the Contract for one (1) year beginning September 26, 2025 through September 25, 2026, in the amount of \$455,400.00 and the Total Contract Amount was revised to \$1,135,000.00; and

Whereas, the Contract will expire September 25, 2026, and the agreed upon Supplies are still required; and

Whereas, an increase of the Contract amount is required for the continuation of Supplies; and pursuant to GC-10 of the Contract, the County and Contractor desire to increase the Contract in the amount of \$1,192,100.00; and

Whereas, pursuant to SC-02 of the Contract, the County and Contractor desire to renew the Contract for one (1) year beginning on September 26, 2026 through September 25, 2027.

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is renewed through September 25, 2027.
2. The Contract is increased by \$1,192,100.00 and the Total Contract Amount is revised to \$2,327,100.00.
3. The Contract is hereby amended to incorporate Attachment A and made part of the Contract.
4. The attached updated Identification of Sub-Contractors/Suppliers/Sub-Consultants Form, MBE/WBE Utilization Plan forms, certificate of insurance, and Economic Disclosures Statement under Attachment B are incorporated and made a part of this Contract.
5. All other terms and conditions remain as stated in the Contract.
