

**AMENDMENT NO. 1 TO THE INTERGOVERNMENTAL AGREEMENT BETWEEN
THE COUNTY OF COOK AND THE FOREST PRESERVE DISTRICT OF COOK
COUNTY FOR BROWNFIELD SERVICES**

This 1st Amendment (“Amendment”) to the Intergovernmental Agreement (“Agreement”) is made and entered into by and between the County of Cook, a body politic and corporate of the State of Illinois (“County”) and the Forest Preserve District of Cook County (“District”), a special district, (collectively referred to as “the Parties” and individually as a “Party”) to support structure demolition, environmental assessment, and environmental remediation on sites within the District to increase access to healthy outdoor recreation and nature, and enhance energy savings.

RECITALS

WHEREAS, the County and District entered into the Agreement on July 19th, 2023; and

WHEREAS, on July 16, 2026, the County Board approved a resolution to amend the Agreement; and

WHEREAS, the County wishes to enter into this Amendment with the District for the purposes described herein.

NOW THEREFORE, in consideration of the covenants and mutual agreements herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties do mutually agree to amend the Agreement as follows:

1. INCORPORATION OF RECITALS

The recitals set forth above constitute an integral part of this Amendment and are incorporated herein by this reference.

2. GENERAL PROVISIONS

2.1 The section entitled III. COUNTY OBLIGATIONS shall be amended in paragraphs 1 and 2 to reflect an increase of \$175,000 in Funds for the Services with a total award of up to One Million Six Hundred and Seventy-Five Thousand Dollars (\$1,675,000.00).

2.2 The section entitled VII. MISCELLANEOUS PROVISIONS shall be amended in paragraph 11 to reflect a change in primary contacts as follows:
