- Legal Counsel reported on third quarter data.

- Number of intakes slight decreased and the number of inquiries has increased.
- New cases filed has decreased in the third quarter. One matter pending settlement. Three cases closed for lack of substantial evidence and two cases pending administrative hearings.
- Shared information on the launch of the Commissions new Case Management System on September 3, 2024.
- Policy: Director and Policy Analyst held six (6) Paid Leave Town halls for suburban Park and School Districts, created and distributed a memo of key take-aways. Commission staff would like to continue discussion on potentially clarifying in Human Rights Ordinance Substantive and Procedural Rules the circumstances during which a Respondent would not be served at the next Commission meeting. Three IAOHRA Resolutions presented at IAOHRA Annual Training Conference were presented and passed.
- Outreach: Outreach and training coordinator provided updates on events and trainings attended to continue departmental efforts to spread awareness of Cook County Human Rights and Ethics ordinances and protections. Specifically training on the Cook County Paid Leave Ordinance, Fair Housing and the Just Housing Amendment, and Equity Fund Recommendation 2.2. There was a request for Commissioner engagement at specific upcoming outreach events. The Human Rights Newsletter continues to grow almost two thousand subscribers!
