WHEREAS Bishop Charles Mason Ford, was born on January 3, 1936 in Chicago, Illinois. Son to Bishop Louis Henry Ford and Margaret Little Ford; and

WHEREAS, Bishop Ford, served his church for several decades as its radio broadcast announcer, known as the voice of St. Paul, he also served as First Jurisdiction-Illinois as Director of Urban Ministries; and

WHEREAS, Bishop Charles Mason Ford was ordained by his father, Bishop Louis Henry Ford in 1982 and 1989 he was appointed Church of God in Christ National Director of urban Ministries; and

WHEREAS, Bishop Charles Mason Ford in 1995 served as pastor after the death of his father. In 1997 he was appointed Superintendent of the Bishop Louis Henry Ford Memorial District. Bishop Ford has held a number of titles and positions within the church however the most memorable one is when he was recommended to become Auxiliary Bishop in 2001 and was approved in May of 2003; and

WHEREAS, Bishop Charles Mason Ford was a retired public servant, where he was Deputy Commissioner of the City of Chicago's Department of Human Services. He never stopped serving his community. He successfully received funding to build a 60-unit independent living senior housing complex and a 24-unit building for disabled individuals and their families; and

WHEREAS, Bishop Charles Mason Ford renovated a former CHA building to develop the St. Paul Community Development and family Center. This center would service residents from the surrounding communities;

WHEREAS, Bishop Charles Mason Ford was an authentic trailblazer, pioneer and dedicated father, he was also a true advocate for his church and community; and

WHEREAS, Bishop Charles Mason Ford passed away on Monday, February 15, 2021; and

WHEREAS, Bishop Charles Mason Ford is survived by his wife Marlene, Sons, Elder Kevin Ford, Louis Ford, Corey Ford, Daughters, Jaqueline and Christi; and

HONORING THE LIFE AND WORK OF CHICAGO TEACHERS UNION PRESIDENT EMITA KAREN JENNINGS LEWIS WHO TRANSITIONED FROM THIS WORLD ON FEBRUARY 8, 2021

WHEREAS, Karen Jennings Lewis was a lifelong Chicagoan, the daughter of public school teachers and a proud a product of Chicago Public Schools, who learned how to stand up for herself and her community as a student at her beloved Kenwood Academy High School; and

WHEREAS, from her days as the only Black woman in her class at Dartmouth College and throughout her life, Ms. Lewis exemplified how powerful, Black women can lead with strength, grace, dignity and love; and

WHEREAS, Ms. Lewis was a renaissance woman, speaking three languages, mastering two musical instruments, a lover of opera, musical theater and comedy; and

WHEREAS, Mrs. Lewis met her beloved husband John Lewis as they both pursued their passion for education as teachers at Lane Tech, and celebrated 20 happy and fulfilling years together during her life; and

WHEREAS, Ms. Lewis was a dedicated, skilled, life-long educator, having attained multiple degrees and National Board Certification, the highest honor awarded to educators; and

WHEREAS, as an educator, Ms. Lewis saw children as precious resources to be nurtured and loved in classrooms filled with joy, creativity and excitement - more than test scores or data points on a spreadsheet; and

WHEREAS, as president of the Chicago Teachers Union, Ms. Lewis worked to unify Chicago educators around a platform of common good demands to support the needs of the students, families and communities Chicago Public Schools serves; and

WHEREAS, Ms. Lewis led the historic 2012 strike which demonstrated the renewed power and solidarity of the Chicago Teachers Union, helped reinvigorate Chicago's labor movement, and sparked the Red for Ed movement across the country demanding dignity and respect for educators and public schools; and

WHEREAS, Ms. Lewis fearlessly confronted the rich and powerful who felt entitled to impose their privatization agenda on schools serving the predominantly low-income Black and Brown students who attend Chicago Public Schools and tirelessly fought for Chicago's children to receive the quality, well-resourced schools they deserve; and

WHEREAS, under her leadership, the Chicago Teachers Union fought the closing of 50 schools in Black and Brown neighborhoods, stalled charter school expansion that drains resources from public schools and pushed for fully-resourced, equitably funded neighborhood schools; and

WHEREAS, Ms. Lewis helped reshape the political landscape in Chicago, paving the way for new, progressive, independent voices to win election at the state, county and city level; and

WHEREAS, Ms. Lewis fought for the soul of public education, challenged education apartheid and transformed the education justice movement into a force to be reckoned with in the halls of power; and

WHEREAS, Ms. Lewis used her voice to change the terms of debate about what ails our education system and force an honest conversation about the deep-seated racism and segregation that plague Chicago and its schools to this day; and

WHEREAS, Ms. Lewis empowered tens of thousands of Chicago teachers, families and students who joined her fight for the schools Chicago children deserve and continue to live by her principals and vision for a quality, equitable, well-funded public school system for all.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Cook County hereby expresses its deep sadness over the passing of a remarkable educator and freedom fighter and with this resolution honors the life and work of Ms. Karen Jennings Lewis.

WHEREAS, the Reconciling Ministry participates in local LGBTQ events including Pride Parades to show their full support of the LGBTQ community; and

WHEREAS, the Reconciling Ministry also offers workshops on how to incorporate the use of pronouns, normalize the practice, and to support people that are going by different pronouns; and

WHEREAS, FUMCAH offers the Pinwheels Support Group where parents with transgender children

and their siblings have a safe space to meet where the kids can play together while the parents share experiences and resources; and

WHEREAS, FUMCAH hosts a Rainbow Circle, a group for LGBTQ Christians to gather regularly to share their experience, worship, and attend social events; and

WHEREAS, this church community represents the inclusivity that is vital to realizing equity for the LGBTQ and other marginalized communities; and

THEREFORE, BE IT RESOLVED, that we, the Cook County Board of Commissioners do hereby honor the First United Methodist Church of Arlington Heights for the outstanding work they do in Cook County; and

A RESOLUTION HONORING AND REMEMBERING THE LIVES LOST DURING 2020 IN COOK COUNTY DUE TO COVID-19

WHEREAS, on January 27, 2020, the United States Secretary of Health and Human Services declared that COVID-19, a respiratory illness spread by close contact through respiratory droplets, presents a public health emergency, and the World Health Organization characterized the COVID-19 outbreak as a pandemic on March 11, 2020; and

WHEREAS, on March 9, 2020, Illinois Governor JB Pritzker issued a disaster proclamation giving the state access to state money and possibly federal reimbursement for the costs of fighting the potentially deadly illness; and

WHEREAS, on March 10, 2020, County Board President Toni Preckwinkle found that the circumstances surrounding COVID-19 constitute a public health emergency under the

Illinois Emergency Management Agency Act and a disaster under the Cook County Code of Ordinances Sec. 26-36 and issued a issued a proclamation of disaster for Cook County activating Cook County's emergency operations plan; and

WHEREAS, the COVID-19 pandemic has been the worst healthcare and economic crisis in most of our lifetimes, disrupting our lives in innumerous ways, and far too many souls have succumbed to this terrible disease; and

WHEREAS, the unprecedented level of disparities in healthcare outcomes during the COVID-19 (Coronavirus) pandemic especially in the African-American and Latinx Communities in Chicago and Cook County has been particularly devastating; and

WHEREAS, in 2020 a total of 8,316 lives were lost in Cook County as a result of contracting COVID-19; and

WHEREAS, this Honorable Body wishes to honor and remember those who perished by conducting a wreath laying ceremony in the lobby of the County Building at 118 N. Clark St., Chicago, IL on March 10, 2021, which marks the one-year anniversary of the County's initial disaster proclamation; and

WHEREAS, the ceremony will also serve to memorialize and stand as a tragic reminder that we must remain vigilant even while we are being vaccinated so that we can protect our friends, loved ones and neighbors as we work in unity to overcome this pandemic and limit the number of lives lost in the coming year;

NOW THEREFORE BE IT RESOLVED, that the President and the Board of Commissioners of Cook County, on behalf of the 5.2 million residents of Cook County, commemorates the lives of the Cook County residents who died from COVID-19 in 2020, and does hereby offer its deepest condolences and heartfelt sympathy to their families and loved ones; and

BE IT FURTHER RESOLVED THAT, a wreath laying ceremony shall be held in the lobby of the County Building at 118 N. Clark St., Chicago, IL on March 10, 2021, which marks the one-year anniversary of the County's initial disaster proclamation, to honor and remember those who perished in 2020 due to COVID-19; and

BE IT FURTHER RESOLVED THAT, this text be spread upon the official proceedings of this Honorable Body.
