Regarding the vaccine mandate:

You, as the Cook County Commissioners, have the legal authority to REVERSE the health department's emergency order No.2021-11 COVID-19-Mitigation, and I'm urging you to do so.

These rules are not consistent with the freedom of your constituents. Forcing businesses to act as the police for vaccine and mask rules is an undue burden and tramples on their right to try and make a living. This order is extremely damaging to many already suffering businesses. These businesses are losing customers, dealing with overwhelmed employees, having to add on additional payroll hours to manage this, and much more, all due to the order you enacted. Vaccination, testing, and masking are all medical decisions that impact health, and the freedom to make one's own medical decisions without coercion is paramount in a country that holds sacred, bodily autonomy, and responsibility for one's own health. There is much evidence that indicates the importance of these health decisions and those who choose not to be vaccinated should not be discriminated against and excluded from normal facilities such as yoga studios, group fitness classes, recreation

centers, dance studios, movie theaters, concert venues, live theater and music spaces, sports arenas, bowling alleys, restaurants, and bars. I would like to make it known to every employee and public official of the Cook County Board of Commissioners that I will not comply with the "vaccine mandate/passport" being forced upon the public in Cook County.
