PROPOSED RESOLUTION

HONORING THE LIFE OF ARIANA MOLINA

WHEREAS, Ariana Molina was a 9-year-old girl who lived in Back of the Yards with her father Jose Molina, and mother Norma Molina; and

WHEREAS, on the evening of Saturday, April 13, 2024 while attending a family party in the Back of the Yards neighborhood, Ariana Molina tragically was the fatal victim of a gun violence; and

WHEREAS, Ariana and her family were in the middle of cutting a cake for the Confirmation party when the unexpected happened, shots were fired, injuring her and eleven other family members; and

WHEREAS, Ariana leaves four siblings, Marco Antonio Molina, Jose Luis Jr. Molina, Ivan Molina, and Daniel Molina who now have to grapple with the loss of their only sister; and

WHEREAS, Ariana was a fourth grade student at Robert Fulton Elementary School, and her teachers and classmates remember her as helpful, kind, and always having a positive attitude; and

WHEREAS, the Molina family, other family members, and neighbors remembered Ariana as playful, smart, and a loving big sister, a bright girl who always kept her younger siblings and cousins safe when they played on the sidewalk; and

WHEREAS, Ariana will forever be remembered as her parents' princess, a loving and caring child to everyone that she was able to meet, always looking after everyone else even at only 9 years old as she took her older sister's duties very seriously, and extended that love and care to anyone that surrounded her; and

WHEREAS, Ariana was a little girl full of life who loved butterflies and enjoyed hobbies such as: dyeing her hair, painting her nails, going to the park, roller skating, and listening to music; and

WHEREAS, according to the Centers for Disease Control and Prevention, National Center for Health Statistics, firearms are the leading cause of death for children and teens (ages 1 to 19) in the U.S.; and

WHEREAS, data from the U.S. Centers for Disease Control and Prevention from 2020 shows that fatal firearm injuries cost a total of \$290 million, with an average cost of \$9,000 per patient.; and

WHEREAS, many children like Ariana have had their lives taken away at a young age, 411 children have

been killed and an additional 1,004 injured by firearms in the U.S. so far this year, according to the Gun Violence Archive; and

WHEREAS, children and families in Cook County should have the assurance of being safe in their own homes.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners do hereby offer its deepest condolences and most heartfelt sympathy to the family of Ariana Molina and joins them in sorrow at this time of loss; and

BE IT FURTHER RESOLVED, that a suitable copy of this resolution be presented to the family of Ariana Molina so that her memory may be honored and ever cherished.

WHEREAS, as she looks to the future, Christanna plans to become a lawyer and a neurologist through a full scholarship she has already received to Tennessee State University; and

WHEREAS, Christianna finds herself inspired by the elected officials she has seen and met who are personal in their approach to problems, and who take a genuine interest in the well-being of the residents of Cook County; and

WHEREAS, the full text of "Cook County As A Brand" as written by Orlando Ceaser and performed by Christianna reads: *A county of neighborhoods* and many factions. That tries to be scandal resistant to shake off the strain of people being distant. WHEREAS, prior to his time with the Glenview Park District, Michael McCarty served as the Assistant Director of Recreation for the Town of South Windsor, Connecticut; Executive Director of Parks and Recreation in the Town of Longmeadow, Massachusetts; and Director of Parks and Recreation for the City of Fairfax, Virginia; and

WHEREAS, in each of his roles, Michael McCarty has been lauded for his professionalism and innovation; and

WHEREAS, Michael McCarty is an energized leader, successfully navigating open space purchases, tax referendums, facility developments, and large-scale renovations; and

WHEREAS, Michael McCarty is known for having the best interest of the community at heart, and advocating for the needs of the park district at every turn; and

WHEREAS, Michael McCarty's outstanding efforts and impressive career will be recognized at the NRPA's Best of the Best Ceremony at the 2024 NRPA Annual Conference in October in Atlanta, Georgia; and
