# **CCH Board of Directors Annual Meeting**

Notice is hereby given that the **Annual Meeting** of the **Board of Directors** of the Cook County Health and Hospitals System scheduled for **Friday**, **July 30**, **2021** at **9:00 A.M.** will be held at 1950 W. Polk Street, Conference Room 5301, Chicago, Illinois.

### **In-Person Attendance**

The following guidelines and protocol will be followed for CCH Board and Committee meetings held in person (subject to change based on public health guidance):

- Masks will be required to be worn by all attendees while in the building and during the meeting, with the exception of presenters who have no less than six (6) feet of social distancing and who have been fully vaccinated against COVID-19.
- Eating is not permitted. Beverages can be consumed with appropriate mask protocol.
- Temperature checks and attestation will not be required for attendees; however, do not attend the meeting if you have current SARS-CoV-2 infection; symptoms of COVID-19, including cough, fever, shortness of breath, or new gastrointestinal symptoms; prolonged close contact (within six (6) feet of an infected person for a cumulative total of fifteen (15) minutes or more over a twenty-four (24) hour period) with someone with SARS-CoV-2 infection in the prior fourteen (14) days; or have otherwise met the criteria for quarantine.
- Social distancing for attendees in the room will be no less than three (3) feet.
