Dear Commissioners,

My name is Dian Palmer and I am the president of SEIU Local 73. We represent 28,000 primarily public sector workers across the state of Illinois and northwest Indiana. Nearly 1,800 of these members work for Cook County Health and 1,200 who work for various other County departments. I am writing today on their behalf to strongly encourage you to take advantage of the current moment to open more school-based health centers (SBHCs) throughout Cook County to address the mental and medical needs of our most vulnerable. The time to expand access to this critical care is now as the County and potential partners, such as municipalities and school districts, finalize their annual budgets and determine how to use the American Rescue Plan Act funds.

According to the Centers for Disease Control and Prevention, between March and May of last year, hospitals across the country saw a 24% increase in the number of mental health emergency visits by kids aged 5 to 11 years old, and a 31% increase for kids 12 to 17. There will not be a "post"-pandemic environment. There will only be a living with COVID-19 environment for our children henceforth as we have already entered the third consecutive school year disrupted by this one disease. New SBHCs operated by Cook County Health could connect adolescents with Skilled Cook County Health staff to meet the mental & medical health needs of adolescents dealing with the repercussions of the pandemic and long-standing health inequities primarily impacting communities of color. SBHCs can help address adolescent behavioral and mental health needs to also reduce violence in communities, disrupt the school to prison pipeline, improve academic outcomes, decrease emergency room use and hospitalization, and link adolescents with a medical home they may not already have.

I am glad to see our Cook County Commissioners seeking guidance, data and feedback through these quarterly reports on our region's mental health needs. I strongly encourage them to consider opening new SBHCs as soon as possible as part of the solution. I thank you for your time commissioners and am available at any time to discuss this opportunity further. Sincerely,
