PROPOSED RESOLUTION

A RESOLUTION HONORING THE BERTEAU BUTTERFLY GARDEN PROJECT

WHEREAS Ruta Lietuvninkas, a resident of Portage Park in Cook County District 12, to promote and maintain natural habitats for monarch butterflies and other important pollinators, cultivated a pollinator garden outside her home in the fall of 2020, thus beginning the Berteau Butterfly Garden Project; and

WHEREAS, with the help of the community, the Berteau Butterfly Garden Project began several "sub-projects." The Semper Pi Project expanded the butterfly garden to the corner parkways of the neighborhood's Berteau block. The Milkweed Alley project aimed to cultivate milkweed seeds on weedy patches in two alleys behind the Berteau block residences; and

WHEREAS, the Semper Pi gardens contain approximately 50 native plants per garden, each with its own marker so people may learn its name and what insects it serves. The gardens also feature signs and artwork made by children in the community; and

WHEREAS, the gardens are enjoyed by neighbors and the wider community, with Ms. Lilliam Narvaez hosting show and tell sessions and gardening days to educate children and adults alike on the importance of pollinators. Many neighbors have been inspired to start their own pollinator gardens. Neighbors work together, sharing native plants and watering shifts; and

WHEREAS, the Berteau Butterfly Garden Project has been successful in strengthening not just the neighborhood's impact on pollinators, but also a sense of community; and

WHEREAS, neighbors in the Berteau community have seen an increase in monarch butterflies, black and eastern tiger swallowtails, and red admirals. A neighbor has seen the endangered Karner blue butterfly; and

WHEREAS, Ms. Lietuvninkas has documented the project at http://www.lietuvninkas.com/berteau/berteau-butterfly-garden-project/>.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners and President Preckwinkle, on behalf of the residents of Cook County, hereby honor and celebrate the Berteau Butterfly Garden Project and the community for their work to create, foster and protect natural habitats for butterflies and other pollinators.

BE IT FURTHER RESOLVED, that a suitable copy of this Resolution be spread upon the official

PROCLAIMING SEPTEMBER 25, 2021 AS, "GLOBAL ISMAILI CIVIC DAY" IN COOK COUNTY, ILLINOIS

WHEREAS, Ismaili CIVIC is a global program under which the Shia Ismaili Muslim community across the world has united around its centuries-old tradition of serving humanity by rendering voluntary service to improve the quality of life of the communities in which it lives; and,

WHEREAS, the international endeavor reflects the community's ethic of civic engagement and good citizenship, exemplifying Islam's core values of service, peace, compassion and care for the vulnerable; and,

WHEREAS, on September 25, 2021, the Global Ismaili CIVIC Day ("GICD") will commemorate serving humanity and enriching lives in the communities in all the countries in which Ismaili Muslims live, including Cook County, Illinois, USA; and,

WHEREAS, across the world, 29 countries will be partaking in over 250 volunteer service projects on the Global Ismaili CIVIC Day; and,

WHEREAS, on GICD, a diverse array of activities will occur simultaneously across the world focused on two themes: Pandemic Response and Environmental Stewardship; and,

WHEREAS, this year, GICD will bring together over 20,000 volunteers across the globe to work with their local communities, governments, and civil society partners to contribute their time, knowledge, and skills for the betterment of their fellow citizens; and,

WHEREAS, the Global Ismaili CIVIC Day in Cook County, Illinois aims to contribute hundreds of hours of community service by volunteers and restore, rehabilitate and beautify the Cook County Forest Preserves District; and,

WHEREAS, to date, Ismaili CIVIC volunteers in Cook County exemplified pluralism and promoted equity through improving the quality of life of community members through hundreds of programs benefitting thousands of people in the areas of Health (including pandemic response, Education, Economic Development, Environmental Stewardship, and Culture; and,

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby salute the service of therapy animal teams in our community and in communities across the nation; and,
