PRIOR CONTRACT HISTORY:

Pursuant to the CCH Procurement Policy, the Cook County Health Board Chair and Finance Chair were notified of an emergency purchase on 7/23/21, and the Finance Committee (and Board by extension) received notification of the emergency purchase at the 8/19/21 CCH Finance Committee Meeting for Contract Number H21-25-110. The Contract was for a three (3) month period from 07/15/2021 thru 10/15/2021 and a not-to-exceed value of \$313,799.00.

NEW PROPOSAL JUSTIFICATION:

This request will allow the Contractor to continuing providing accreditation readiness support and Implementation services. Contractor will assess, evaluate, and support the entirety of the Quality Program through the identification of strengths and weaknesses, and the creation of a Roadmap to develop a strong and culturally engaging Quality Program that encourages connection in Quality, Regulatory Readiness and Performance Improvement. Additionally, the Contractor will provide Behavioral Health Services to assess, evaluate and identify the required components, roles and responsibilities, budget, and overall scope for a 16-bed adult inpatient behavioral health unit.

TERMS OF REQUEST:

This is a request to amend, extend and increase contract number H21-25-110 in an amount not to exceed \$1,334,026.00, as needed for a thirteen (13) month period thru 11/15/2022.
