I am writing to you today to express my extreme opposition against order No. 2021-11 COVID-19 Mitigation, blocking unvaccinated residents from moving about freely in Cook County. As a resident of Cook County, I am asking you to immediately withdraw order No. 2021-11 COVID-19 Mitigation before this order creates permanent damage. The order bypasses the United States Constitution and forces businesses to become agents of the government. The order also dictates what Cook County residents must put into their bodies in order to participate in daily activities, which goes against the right of bodily autonomy. Bodily autonomy is the right to make decisions over one's own life and future. It is about being empowered to make informed choices. These are universal values. Not only is bodily autonomy a human right, but it is also the foundation upon which other human rights are built. What removal of freedom will be next?

I feel the Cook County mandate order violates The Nuremberg Code. The Nuremberg Code is the most important document in the history of the ethics of medical research. The Code was formulated 50 years ago, in August 1947, in Nuremberg, Germany, by American judges sitting in judgment of Nazi doctors accused of conducting murderous and torturous human experiments in the concentration camps (the so-called Doctors' Trial). The first basic principle of the Nuremberg code is Voluntary Consent of the Human Subject is Essential. The duty and responsibility for ascertaining the quality of the consent rests upon everyone who initiates, directs, or engages in the experiment. It is a personal duty and responsibility which may not be delegated to another with impunity. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, over-reaching, or other ulterior form of constraint or coercion.

I grew up in Skokie, IL in the 70's and had many Jewish friends. One out of every six Jewish citizens in the late 1970s was a survivor—or was directly related to a survivor—of the Holocaust. Forty years ago, Skokie was home to some 70,000 people, of whom 40,500 were Jews, and of those 5,000–7,000 were survivors of Nazi concentration camps. In 1977, there was a fight for the Nazi's to march in Skokie. The news set off a rhetorical firestorm that the Chicago Tribune dubbed the "Skokie swastika war." I remember hearing about the Nazi march from my friends and how upsetting it was for them and their families. I feel like history is repeating itself. I fear that this mandate is a setting a precedent to ostracize and demonize those who choose not to be vaccinated as well as treating them like second class citizens. It is the freedom found in the United States that has always differentiated us from other countries and attracted immigrants from around the world. Let's learn from the mistakes made against humanity instead of repeating them.

What is now Cook County was so designated in 1830, by the State of Illinois which was formed in 1818. For millennia previous, this land was occupied and cherished by indigenous people whose past stewardship of these lands needs to be continually recognized. A land acknowledgement would be a step in the right directly toward healing and reconciliation of the shameful way in which their land was taken.

Rev. Dr. King wrote in his 1963 book "Why We Can't Wait" which outlined the historic injustices inflicted on Native people:

"Our nation was born in genocide when it embraced the doctrine that the original American, the Indian, was an inferior race. Even before there were large numbers of Negroes on our shores, the scar of racial hatred had already disfigured colonial society. From the sixteenth century forward, blood flowed in battles of racial supremacy. We are perhaps the only nation which tried as a matter of national policy to wipe out its Indigenous population. Moreover, we elevated that tragic experience into a noble crusade. Indeed, even today we have not permitted ourselves to reject or feel remorse for this shameful episode. Our literature, our films, our drama, our folklore all exalt it."

The Indigenous Peoples' Day Coalition is still working to pass a resolution that would require the Cook County Board to read a Land Acknowledgement at monthly board meetings. We know Land Acknowledgements alone are not enough, but they can be a step in the right direction in terms of education/awareness.

What's the point of these requirements?

Beyond the problems with the lack of authority for the current arbitrary vaccine mandate, the argument in support of the public health notice rests on another fundamental flaw: the idea that vaccines will reduce transmission of the COVID-19 virus. Claiming that a vaccination mandate is intended to address "transmission of SARS-CoV-2 in the our cities" ignores the fact that the current vaccines do not prevent transmission. As the Director of the Centers for Disease Control and Prevention ("CDC") made crystal clear, with the rise of Delta and other variants "what they [vaccines] can't do anymore is prevent transmission.

Further bringing this fact into sharp focus is the most recent official government data from Canada, which now shows that vaccinated individuals are more likely to be infected with the COVID-19 virus than unvaccinated individuals. The CDC has not published recent data on infection rates between vaccinated and unvaccinated individuals, and hence the need to rely on our neighbor to the north. For example, the official government data from Ontario, Canada, establishes that as of December 31, 2021, there were 80 Covid infections per 100,000 fully vaccinated individuals versus only 60 Covid infections per 100,000 unvaccinated individuals:

Similarly, in British Columbia, Canada, as of December 29, 2021, there are now 58 Covid infections per 100,000 double-vaccinated individuals versus only 40 Covid infections per 100,000 unvaccinated individuals. The fact that the vaccinated spread the virus alone undercuts the premise of the ETS but if the vaccinated, as reflected by this data, are the primary drivers of the virus, it renders the ETS completely illogical.

Moreover, since vaccinated individuals can transmit the virus, and are more likely to be asymptomatic – since according to the government, vaccines reduce symptoms – wouldn't there be a greater need for the government to impose a mask and weekly test mandate on the vaccinated?

As for natural immunity, which the mandate refuses to consider, as it must, that such immunity provides protection". Cohort studies of millions of individuals consistently find that previously infected individuals have a reinfection rate that is effectively negligible, while breakthrough cases after vaccination are common. However, even putting that aside and taking the county's argument at face value, when it comes to people who are vaccinated, it is also unknown which vaccinated individuals will have a breakthrough infection. Hence, the logic behind its decision to force naturally immune individuals to require a vaccine card to work out in a gym, but not vaccinated individuals, makes no sense and supports the conclusion that the current public health mandate is about achieving its vaccination coverage policy goal (i.e., full vaccination of the entire population, under the threat of loss of participating in life), not about addressing a grave danger posed by a virus with a 99% recovery rate for people under the age of 65.

Vaccination status should be no one's business, especially a restaurant, a movie theater or a fitness-facilities, but here we are living in a society that openly discriminates against those who refuse (for whatever reason, moral, religious, medical, the fact it's still an experiment with no long -term safety data) a COVID-19 vaccine.

The Cook County vaccine mandate is designed to coerce people into accepting a medical procedure that they do not want to accept. If people have not gotten vaccinated by now it is because they do not want to. From a public health and from a philosophical perspective, this coercion is wrong.

From a public health perspective it is wrong for at least three reasons. First, as has been demonstrated repeatedly, the vaccines are minimally effective against the Omicron variant. Consider the data. Early December US data found 79% of Omicron cases to be among fully vaccinated people, including 33% who had received their boosters (<https://www.cdc.gov/mmwr/volumes/70/wr/mm7050e1.htm>). More recent UK data shows 70% of COVID deaths occurred in those who were fully vaccinated. (https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/1045329/Vaccine_surveillance_report_week_1_2022.pdf)

Next, consider the science. One study entitled "Omicron extensively but incompletely escapes Pfizer BNT162b2 neutralization," found a 22-fold reduction in vaccine neutralization capacity with Omicron. (<https://doi.org/10.1038/d41586-021-03824-5>) Another paper concludes: "Primary immunisation with two BNT162b2 or ChAdOx1 doses provided no or limited protection against symptomatic disease with the Omicron variant." (<https://www.medrxiv.org/content/10.1101/2021.12.14.21267615v1>) Another study found that, "Remarkably, neutralization of Omicron was undetectable in most vaccinated individuals." (<https://www.medrxiv.org/content/10.1101/2021.12.14.21267755v1>) Another found a 35.7-39.9-fold lower geometric mean neutralization antibody titer for Omicron, concluding, "Omicron variant escapes neutralizing antibodies elicited by BNT162b2 or CoronaVac." (<https://www.medrxiv.org/content/10.1101/2021.12.13.21267668v1>) While these studies do generally conclude that booster doses are more effective, authors are still finding considerable escape: "Administration of a booster Pfizer dose as well as vaccination of previously infected individuals generated an anti-Omicron neutralizing response, with titers 6 to 23 fold lower against Omicron than against Delta." (<https://www.nature.com/articles/d41586-021-03827-2>) Moreover, how long booster induced immunity can be expected to last is highly questionable given the rapidly and severely waning immunity we witnessed following initial doses.

Second, Omicron may be presenting an opportunity to reach herd immunity and stop this pandemic. Although antibodies post-vaccination or post-infection do not effectively neutralize Omicron, antibodies following Omicron infection do neutralize preceding variants as has been shown by Khan and colleagues who write, "The increase in Delta variant neutralization in individuals infected with Omicron may result in decreased ability of Delta to re-infect those individuals. Along with emerging data indicating that Omicron, at this time in the pandemic, is less pathogenic than Delta, such an outcome may have positive implications in terms of decreasing the Covid-19 burden of severe disease." <https://www.medrxiv.org/content/10.1101/2021.12.27.21268439v1.full.pdf>

Fortunately, Omicron is well-suited for the role of conferring herd immunity in that it is less dangerous compared to other variants both in terms of risk for hospitalization and disease severity. "Early analyses suggest a reduced risk of hospitalisation among SGTF [Omicron]-infected individuals when compared to non-SGTF infected individuals in the same time period. Once hospitalised, risk of severe disease was similar for SGTF- and non-SGTF infected individuals, while SGTF-infected individuals had a reduced risk of severe disease when compared to earlier Delta-infected individuals." (<https://www.medrxiv.org/content/10.1101/2021.12.21.21268116v1>)

Vaccination, on the other hand, appears to be driving immune escape:

A study by Servellita et al. found 78% of vaccine breakthrough cases were a result of infection by antibody resistant strains compared to 48% in the unvaccinated population. The authors concluded: "The predominance of immune-evading variants among breakthrough cases indicates selective pressure for immune-resistant variants locally over time in the vaccinated population concurrent with ongoing viral circulation in the community." (<https://www.medrxiv.org/content/10.1101/2021.08.19.21262139v1.full.pdf>)

Third, there are grave safety concerns with regards to COVID vaccines. The Vaccine Adverse Event Reporting System (VAERS) is

imperfect, primarily in that it is well known from nurses' claims (<https://banned.video/watch?id=61c3793c5ba039303b98d478>, <https://thehighwire.com/videos/these-patients-deserve-to-be-heard-vaers-whistleblower/>) and other sources (<https://digital.ahrq.gov/sites/default/files/docs/publication/r18hs017045-lazarus-final-report-2011.pdf>) that most vaccine adverse events do not get reported, but it is the best safety data available in the US. So what does it reveal? 1,016,999 reports of adverse events have been processed between 12/14/2020 and 12/31/2021. Prior to the the COVID vaccine rollout, the highest number of reports of death in a year had been 605. We are now up to 21,382 reports of death following COVID vaccination. "Of the 9,623 U.S. deaths reported as of Dec. 24 [2021], 20% occurred within 24 hours of vaccination, 25% occurred within 48 hours of vaccination and 61% occurred in people who experienced an onset of symptoms within 48 hours of being vaccinated. (<https://childrenshealthdefense.org/defender/vaers-cdc-covid-vaccine-injuries-fda-pfizer-booster-kids/>) While we are told that a causal relationship has not been established, ignoring 21,382 deaths, especially given their temporal proximity to vaccination and that this is certainly an undercount, would be exceedingly foolish.

Also note that Pfizer itself in a recently released document admits to having received 42,086 reports of adverse events between 12/01/2020 and 02/28/2021 25,379 of which were medically confirmed and 1,223 of which were deaths. Note that these numbers though likely also an undercount, reflect the consequences of just the first two months of vaccine rollout. (<https://phmpmt.org/wp-content/uploads/2021/11/5.3.6-postmarketing-experience.pdf>)

Moreover, that these vaccines cause injury and death should be entirely unsurprising given that the scientific literature has demonstrated that injury and death are highly likely to result. To keep things brief, consider just three adverse health effects.

1) Cancer:

"...the spike protein localizes in the nucleus and inhibits DNA damage repair by impeding key DNA repair protein BRCA1 and 53BP1 recruitment to the damage site. Our findings reveal a potential molecular mechanism by which the spike protein might impede adaptive immunity and underscore the potential side effects of full-length spike-based vaccines." (<https://www.mdpi.com/1999-4915/13/10/2056/htm>)

Note that, "It has been extensively demonstrated that aberrant expression of 53BP1 contributes to tumor occurrence and development. 53BP1 loss of function in tumor tissues is also related to tumor progression and poor prognosis in human malignancies." (<https://pubmed.ncbi.nlm.nih.gov/30497961/>)

2) Fertility:

Pfizer's report to the Japanese government which contains lipid nanoparticle biodistribution analysis found accumulation in particularly high concentrations in the ovaries. (https://www.pmda.go.jp/drugs/2021/P20210212001/672212000_30300AMX00231_1100_1.pdf)

Note that nanoparticles (NP's) "...can pass through the blood–testis barrier, placental barrier, and epithelial barrier, which protect reproductive tissues, and then accumulate in reproductive organs. NP accumulation damages organs (testis, epididymis, ovary, and uterus) by destroying Sertoli cells, Leydig cells, and germ cells, causing reproductive organ dysfunction that adversely affects sperm quality, quantity, morphology, and motility or reduces the number of mature oocytes and disrupts primary and secondary follicular development." (<https://www.ncbi.nlm.nih.gov/labs/pmc/articles/PMC6294055/>)

3) Autoimmune Diseases:

One study found that "SARSCoV- 2 antibodies reacted from low to very high with 28 out of 55 tissue antigens. These 28 antigens were a diverse collection of tissue groups that included gut and barrier proteins, gastrointestinal system cells, thyroid, nervous system, heart, joint, skin, muscle, mitochondria and liver tissues...." (<https://www.frontiersin.org/articles/10.3389/fimmu.2020.617089/full>)

A review of the literature urges, "As a matter of fact, because of the pathogen–host peptide commonality, a potential consequence of vaccination might consist of a specific autoimmune reactions hitting self-antigens such as the already analyzed alveolar surfactant protein." The authors continue: "In order to understand its nature we were able to prove that the infiltrate was dominated by T lymphocytes (CD3+), and the most numerous of them were CD8+ suppressors, observed in the lungs, adrenals, liver, intestine and other organs partly accompanied by tissue lesions. Taking in to consideration that one of the most important mechanisms of autoimmune reactions is CD8+ T Cell mediated cytotoxicity, we assumed that the findings confirm an autoimmune process."

Another study's findings "...that 21 out of 50 tissue antigens had moderate to strong reactions with the SARS-CoV-2 antibodies are a sufficiently strong indication of cross-reaction between SARS-CoV-2 proteins and a variety of tissue antigens beyond just pulmonary tissue, which could lead to autoimmunity against connective tissue and the cardiovascular, gastrointestinal, and nervous systems." (https://www.ncbi.nlm.nih.gov/labs/pmc/articles/PMC7246018/)

The study author's fears are apparently well justified as a recent autopsy report following the deaths of 15 vaccinated human subjects concluded: "Histopathologic analysis show clear evidence of vaccine-induced autoimmune-like pathology in multiple organs." (https://doctors4covidethics.org/wp-content/uploads/2021/12/end-covax.pdf)

From a philosophical perspective, where there is risk, there must be choice. These mandates take away people's ability to freely choose. Comparing Nazi Germany to modern day, holocaust survivor Vera Sharav states, "The stark lesson of the holocaust is that whenever doctors join forces with government and deviate from their personal professional clinical commitment to do no harm to the individual... medicine can then be perverted from a healing, humanitarian profession to a murderous apparatus.... Medical mandates today are a major step backward to a fascist dictatorship and genocide." (https://www.youtube.com/watch?v=PdlWhuUFuKs&t=1s) Please do everything in your power to prevent this "step backward."

In sum, the vaccines will not protect us from Omicron. Omicron may be our best shot at protecting people from more severe disease and a prolonged pandemic. There can be no doubt that the vaccines are extremely dangerous and indeed, deadly. Taking coercive measures to force people to accept a dangerous and deadly procedure that will not protect them from a disease that they do not need protecting from is nonsensical, immoral, and absolutely unacceptable in a free society.

I am a physician in Cook County. I have taken care of thousands of families here for over 30 years. I dedicate my work and service every day to using science and current medical knowledge to protect and save lives.

There has to be a strong reason for the drastic measure of identifying certain groups of the population and segregating them from normal society. The consequences must be far outweighed by the benefits of such an action

The recent requirement for 5-yearolds and older to show proof of being fully vaccinated to enter public facilities such as gyms, restaurants, movie theaters, music, sports and entertainment venues is an example of a drastic measure for which there must be a strong argument. There is no strong argument.

I've been told that this would stem the rising tide of Covid 19 cases which will lead to many more hospitalizations and deaths in our county. The reason, I've been told is to save these lives and prevent burden to our health care system. This is certainly a noble pursuit. But the accepted science does not support this declared benefit.

It has been known from the very beginning of the roll out of the vaccine that the vaccine was not designed to stop the transmission and spread of the disease. That certainly has turned out to be the real-world experience as we have seen the continued spreading of virus in both the vaccinated and unvaccinated populations everywhere in society. These cases in the vaccinated are being called breakthrough cases but the science never promised that getting vaccinated would stop you from getting the disease. There still would be cases even with vaccination. The science told us this at the beginning. "The shot will protect you from severe disease and death." That's it! There is no science to say you won't get the virus or pass the virus even if you are vaccinated. Those are accepted facts of science. And we are seeing that play out.

So the conclusion is that an unvaccinated person being in public facilities will not have any more bearing on the spreading of the disease than the vaccinated. You could argue that science tells us that the unvaccinated person if exposed and becomes ill leads to a greater chance of severe illness or hospitalization or death but you can't argue it will affect the unvaccinated person in public to any greater degree than a vaccinated person.

You then might say the strong argument is that it is the group of unvaccinated persons are at risk for hospitalization. We can't have our hospitals and ICU's overrun with Covid patients that are unvaccinated. Therefore, it is the population's moral obligation to get vaccinated so as not to burden the hospital system, right?

That argument breaks down when you consider the overwhelming majority of individuals deciding not to get the shot is based on their assessment of personal risk and chance of getting serious disease. Many people, (especially young adults and parents) who are aware of the science, determine that they have very little risk of severe illness and especially hospitalization and death if they get a Covid 19 illness. The overwhelming numbers of people deciding not to vaccinate will not be the cases that overwhelm our health care system. It is not good argument to segregate the whole segment of unvaccinated. It actually discriminates and stigmatizes the healthy and well population who is deciding not to vaccinate.

This policy is deeply affecting the lives of countless persons and their families. It is conceivable that measures like this would be worth it if there was a reasonable chance of gaining a positive outcome that outweighs the negatives for society. There isn't. Please repeal this rule to prove vaccination status.
