WHEREAS, Tom Balanoff is the president of Service Employees International Union Illinois Council and the Vice President of its international Executive Board, as well as the President of SEIU Local 1, a union close to about 2 million diverse members; and

WHEREAS, Tom comes from a family of labor union officials, including his father James Balanoff who served as President of the largest steelworkers local 1010 based in East Chicago; and

**WHEREAS,** Tom graduated from the University of Illinois with a master's degree in Labor, where he observed and witnessed the rejection of the labor movement as he took part in student actions. Tom saw the world with the mind of an activist due to his family roots in the labor and civil rights movements; and

WHEREAS, Tom moved to Chicago in 1993 to become the Local 73 Trustee. In 1994 he was elected president, and one year later he joined the SEIU International Executive Board and became Vice President; and

**WHEREAS,** As President Tom's leadership and vision has afforded SEIU Local 1 to improve the lives of more than 10,000 working people throughout the Midwest. One of his greatest accomplishments was winning a contract where janitors were allowed to work full-time hours with a higher wage of \$20 a day. He has also seen SEIU grow into the largest security union worldwide; and

WHEREAS, Tom's dedication to improve our country for all working people, led to his support of a young activist named Barack Obama to win the Illinois State Senate seat and U.S. Senate, something that unions stayed away from. SEIU was one of a few unions to back a political candidate and witness a victory; and

**WHEREAS,** Tom's 25 years of experience has helped to double the growth of membership to more than 90,000 plus members spanning across Illinois, Indiana, and Michigan; and

**WHEREAS**, Tom will officially retire as President of SEIU Local 1 on March 3, he will no doubt still remain instrumental in raising the awareness of higher wages for working families; and

HONORING THE WORK AND CONTRIBUTIONS OF SUPERINTENDENT ERIC WITHERSPOON

**WHEREAS,** Eric Witherspoon, superintendent of Evanston Township High School District 202 since July 2006, will retire at the end of the 2021-22 school year; and

WHEREAS, a lifelong educator, Witherspoon has served as a school superintendent for more than 30 years. He began his career as a high school English teacher and was previously a director of a high school gifted education program, assistant principal, acting principal, and assistant superintendent. Prior to coming to Evanston, he was a school superintendent in Iowa and Indiana. He was named Iowa Superintendent of the Year in 2001-02. During his tenure at ETHS, Witherspoon received several contract extensions from the Board of Education; and

WHEREAS, equity and anti-racism were the hallmarks and foundation of his superintendency. Witherspoon led the de-tracking and restructuring of the freshman experience and the acclaimed earned honors model that increased rigor and expectations for all ETHS students. Academic performance increased and enrollment in Advanced Placement courses grew, particularly among students of color. Over the years, the earned honors model, which benefits all students, has been expanded to most courses throughout the school; and

**WHEREAS,** as part of his push for equity in education, Witherspoon worked alongside ETHS staff and board members to develop and implement the district's equity initiatives. Professional development and training for staff were developed through an equity lens to facilitate conversations about race and identity while re-examining policies, procedures, and practices; and

WHEREAS, ETHS saw an increase in academic achievement and graduation rates under Witherspoon's leadership. During his tenure, ACT results at ETHS reached the highest in the history of ETHS for nine consecutive years. With a focus on career and college readiness, opportunities for students have expanded to prepare them for life after high school. ETHS also invested in alternative school and therapeutic day school programs to increase student success in supportive settings while reducing obstacles to progress; and

**WHEREAS,** ETHS has been consistently recognized by U.S. News and World Reports and The Washington Post as ranking in the top 2-3% of all ranked high schools in the nation. The College Board also named ETHS one of the eight Inspiration Schools in America; and

WHEREAS, implementation of strategies led by Witherspoon will help to ensure that ETHS District 202 continues to demonstrate growth in key areas: curricula and academic supports, programs and services that include social/emotional supports, partnerships and collaborations with Northwestern University and Evanston Cradle to Career, and the Joint Achievement Report with the elementary Evanston/Skokie School District 65; and

**WHEREAS,** Witherspoon led the district through a global pandemic. Focusing on the health and safety of the ETHS community in a rapidly changing environment, he remained vigilant to offer high quality remote instruction during one of the most challenging times in the district's history. Overseeing new and innovative ways to educate students, Witherspoon helped ensure that the stakeholders were informed as the district prioritized the safe reopening of the school; and

**WHEREAS,** ETHS reached significant milestones under his careful guidance and decision-making, providing consistent fiscal strength and responsibility during challenging economic times in Illinois. The district achieved a balanced budget every year during his tenure, annually winning the top national budget and accounting awards and receiving the coveted AAA bond rating; and

WHEREAS, striking the balance between preserving the historic architecture of ETHS and creating a 21st-Century learning environment, Witherspoon ensured that facility upgrades and long-term strategic initiatives would benefit students for decades to come. By careful fiscal planning and partnering with the efforts of the ETHS Foundation and Alumni Association, he focused on students having access to unprecedented resources and facility upgrades. These include a Geometry in Construction site, science research center, literacy lab, science labs, planetarium, wellness center, athletics and physical education spaces, Central Library, entrepreneurship center, the Hub student success center, labs for auto technology, advanced manufacturing, and engineering, and auditorium upgrades, along with increased energy efficiency, and other improvements. Developments in technology and communications (Google for

Education Reference District, 1:1 Digital Initiative, mobile app, branding and signage, and school website) have also made ETHS a model school district; and

**WHEREAS,** Witherspoon is widely known for being student-centered. A highly visible leader at ETHS, Witherspoon regularly connected with students, including at the start and end of the school day. Most days, he spoke with students in cafeterias and attended school events. With a steadfast focus on serving the needs of all students, Witherspoon also worked with community leaders and local organizations to increase community involvement and mobilize efforts that amplify student voice; and

WHEREAS, Witherspoon began his daily announcements with "It's a great day to be a Wildkit!" This was more than just a saying for him as he embraced whole heartedly the special meaning of being part of the ETHS community; and

WHEREAS, Pat Savage-Williams, president of the ETHS District 202 Board observed "ETHS and the Evanston community have been so fortunate to have Dr. Witherspoon as our superintendent for the past 16 years. His leadership, his compassion, and his positive impact on ETHS have set the tone for this amazing school district. It has been an honor for the Board of Education to work alongside Dr. Witherspoon. He is incredibly dedicated to our students, staff, and community."

HONORING THE LIFE AND WORK OF COOK COUNTY CIRCUIT COURT JUDGE ABISHI C. (A.C.) CUNNINGHAM, JR.

WHEREAS, the Honorable Abishi C. (A.C.) Cunningham, Jr. was born in West Virginia. His father, Abishi C. Cunningham, Sr. was the first African-American student to attend and graduate from the University of Iowa Law School. Judge Cunninghas was raised in West Virginia along with his sister, Marjorie Laws, who is also a judge of the Circuit Court of Cook County. After graduating from Fisk

University with a Bachelor of Science in 1969 and from Northwestern University School of Law with a Juris Doctorate in 1972, Judge Cunningham became a member of the Illinois Bar; and

WHEREAS, Judge Cunningham first worked as legal advisor to the Illinois State Superintendent of Public Instruction. One year later, he joined the Cook County State's Attorney's office as a felony trial assistant. Judge Cunningham subsequently served as Chief of the Vertical Prosecutions Unit; and

WHEREAS, after leaving the State's Attorney's office in 1976, Judge Cunningham joined the Criminal Defense Consortium of Cook County as a Supervisor of that organization's Lawndale office. Judge Cunningham subsequently rejoined the Office of the Cook County State's Attorney, where he supervised 40 Assistant States Attorneys responsible for prosecuting all criminal misdemeanor and quasi-criminal cases in the City of Chicago, as well as advising the office on legislative issues; and

WHEREAS, Judge Cunningham joined the Cook County Circuit Court bench in 1986. He served as a judge until 2009. During his time on the bench, he presided over thousands of bench trials, hundreds of jury trials, and was appointed by the Chief Judge to mentor newly appointed and elected judges. His last judicial assignment was in the Law Division, where he presided over an array of civil matters; and

WHEREAS, on April 1, 2009, after being appointed by then County Board President, Todd Stroger, Judge Cunningham was sworn into the office of Public Defender of Cook County by his sister and Presiding Judge of the Sixth Municipal District, Hon. Marjorie Laws. During his six-year term as Public Defender, Judge Cunningham diligently carried out his mission to uphold the Constitutions of the United States of America and the State of Illinois; and protect the rights, liberties, and dignities of every person his office was appointed to represent; and

WHEREAS, Judge Cunningham is certified in Comprehensive Mediation in the State of Illinois. He has been an adjunct professor in the Political Science Department at the University of Illinois at Chicago, and was also an adjunct professor at the DePaul University School of Law and the John Marshall School of Law. His professional affiliations included membership in the American Bar Association, the National Bar Association, the Cook County Bar Association, the National Lawyers Guild, the Chicago Bar Association, the Illinois Public Defender Association, and the National Legal Aid and Defender Association.

**WHEREAS**, Judge Cunningham is survived by his daughter Theodora Cunningham. He has served the residents of Cook County in literally every aspect of the court justice system. He was universally respected and will be missed by his colleagues and friends alike.
