Dear President Preckwinkle and Commissioners:

The League of Women Voters of Cook County is contacting you regarding the 2021 4th Quarter Report dated January 14, 2022 from the Independent Inspector General ("IIG Report") that is on the Board's March 17, 2022 agenda, Item 22-1760..

We were dismayed to read in both the IIG Report and the Chicago Sun Times about the Inspector General's findings of conflict of interest, waste and institutional mismanagement in the performance of duties by the Board of Trustees of the South Cook County Mosquito Abatement District (SCCMAD) IIG19-0219). We understand that the President and Cook County Board have no direct authority or oversight over the workings of the SCCMAD or the Trustees. We are aware that the President has sent a letter to the Trustees supporting the recommendations of the Inspector General. Thank you. We encourage all of you to take any further actions you can to see that these very serious findings are resolved promptly.

This investigation demonstrates the importance of the Independent Inspector General's office and why its recommendations need to be taken seriously. We are concerned about the recurring lack of timely responses to the recommendations of the Independent Inspector General, as required under the Independent Inspector General Ordinance, from various offices, departments and agencies that we regularly see in the quarterly reports.

In this IIG Report, there are 6 such investigations for which timely responses have not been made and which are reported to be still outstanding:

IIG20-0533-A and IIG20-0533-B Recommendations made Sept. 30, 2021

IIG21-0337 Recommendations made Sept. 30. 2021
IIG 20-0439 Recommendations made June 28, 2021
IIG20-0149 Recommendations made March 24, 2021
IIG20-0436 Recommendations made Dec. 11, 2020

We urge the Board to take appropriate steps to see that the applicable departments respond promptly and send a message to all County officials and employees that a failure to timely respond as required under the Ordinance is not acceptable.
