The Pleasantview Fire District protects multiple jurisdictions in Cook County. We provide fire and EMS service to the Villages of Hodgkins, Indian Head Park, and Burr Ridge, the City of Countryside as well as a large unincorporated area of Cook County known as the La Grange Highlands. As a Fire District property tax equates to over 90% of our revenue, with limited revenue streams our financial planning can be challenging and continuous revenue is key to our success. While we plan for purchases and carry reserve funds for emergencies we will not be able to absorb a six month delay in property tax revenue. If this were to occur we would have to make difficult decisions on how to proceed. I am concerned that this would equate to service reductions for the residents we are proud to serve. I am respectfully requesting that Cook County overcomes this hurdle so the second installment can go out as scheduled. Thank you for the ability to submit testimony.
