WHEREAS, in 1992, Esther Joo continued her work at the Illinois Department of Public Health and became the Administrator of the Epidemiology Program, HIV/AIDS Section where she developed the first statewide HIV epidemiologic profile and developed successful grant applications to CDC to support program initiatives; and

**WHEREAS**, in 1999, Esther Joo spent 7 years as the Director of Research at the CORE Center where she oversaw research budgets of \$7 million annually and effectively allocated resources, and

WHEREAS, from 2006 to present, Esther Joo, Executive Director of the CORE Foundation, was responsible for ownership functions of the Ruth M. Rothstein CORE Center facility including the capital budgets and financial stewardship of the endowment fund, capital projects, acquiring and administering grants and research contracts, and securing both public and philanthropic revenues for innovative HIV prevention, education, and care coordination programs for the CORE Center, and

WHEREAS, Esther Joo has spent 35 years of her career devoted to HIV and AIDS and her lifelong work has been important to protecting the health of Cook County residents and those in the surrounding communities, and

WHEREAS, throughout her career Esther Joo has earned a reputation as an inspiring leader, known for her accessibility and generosity with her time; and

WHEREAS, besides her dedication to making the CORE Center a welcoming space for all people, she is also known for her willingness to step in and work hard at every level, a consummate team player and a positive force for change; and

## PROPOSED RESOLUTION

# RECOGNIZING THE JUVENILE TEMPORARY DETENTION CENTER'S NATIONAL COMMISSION ON CORRECTIONAL HEALTH CARE (NCCHC) ACCREDITATION

**WHEREAS,** the National Commission on Correctional Health Care (NCCHC) was founded over 52 years ago to provide an objective assessment of juvenile facilities where health care is provided; and,

**WHEREAS,** securing NCCHC accreditation offers the Juvenile Temporary Detention Center (JTDC) public recognition and tangible evidence of a standards-based system of care that is efficient, reduces the risk of adverse events, decreases health care related litigation and improves staff morale; and,

**WHEREAS,** JTDC has successfully maintained NCCHC accreditation and 2019, NCCHC awarded JTDC the National Program of the Year for our Ambassador initiative; and,

**WHEREAS,** on April 14 and 15, 2022, the NCCHC conducted its review of JTDC for continued accreditation. Two experienced surveyors who are certified correctional health professionals, utilized NCCHC's 2015 Standards for Health Services in Juvenile Detention and Confinement Facilities as the basis of their analysis; and,

**WHEREAS**, Re-accreditation requires a review of health services provided to residents from 2019 to 2021. There are a total of 70 NCCHC Juvenile Detention standards, 66 are applicable to JTDC, and 66 (100%) were found to be in compliance.

**NOW, THEREFORE BE IT RESOLVED,** the Cook County Board of Commissioners and residents of Cook County recognize the Juvenile Temporary Detention Center's achievement of receiving National Commission on Correctional Health Care (NCCHC) accreditation.
