More than 50% of Black women over 20 years of age have high blood pressure (BP)

As we recognize and honor July as Bebe Moore Campbell National Minority Mental Health Awareness Month. We continue to support the goals of the organization by improving access to mental health treatment and services and promoting public awareness of mental illness.

A lot of times people try to think of heart health and mental health as separate issues, but mental health is health. As you think about the ways in which impaired mental health and mental wellness, psychological distress informs our decision making and our ability to overcome barriers.

So picture the person who is mildly depressed not even necessarily clinically depressed, but who is lacking motivation. That motivation means, the absence of motivation can make it hard to want to get up and do stretching exercises in the morning. The lack of motivation can make it hard to stick with the discipline of having a healthy meal to start the day, and then every insult coming after that is even harder to deal with.

Mental health is something that we do not spend enough time discussing in our communities. Mental health because of the stigma of having a weak mind, and we have perpetuated this somewhat by really celebrating the strength of our communities against various adversities. But part of that strength needs to be admitting when we need help and reaching out to get that help because again mental health is health.

Get active, move more, eat smart, sleep well - monitor your blood pressure daily. Nearly 80% of Black adults who have high BP don't have it under control. I challenge everyone listening to visit nhci.heart.org to take control of your blood pressure and take control of your mental health.

Dear Cook County Forest Preserve Board Members,

As the Captive Animals Campaigner for In Defense of Animals, an international animal advocacy organization with a major following and a 39 year history, I am writing to request that Rocky the coyote be surrendered to an accredited wildlife sanctuary. The alert we prepared for Rocky has over 20,000 supporters who are requesting this transfer.

Rocky exhibits numerous signs of stress, such as pacing back and forth, biting and licking his paws, and scratching to alleviate itching, for which he is on antidepressant and anti-anxiety medications. Throughout the winter months, his water bowl was observed repeatedly frozen solid. Rocky's environment violates the USDA blue book Forest Preserve policy manuals on housing wildlife and Illinois' Humane Care for Animals Act, as well as the Forest Preserve's own Mission Statement.

Rocky's true needs are not being met. It is inhumane to keep him alone in a cage (no matter the size) for the rest of his life simply because he was mistaken for a dog, and ended up deposited there. He deserves to have space to roam, hide in underground tunnels, have the opportunity to integrate with his own species, and be taken off the drugs that are used to address his stress.

For his well-being and his long-term health, Rocky should be surrendered to The Wild Animal Sanctuary in Keenesburg, Colorado. He should be free to live in as natural an environment as possible, and living at the sanctuary will provide him with the life he deserves. Just because he interacted with humans instead of other coyotes at a young age, doesn't mean he should be deprived of the opportunity to socialize with members of his own species. There are solutions for integration that the sanctuary has plenty of experience with. Even wild animals who have been domesticated have instincts to roam, run, dig tunnels, and interact with their own kind, and these things are denied to Rocky in his enclosure at the nature center.

We are requesting that the board exercise compassion for Rocky and surrender him to the wildlife sanctuary.
