Our literature, our films, our drama, our folklore all exalt it." MLK Jr. is now regarded with such love, but he was a villain at the time. For his courage he is remembered valiantly. Passing #21-0565, having Indigenous Peoples' Day replace Columbus Day, and #21-0597 to have Cook County read a Land Acknowledgement at monthly Board Meetings, which the Cook County Forest Preserve Meetings have already done, is the example of the type of reckoning we all need. This is about righting a wrong. Acknowledging what was done in order to have what we currently enjoy. This won't stop the white rage, the racial supremacy weaved into us by our families and this society. My Italian brothers and sisters were bamboozled out of their ethnicity to align with power. They are a product of the othering that is fundamental to oppression and subjugation. 1937 was when Columbus Day was recognized annually due to a push by the Knights of Columbus. Columbus at the time was seen as a hero, he is no longer that because the truth of what his mission was and then what he decided to do when he got lost. He colonized people and claimed discovery. He saw people that didn't look like him, spoke a different language, and saw them as having no meaning including to the God of which he supposedly was claiming. I'm a practicing Catholic and many things the Catholic church has stood for and continues to do is deplorable. I do understand that it's the humans and not the God I believe in. The God I believe in reminds me to love and care, not to hurt and harm. The financial issue faced by my Freedmen brothers and sisters can not be addressed without full recognition of what was done in order for tribes to do what they did. It is all interconnected. I ask that the Cook County Board be the example. Italians in Cook County have Enrico Fermi (self-sustaining nuclear reaction), the Italian Beef, and the radio flyer red wagon maker Antonio Pasin. Whatever any 'group' wants to say about how 'they' were treated, our Indigenous brothers and sisters were the quinea pigs. It was perfected on the enslaved. Italians fleeing fascism were immigrants.
