WHEREAS, after four (4) years of exemplary service as a public servant, Commissioner Brandon Johnson will vacate his seat as Cook County Commissioner of the 1stdistrict; and

WHEREAS, Commissioner Johnson grew up with nine siblings in a three-bedroom house with one and a half bathrooms in Elgin; and

WHEREAS, his parents were pastors and foster parents; Johnson was a volunteer at his father's church, leading the youth group and driving a church van; and

WHEREAS, Brandon and his wife Stacie live in the Austin community, where they are raising their children Owen, Ethan and Braedyn; and

WHEREAS, Johnson earned a bachelor's degree in human services, Youth Development Programming, and Management and a master's degree in teaching from Aurora University; and

WHEREAS, Johnson worked as a social studies teacher at Jenner Academy Elementary and George Westinghouse College Prep, both part of the Chicago Public Schools system; and

WHEREAS, he became an organizer with the Chicago Teachers Union in 2011, and helped organize the 2012 Chicago teachers strike; and

WHEREAS, Commissioner Johnson sponsored Ordinances and Resolutions which successfully passed the Just Housing Ordinance, prohibiting discrimination against justice-involved Cook County residents seeking affordable housing; and

WHEREAS, he acted as lead sponsor for the Justice for Black Lives resolution, which called for investments in physical and mental health, jobs, housing, restorative justice, violence prevention, internet access, and additional resources; and

WHEREAS, he stood in solidarity with Little Village and Southeast Side communities in fights for environmental justice; and

WHEREAS, he helped secure over \$100 million in historic violence prevention funding to community

groups working directly in neighborhoods most impacted by violence; and

WHEREAS, he was a part of a coalition that created a dedicated Cook County Public Defender Immigration Unit to provide legal representation and protect immigrant communities; and

WHEREAS, he was a co-sponsor of an ordinance that shut down the Cook County gang database; and

WHEREAS, Commissioner Johnson brought a visionary, and passionate energy to the board; and

WHEREAS, Commissioner Johnson has led with compassion, and dedicated his years of service to helping improve the County for everyone, especially our most vulnerable communities; and

WHEREAS, while we wish nothing but the utmost happiness in his new role, Commissioner Johnson's presence on the board will be missed.

WHEREAS, For the first time in the college's history, this year, the entire team was inducted to the Moraine Valley Hall of Fame to include: Ellen Schultz, Lisa Barcella, Sheila Burke, Jackie Davis, Maureen Frangella, Jackie Gruca, Joanna Poulos, Laura Sartausky, Patti Wolf, manager Carol Filipiak and head

WHEREAS, she has had two retail businesses in Evanston and was one of the founders of the Evanston Main Street Merchants Association working closely with the Evanston Chamber of Commerce; and

WHEREAS, in her Evanston community of almost fifty years, she has served as President of Optima Towers Condominium Association and currently serves as Chair of Evanston First Responders Foundation, Executive Committee member of Downtown Evanston, and V.P. of Canal Park Neighborhood Association; and

WHEREAS, she continues to serve the Evanston community through CERT (Community Emergency Response Team through Emergency Management/Evanston Fire Department-EFD) and the Medical Reserve Corps (through the City of Evanston) where she served in the Evanston vaccine clinics. For her work in CERT with fire assistance in 2010, she received a recognition award from the EFD and City of Evanston and continues to serve in an 'emeritus' position; and

WHEREAS, her family, friends, son, John, and daughter-in-law and dogs are the source of love and joy in her life; and

WHEREAS, she pursued a Master's Degree in English from Adam Mickiewicz University in Poznań, the city her father was born. After completing her Master's, she came to the United States; and

WHEREAS, she is survived by her loving husband Józef. While visiting her uncle in the United States in 1978, her intent was to only stay for the summer. Shortly after arriving to Chicago she ended up meeting her future husband Józef, who became the love of her life and who she built a beautiful life together; and

WHEREAS, the two were joined in holy matrimony at Saint Hyacinth Basilica on November 11th, a date they chose because it was the date Poland briefly regained its independence in 1918; and

WHEREAS, she is survived by her sons Daniel, Christopher (Angie), Phillip (Amber), and daughter Paulina (Whitney). Aleksandra was always full of laughter and instilled in her children the importance of thinking outside the box; and

WHEREAS, she was the loving sister to brother Marek (Maryla) and sister Emilia; and

WHEREAS, she cherished her grandchildren Amelia and Milo, goddaughter Magda, as well as godsons Peter and Martin; and

WHEREAS, she excelled in her career in the hospitality industry thanks to her attention to customer service and knack for human connection.
