Before serving in an elected role, Michael had served as the President and founder of the homeowners association for Haverford Place; and

WHEREAS, the Senior pastors of First Trinity were Ferdinand Doederlein (1866-1877), Louis Lochner (1877-1909), Arthur Both (1910-52), Harold Lachmann (1953-58), Albert Rolf (1959-62), Adam Dietrich (1963-67), Gerald Peppler (1967-78), Ronald Nitz (1979-86), Jonathan Breimeier (1986-95), William Hall (1995-97), Thomas Gaulke (2009-2018), Nicolette 'Nic' Peñaranda (2018-2021) and Christina M. Montgomery (current), and

WHEREAS, the First Lutheran Church of the Trinity has also served as a community center which hosted various community events including clothing drives, art, and music festivals, and

WHEREAS, the First Lutheran Church of the Trinity was the first parish to elect a female president of the congregation, and

WHEREAS, the First Lutheran Church of the Trinity voted to become a Reconciling in Christ congregation welcoming lesbian, gay, bisexual, and transgender parishioners in 2013, and

WHEREAS, the First Lutheran Church of the Trinity has long served the residents of the Bridgeport neighborhood and has been active promoting services for the area, and

PROPOSED RESOLUTION

A RESOLUTION TO STAND IN SOLIDARITY WITH THE WORKERS AND MEMBERS OF THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS AS THEY NEGOTIATE A NEW CONTRACT WITH UNITED PARCEL SERVICE (UPS)

WHEREAS, 12,000 members of Teamsters Local 705 work for United Parcel Service (UPS) in Cook County; and

WHEREAS, the collective bargaining agreement between Local 705 and UPS expires at midnight, August 1, 2023; and

WHEREAS, Local 705's contract with UPS expires at the same time as the rest of the Teamsters' contracts with UPS, which covers 340,000 workers across the country; and

WHEREAS, the Teamsters nationally elected new leadership recently, the Teamsters United Slate, on a platform of building a fighting union that can not only win stronger contracts but also a stronger working class, including electing Local 705's principal officer Juan Campos as International Vice President; and

WHEREAS, the Teamsters' militant and rank and file leadership have spent the last year debating, deliberating, and organizing in anticipation of this contract fight; and

WHEREAS, UPS Teamsters are fighting to eliminate the second tier of package car drivers, known as "22.4 drivers," who make less money and have less stability in their jobs and schedules than regular package car drivers, to ensure that all package car drivers are treated the same; and

WHEREAS, UPS Teamsters are fighting to end part-time poverty, ensuring that the thousands of UPS employees who work part-time are paid dignified wages, so they do not have to struggle to make ends meet for themselves and their families; and

WHEREAS, UPS Teamsters are fighting UPS's efforts to outsource deliveries to non-union, precarious

"gig" workers who deliver out of the back of their own personal vehicles, forcing them to take on the cost and risk of the work while being paid even less than the value of their labor; and

WHEREAS, UPS Teamsters are fighting to ensure that all UPS workplaces are healthy and safe by guaranteeing that UPS install air conditioning into all of their trucks and warehouses to combat the impacts of climate change as it continues to create more dangerously hot days; and

WHEREAS, UPS Teamsters are fighting against the use of invasive surveillance technologies like driver-facing cameras that prevent workers from having a single moment of privacy during their workdays; and

WHEREAS, UPS Teamsters are fighting to ensure that UPS recognizes the history of the Black Freedom Struggle by making Martin Luther King Day and Juneteenth paid holidays; and

WHEREAS, the fight over the UPS contract is a fight that will affect all working people in Cook County and the United States; and

WHEREAS, the demands that UPS Teamsters are fighting for, like living wages, reliable and stable jobs, and healthy and safe workplaces, are the same demands that working-class people across Cook County and the U.S. need to improve their lives; and

WHEREAS, 6% of the gross domestic product (GDP) of the US depends on the labor of UPS's employees;

WHEREAS, UPS, which reported 11.3 billion dollars in record-breaking profits in 2022, is fighting the union mightily, trying to maximize their corporate profits on the backs of workers; and

WHEREAS, major capitalist institutions like Vanguard and BlackRock, who own a majority of UPS, know that if they continue neglecting precarious and dangerous working conditions for these unionized workers by prioritizing their profits over the needs of the workers, they can replicate this profit-driven model over working people across the country; and

WHEREAS, while UPS Teamsters hope that UPS will agree to a fair contract, they are prepared to go on strike if need be and have already authorized a strike by 97%; and

WHEREAS, if UPS Teamsters go on strike, it will be the largest strike in the United States since the last UPS Teamsters strike in 1997; and

WHEREAS, Cook County is a proud union county; and

WHEREAS, the vast majority of Cook County residents are working class, who face many of the same issues that these UPS workers do.

NOW THEREFORE BE IT RESOLVED, that we, the President of the Cook County Board of Commissioners and members of the Cook County Board of Commissioners, stand in steadfast solidarity

with Teamsters at UPS in Cook County and across the country in their fight for a fair contract; and

BE IT FURTHER RESOLVED, that if these workers find it necessary to go on strike to obtain a fair contract from UPS, we will support them in their struggle, including joining them on the picket line; and

BE IT FURTHER RESOLVED, we encourage all working people in Cook County to stand with these workers in their fight in any way they can.

PROPOSED RESOLUTION

A RESOLUTION MEMORIALIZING CHICAGO'S 1966 AND 1977 DIVISION STREET "RIOTS" - THE DIVISION STREET PUERTO RICAN REBELLION

WHEREAS, Chicago's vibrant Puerto Rican community, comprised of 120,000 people, has grown as a stronghold for community organizing after two major events of civil unrest dubbed as the Division Street "riots" of 1966 and 1977, which were the result of its historical socio-economic political marginalization; and

WHEREAS, the Division Street riots were multiple days of civil urban rebellion between June 12-14, 1966 and June 4-5, 1977 in the "Greater Humboldt Park" communities of Humboldt Park, West Town, Hermosa and Logan Square; and

WHEREAS, tensions have been high within the Puerto Rican community during the 1950s, '60s, and '70s as they faced spatial de-concentration in the form gentrification in Lincoln Park, Wicker Park, and Bucktown, housing discrimination based on the color of their skin and their ethnicity (as well as arson on properties for profit and red-lining), health inequity, high unemployment, police brutality, poor educational resources, and a sense of neglect, abandonment, and marginalization by the City of Chicago and local institutions; and

WHEREAS, on June 11, 1966, the inaugural Puerto Rican Parade took place in Chicago's downtown Loop, and that same day, a community member named Cruz Arcelis was shot by a white Chicago Police patrolman on Damen and Division Street. Community members gathered to help Mr. Arcelis with his injury while others came in immediate defense against the police officers involved; and on June 4, 1977, Rafael Cruz and Julio Osorio were assassinated by the Chicago police in Humboldt Park following the 11th Puerto Rican Parade downtown, and the Puerto Rican community once again rose up against this injustice and the overwhelming presence in the area of 500 policemen with canine dogs; and

WHEREAS, following both "riots," the community organized itself to address the plight of the Puerto Rican people in Chicago, the United States of America, and in the island of Puerto Rico; and in the case of the 1977, the incident that began the Puerto Rican People's Day Parade, which this year marked its 45th anniversary.

WHEREAS, in the 1966 case, a series of organizations were created, including the Spanish Action Committee of Chicago (SACC), the Northwest Community Organization, the First Congregational Church of Chicago (led by Jose A. Torres, the only Puerto Rican and Latino to march with Martin Luther King in Selma), and in Lincoln Park -- the Young Lords Organization (YLO) to address the plight of the Puerto Rican people in Chicago, the United States of America, and in the island of Puerto Rico; and

WHEREAS, after these Division Street "riots", the community has made progressive strides in achieving equity and the self-determination for the Puerto Rican people including the creation of Paseo Boricua, the cultural and commercial heartbeat of Puerto Rican Chicago, encased by the world largest flags of steel -- a monument to the Puerto Rican national emblem and now part of Chicago's Landmark legacy; but leaders still recognize that much of the factors that have incited the "riots" still remain.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County President and Board of Commissioners does hereby honor the 1966 and 1977 Division Street Puerto Rican uprising as a paramount event that helped further ethnic and racial equity in Cook County; and

BE IT FURTHER RESOLVED, that the Cook County President and Board of Commissioners praise the county's Puerto Rican organizations for continuing their advocacy for a more just and equitable Cook County.

PROPOSED RESOLUTION

RECOGNIZING THE ONE YEAR ANNIVERSARY OF THE HIGHLAND PARK SHOOTING

WHEREAS, the Fourth of July is traditionally celebrated with parades and festivities; and

WHEREAS, last year, tragedy struck as a gunman utilized a high-powered rifle to open fire on the crowd gathered to celebrate the holiday in Highland Park; and

WHEREAS, in a matter of moments this horrific event took the lives of seven individuals, and injured dozens more; and

WHEREAS, we remember the names of those whose lives were taken too soon: Katherine Goldstein; Irina and Kevin McCarthy; Jacquelyn Sundheim; Stephen Straus; Nicolas Toledo-Zaragoza; and Eduardo Uvaldo. May their memory be a blessing; and

WHEREAS, we recognize the first responders who sprung into action without a moment's hesitation,

tending to the wounded and working to secure the premises; and

WHEREAS, we laud the trauma surgeons, nurses, and doctors at Highland Park Hospital, who have sadly had to train for moments like this one, and who worked tirelessly to aid those coming in through their doors; and

WHEREAS, we lift up the Highland Park community, under the leadership of Mayor Nancy Rotering, who banded together in the face of tragedy to help strangers and neighbors alike, both on the day of the shooting, and in the weeks and months ahead; and

WHEREAS, it is a tragic fact that horrific gun violence happens on a daily basis in Chicago, in Cook County, and throughout our nation - and sadly in stark contrast quite often without garnering a similar sympathetic response. Per the Gun Violence Archive, there have been 311 mass shootings through mid-June alone; and

WHEREAS, we cannot continue to stand idly by as we lose community members to entirely preventable gun violence at parades, in their homes, at the grocery store, on the playground, in movie theaters, at schools, or in their places of worship; and

WHEREAS, we must commit to enacting common sense gun laws, expanding access to mental health care, and eradicating hate that is all too pervasive in our day to day lives; and

WHEREAS, these are lofty goals are essential to the well-being of our communities and their residents. Without action, we are doing a great disservice to those who have lost their lives to senseless gun violence; and

WHEREAS, to community support and solidarity, the Highland Park community will again gather this 4th of July for a remembrance ceremony followed by a community walk of the 2022 parade route as a sign of resilience; and

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners expresses its support of the strength and spirit of the Highland Park community as they continue to heal from last year's gun violence; and

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby vow to support efforts that reduce gun violence, expand access to mental health resources, fight against hate, and create positive opportunities for young people; and

BE IT FURTHER RESOLVED, that a suitable copy of this Resolution be spread upon the official proceedings of this Honorable Body and that an official copy of same be tendered to the Village of Highland Park as a means of communicating our unwavering support.
