Dear Cook County Board Members,

I write to you today regarding a proposed ordinance (23-211) that would ban the sale of certain flavored vape products in the County. The Illinois Fuel and Retail Association (IFRA) is firmly against a complete ban on flavored products, and here is why.

The only thing a total ban will accomplish is driving adult consumers to other counties or across state lines and to illicit markets where sellers are unconcerned about age-of-purchase laws and other efforts to prevent youth access to these age-restricted products. The results could actually mean increased access to tobacco/vape products at a time when youth smoking rates are at an all-time low.

Take the State of Massachusetts for example; on November 27, 2019, Massachusetts became the first (and only) state to permanently ban the sale of all flavored tobacco products. This includes mint and menthol cigarettes, flavored electronic cigarettes (vaping and heat-not-burn), and smokeless tobacco. The law also included a 75 percent excise tax on e-cigarettes. The stated purpose behind this proposal was to stop an epidemic of youth vaping and prevent teenagers from beginning a lifetime of addiction.

What happened after the ban was passed?

Massachusetts' loss became its neighboring states gain. Cigarette excise tax stamp sales dropped 23.9 percent in Massachusetts while New Hampshire gained \$28,574,340 or 29.7 percent. Rhode Island gained \$12,100,000 or 18.2 percent in excise taxes. The estimated Massachusetts loss including the sales tax was \$73,008,000 while Rhode Island saw a gain of \$14,066,740.

Before Cook County decides to unilaterally enact an anti-flavor ordinance, I would urge the entire Board to carefully examine what has happened to Massachusetts since the ban was put in place. Is a vast reduction in tax revenue, especially as local governments continue to struggle financially following a global pandemic, really worth it as adult consumers can simply take their money to neighboring suburbs to purchase these products?

No one can disagree with the objective of reducing smoking and, in particular, working to keep vaping products out of the hands of youth. The retailer members of our Association work hard to that end. They are bound by contractual restrictions and take steps to ensure their clerks obey laws prohibiting sales to youth. Many of them participate voluntarily in training programs—such as We Card—which not only puts young people on notice that age-restricted products will not be sold to them illegally, but also provides training to team members on how to prevent underage sales.

Moreover, illegal cigarette sales are on the rise across the Chicagoland area, contributing to a tobacco and cigarette related illicit market that in turn fuels increased levels of violent crime both here and in major metro areas across the country. That's why it's critical that policy makers understand that banning flavored products can ultimately create more harm than good.

Teen use of electronic cigarettes fell sharply in 2021, the second consecutive year of big declines, according to the government's annual National Youth Tobacco Survey. Moreover, in 2021, only 11.3 percent of high school students reported that they currently vape — down from 19.6 percent in 2020 and strikingly lower than the 27.5 percent reported in 2019, according to a recent report of a survey issued by the Centers for Disease Control and Prevention.

Banning flavored vape products in the County would take one of the most lucrative and violent illicit tobacco markets in our nation and make it even worse.

In fact, an analysis conducted late last year by the Tax Foundation and the Mackinac Center for Public Policy found that as many as 17.2 percent of cigarettes smoked in Illinois in 2017 were smuggled into the state from elsewhere, placing us in the worst 15 states for

cigarette smuggling. When almost 1 in 5 cigarettes smoked in the state come from illicit sales, it's clear that criminals see profits to be made.

Criminals already have an arbitrage opportunity to capitalize on the tax disparity between states. They buy truckloads of cigarettes in low-tax markets such as Missouri or Indiana and smuggle them back into high-tax markets like Chicago, where taxes can add \$8.17 to the cost of a pack of cigarettes. There's a significant profit motive, and a lot of cash to be made. That cash, unfortunately, is used to buy guns and drugs, or to fund other criminal enterprises.

We know that bans don't work. Prohibition of alcohol was a failure, it led largely to bootlegging and unacceptable levels of violence; the federal government's misguided "war on drugs" that saw marijuana banned and classified as a Schedule I narcotic also failed, with individual state governments finally coming to their senses, Illinois included, and crafting sensible drug policies that work. Why then would Cook County be in such a hurry to craft a new ban and create a new illicit market for an otherwise legal product? It doesn't make sense.

Unfortunately, an ordinance that bans ALL flavored products represents a step backwards for Cook County policy makers. It's costly to taxpayers, won't fix the problem it's intended solve and will unfortunately create Illinois' newest and most lucrative black market fresh on the heels of putting one out of business.

Cook County should remain focused on what works. More targeted enforcement, along with stiffer penalties, will produce more effective results. Elected officials should look to strengthening enforcement where it is needed both online and in-store as well as engaging in educational campaigns against youth vaping and use of tobacco products. I remind you again that Illinois retailers and adult tobacco users are not the problem.

Honorable Members of the Cook County Board of Directors,

I am Reid Nuttall, the owner and operator of Cool Clouds Vapor Shop. Since opening my store in 2014, I have assisted over 10,000 people in transitioning away from deadly combustible cigarettes. I also serve as the Vice President of the Smoke-Free Alternatives Coalition of Illinois. Our organization's mission is to ensure quality and affordable vapor products are available for current and former cigarette smokers in Illinois. Our members are industry-leading retailers, manufacturers and distributors of nicotine vapor products and have consistently advocated for reasonable regulation of vapor products.

Today, I stand in opposition to Bill 23-2311, which proposes to ban the sale of flavored vapor products in our county. While I respect the intention behind this bill—to protect the health and well-being of our young people—I am deeply concerned that its implementation will not achieve these objectives and may also generate numerous unintended consequences.

Firstly, this bill is predicated on the notion that banning flavored vapes will significantly decrease teen usage. While we all share concerns about teen vaping, the data invoked to validate this legislation lacks crucial context and is misleading in its current presentation. It's crucial that our legislative decisions are informed by data that is not only accurate but also presented in its full context to provide a realistic picture of the situation.

Second, this bill seems to undermine the principle of harm reduction, a fundamental component of modern public health policy. For many adults battling nicotine addiction, flavored vapor products offer a less harmful

alternative to traditional cigarettes. By restricting access to these products, we risk pushing these individuals back towards traditional, more harmful methods of nicotine consumption or towards unregulated black markets.

Additionally, this bill would create a direct conflict with existing state laws. The proposed signage requirements, stating that the sale of tobacco products to anyone under the age of 18 is illegal, directly contradict the state law which mandates 21 as the legal age for purchasing such products. This inconsistency creates confusion and undermines the credibility of our legal institutions.

In 2016, I cautioned against a tax that would incentivize high-nicotine products. Now, in 2023, we grapple with the repercussions of that decision. We find ourselves contemplating adding even more restrictions to the very products that were created as a result of our past legislation. We must learn from our past and not repeat these mistakes.

This bill, if passed, will hand over a monopoly on vapor products to big tobacco, leaving our county to rely on RJ Reynolds to ensure that harm-reducing vapor products are designed in a manner that cigarette smokers find acceptable.

A century ago, legislators sat in a room similar to this one, deciding the fate of cannabis in our state. The concerns we address today eerily echo those from that time. We chose prohibition then and ended up sending a quarter of our minority male population to prison for consuming a substance that should have been legally available for adult consumption.

I urge this Board to delay action today to allow for a thorough understanding of this issue to be explored by its members. The lives of county residents hang in the balance, and hastily pushing through flawed legislation does not reflect good governance.

In closing, I implore you to reconsider the implications of Bill 23-2311. We need evidence-based solutions to address the issue of teen vaping, rather than blanket bans that may cause more harm than good. Let us work together to create a policy that genuinely protects our youth, respects adult rights, and upholds the integrity of our laws.

I extend my decade of experience in helping craft reasonable regulations on vapor products to any member of this board. We are allies in the fight to reduce teen nicotine consumption. However, persuading the parents of these same teens to exclude harm-reduction strategies isn't just an oversight—it's an action that could precipitate the preventable loss of life within the very citizenry this board is committed to serving.
