On behalf of the Prospect Heights Park District Board of Commissioners, I am requesting an exemption to mirror the state exemption for the county paid leave ordinance. I am concerned that this will have a big impact on the Park District. Prospect Heights is a nonhome rule municipality so we have no way to opt out. We believe the financial impacts to the Prospect Heights Park District are estimated to be \$78,000 - \$250,000 for part time and seasonal employees (maintenance, parks, grounds, office, guards, instructors, etc.). This financial impact is significant to a small park district with a total operating budget of \$6million. We have been discussing ways to potentially pay for this as our operating budget is very lean and some possibilities are to increase program fees which may make programs cost prohibitive and then be canceled due to lack of registration or decreasing the number of staff we have for lifeguards, summer camp, preschool program, etc. or cut the hours of operation both of which affect the quality of the programs. We also need to include the pay for the substitute employees when the others are on "paid leave", so business is not interrupted. Prospect Heights Park District operates 14 parks (with playgrounds, courts, and fields, etc.), a recreation center (with swimming pool, fitness center, etc.) an 18-hole golf course, several buses, etc. As you can imagine the upkeep is costly and constant for capital improvements in addition to operations. Each dollar the District "saves" goes to fund capital improvements. Not being prepared for this mandate will create a financial hardship. Thank you for your consideration.

Thank you for the opportunity to share my voice as the Executive Director of the Northbrook Park District. I am writing in support of amending Ordinance 23-553 File# 24-1233, commonly known as the paid leave act. If this act remains unchanged, it will negatively impact the Northbrook Park District's ability to provide services to our community.

While some groups have framed Cook County Park District's request to amend the paid leave act as an assault on the rights of hardworking adults in Cook County, this couldn't be farther from the truth. The Northbrook Park District, on average each year, provides 36 fully paid days off to full-time staff, including those within our bargaining unit positions. The District also provides paid time off to year-round part-time staff.

Where the ordinance falls short of supporting the District's operation is when seasonal staff are factored in. The Northbrook Park District employs nearly 600 seasonal staff who, on average, work between 250-350 hours each summer. These are high school and college students, many of whom are in their first jobs as camp counselors and lifeguards. These individuals typically are not supporting families and are working during school breaks.

Districts are already challenged to operate our camps and facilities during holidays, local music festivals, and periods of excessive heat. We must achieve this in an economic climate where even the slightest cost increase can cause participants to be excluded. By passing this ordinance in its current form, the Cook County Board has effectively passed a fee increase for services on to Northbrook residents. This act will now make providing services more difficult, not easier.

This unfunded mandate blindsided the District, and we are not prepared financially or organizationally to provide and manage this benefit time. I respectfully request that you consider a two-way dialogue to find common ground that achieves the goals of the Paid Leave Act without unduly burdening local governments.

My name is Michelle Tuft, and I am the Executive Director of the Skokie Park District. I would like to express support for a compromise of the Paid Leave For All Workers Act as it is currently proposed.

The first compromise is changing the effective date to January 2025 which will allow park districts to prepare for the new law and budget for the increased salaries.

The second compromise is to increase the number of days that an employee must work before the leave benefits become available from 90 days to 120 days. This will help the district manage the leave of seasonal employees who are primarily college and high school students who work over the summer as lifeguards, day camp counselors, and cashiers. As the act is currently written, most of these seasonal employees become eligible to take their leave after 90 days, at the end of the summer, which is when park districts struggle to keep the pools open, and camps staffed. Safety in our programs is imperative and the timing couldn't be worse. Park districts depend on these seasonal staff and rehire these young adults for as many summers as possible. Retaining these staff over multiple summers allows them to mature and improves the quality of our camp programs and pool operations. If these employees come back over multiple summers, which is extremely common, the 120 days in a year would likely occur at the beginning of the summer when they return to the district. This would allow the staff to take time off throughout the summer and will help tremendously with the end of summer staffing shortage issues.

I believe the intent of the act is to provide much needed time off for part-time staff, especially those workers who are employed year-round and are supporting their families through their employment. Changing the wait period to 120 days will not negatively impact these workers and will not negatively impact the end of season operations of the district.

My name is Kevin Romejko and I am the Executive Director of the Rolling Meadows Park District, a unit of local government within Cook County. I'm writing in favor of the proposed Paid Leave Ordinance Amendment (24-1233).

As I imagine you are aware, park districts have been exempted by the Paid Leave for All Workers Act by the state of Illinois (Act 820 ILCS 192). However, unfortunately, park districts were not similarly exempted by the Cook County Paid Leave Ordinance. I am writing today respectfully requesting the County Board enact Amendment 24-1233 to its Paid Leave Ordinance to exempt park districts; thus, matching the state's Act.

Park districts are a vital and essential part of each and every community within Cook County. The added expense this unfunded mandate would create for our park district in Rolling Meadows, and park districts across Cook County, would mount to hundreds of thousands of dollars, which we will then need to offset with increased user fees in areas like outdoor pools, swim lessons, fitness memberships, preschool, and childcare.

During the COVID-19 Pandemic, park districts were there for the residents of Cook County, your constituents. We provided safe, outdoor activities, continued to maintain our playgrounds, ballfields and open spaces; opened our doors to those families needing a safe environment for e-Learning; and provided opportunities for virtual recreation to those unable to leave their homes.

The requirement of paid time off for all workers, though exemplary in its concept, does not fit well for park districts that employ the greatest majority of our part-time staff during the summer.

Many of these employees are high school and college teenagers often working their first job to gain experience for their future careers. As part-time employees they are not the major household income provider, and we allow tremendous flexibility for time off per their requests. The majority of these seasonal staff will quite simply accrue the time and then receive extra pay when they leave, nullifying the intent of your ordinance.

On behalf of park districts across Cook County, I respectfully ask you please understand the special circumstances of park districts and the good we provide to our communities and enact Amendment 24-1233 excluding park districts from the Paid Leave Ordinance.
