My name is Brian Anthony, I am President of The Brewer Company and acting Chairman of the Pavement Coatings Technology Council (PCTC). I have worked for The Brewer Company for thirty years, rising from the position of Technical Director to President. Though we were founded in 1933 as a family-owned business, we became an Employee-owned business (ESOP) in 2012, when the remaining family shareholder sold the business to our employees. We average approximately 46 full-time employees, over 1/3 of which are employed in Illinois.

We have been manufacturing and/or distributing pavement sealers, predominantly refined coal tar based, since the 1960's. In the State of IL, we operate a manufacturing facility in LaSalle (5 employees) and two (2) distribution centers, one in Markham (7 employees) and the other in Bensenville (5 employees).

We respectfully register our opposition to this ordinance for several reasons, including but not limited to:

- Independent, third-party testing has demonstrated that the science (USGS study) which serves as the basis for this ordinance is flawed and has been debunked.
- The alternative products available on the market are inferior in performance and some are more than double the price of refined coal tar sealant. These alternatives, lasting only half as long as refined coal tar sealants, will double to quadruple the cost of maintenance for the property owner. Additionally, the more frequent maintenance applications will virtually double the carbon footprint and will yield significant increases to landfill waste due to pre-mature asphalt pavement failures and resurfacing remedies.
- Refined coal tar sealants are:
 - o FAA approved for use on municipal airports.
 - o Currently specified for use in bridge deck water proofing in the State of Illinois.
- No current or historical studies have ever directly linked the use of refined coal tar pavement sealers to adverse human health effects.
- The proposed ban language is vague and contains gaps:
 - o "Sell at retail" is not a defined term. A quick Google search generates a plethora of "definitions".
 - o The ordinance is silent on validation and enforcement mechanisms.

Dear Commissioners,

I respectfully request that you the ban of coal tar sealant in Cook County.

I am the Executive Director of the Pavement Coatings Technology Council, a non-profit organization dedicated to the research and education of pavement coatings, and I am writing to formally oppose Commissioner Trevor's proposed bill banning coal tar sealant. Our members provide pavement maintenance services to businesses, homeowners, and local governments in your community. We have done many projects in your area the last several years.

The proposed ordinance would virtually ban the use of effective and long-used products that protect and extend the life of parking lots, home driveways, sport/playground surfaces, and many other pavements. It would require contractors like me to use more expensive, less reliable products that have shorter lifespans. This would result in more frequent sealant applications and more costs to residents and businesses.

Most importantly, advocates of this ban incorrectly assert that "Polycyclic aromatic hydrocarbons" (PAH) found in certain kinds of asphalt sealant are responsible for wide-ranging negative health and environmental outcomes – there is no proof of these assertions. PAHs are everywhere in our environment -- motor oil, automobile exhaust, electricity generation, wood-burning, and even barbeque grilling. This legislation singles out one type of product based on flawed or non-existent data. There is also no demonstration that bans or restrictions in the few localities that banned sealants, have reduced the presence of PAHs in the surrounding environment.

PLEASE OPPOSE this ban. It is an overreaching ban of a reliable product that will hurt businesses. It will also not have a demonstrable positive impact on the environment.
