As a HUD-designated fair housing organization serving the northern suburbs of Chicago, our organization has long been frustrated with the ubiquitous presence of so-called "crime-free" and nuisance ordinances (CFNOs). As part of the coalition to pass the Community Safety Through Stable Homes Act, we believe that municipalities can pursue safe neighborhoods without threatening housing stability or punishing landlords for alleged criminal activity of their tenants (often entire families are evicted due to the actions of a single family member, and the vast majority of CFNOs do not even require convictions to enact penalties). Many supporters of CFNOs can only point to a reduction of calls for service as a metric of success, which we view as highly problematic given the needs that victims of crime, survivors of gender-based violence, and people with disabilities disproportionately have to contact law enforcement. These ordinances also present serious fair housing compliance considerations - covered criminal history as well as arrest record are protected classes in the region. We strongly support the County's resolution and encourage other IL stakeholders to consider supporting the Act.
