#### HONORING OFFICERS MICHAEL A. MCEVOY, KEVIN SULLIVAN, AND MICHAEL TURANO AND INTERIM FIRE CHIEF KENNETH KOEPPEN FOR THEIR BRAVERY AND SERVICE ON DECEMBER 12, 2013

**WHEREAS,** on the evening of December 12, 2013, Officer Michael A. McEvoy responded to a 9-1-1 call reporting a man with a gun at a townhome in the 1900 block of Windham Court in Arlington Heights; and

**WHEREAS,** Officer McEvoy, as the first officer on the scene, approached a service entrance through an open garage door and, immediately upon entering the entrance, came under gunfire; and

WHEREAS, Officer McEvoy sustained a gunshot wound through the neck; and

**WHEREAS,** upon arriving at the scene moments later, Officer Kevin Sullivan immediately - and without regard for his own safety - entered the garage, grabbed Officer McEvoy by the leg and attempted to pull him to safety; and

**WHEREAS,** Officers Michael Turano and Douglas Glanz, upon arriving at the scene and also without regard for his own safety, quickly entered the garage and assisted Officer Sullivan in pulling Officer McEvoy out of the residence to safety behind a patrol vehicle at the end of the driveway; and

**WHEREAS,** Fire Chief Kenneth Koeppen, visiting a relative a few blocks away, heard the commotion, and rushed from his family gathering to offer assistance; and

**WHEREAS,** Chief Koeppen, as the first medical officer on the scene, began administering first aid to Officer McEvoy with the assistance of Officers Turano and Glanz, applying direct pressure to the wound and significantly slowing the bleeding; and

**WHEREAS,** Officer Sullivan maintained cover of Officers Glanz, Turano and Chief Koeppen as they worked to stem Officer McEvoy's bleeding until paramedics arrived; and

**WHEREAS,** police officers and SWAT team members, knowing that the assailant had a hostage, attempted to negotiate with him until circumstances required them to take action while, at the same time, the hostage was rescued unharmed; and

**WHEREAS,** the quick and heroic response by Officer Michael A. McEvoy, Officer Kevin Sullivan, Officer Michael Turano, Officer Douglas Glanz, and Interim Fire Chief Ken Koeppen, as well as all of the first responders involved in this incident, demonstrates the dedication of police and firefighters in Cook County and exemplifies the finest tradition of the Arlington Heights Police and Fire Departments.

# COMMEMORATING THE LIFE, MANY ACCOMPLISHMENTS AND MEMORY OF JAMES L. WHIGHAM

**WHEREAS**, James L. Whigham , a man whose life was devoted to public service, family, and faith, died on July 5, leaving friends, family and a community profoundly enriched for having known him; and

**WHEREAS,** James Whigham grew up in the East Garfield Park neighborhood on Chicago's west side where he attended St. Mathew's Catholic School and Quigley North Seminary; and

**WHEREAS**, after graduation from Quigley, James Whigham's strong ties and dedication to his community lead him to enter the Chicago Police Department Cadet Academy where his positive attitude and hard work earned him the respect of his fellow cadets and brought him recognition by his superiors; and

**WHEREAS,** James Whigham's dedication to service was not limited to his immediate community. He proudly served his country during the Vietnam War and left the service of his country to return to the Chicago Police Department; and

WHEREAS, James Whigham served with distinction and was singled out for recognition at the Chicago Police Department. He achieved the highest civil service rank possible, Captain. Whigham was selected by several police superintendents to serve in the exempt executive ranks and was elevated to Police Commander of two police districts and later served as Deputy Superintendent. His exemplary work was further recognized when he was chosen to run the police training academy where he helped shape the next generation of Chicago law enforcement. In further recognition of his expertise he was selected to create the new 911 Emergency Phone Response Center; and

**WHEREAS**, Senator Richard Durbin noted James Whigham's leadership and recommended him to President Bill Clinton who appointed him U.S. Marshal for the Northern District of Illinois. James Whigham became the first African American to ever serve in that role. His extraordinary leadership skills were utilized by the U.S. Marshals service in its response to the September 11, 2001 terrorist attacks on the World Trade Center; and

**WHEREAS** James Whigham's prodigious management, leadership and organizational talents were recognized and put to use by Cook County Board President John Stroger who appointed him to be the Inspector General of Cook County and then later as his Chief of Staff. After leaving the County he served the village of Hazel Crest as their Village Manager; and

**WHEREAS,** James Whigham was a firm believer and supporter of higher education. He received his undergraduate degree and one of his graduate degrees from Chicago State University, was a graduate of Northwestern University's Public Safety Institute and received a degree from the Strategic Management Program at the Harvard University's John F. Kennedy School of Government; and

**WHEREAS,** just as he had taken his skills to teach the next generation of law enforcement officers at the police training academy, James Whigham took his talents to Governor's State University, where, as a university lecturer in their Masters of Public Administration program he helped shape the next generation of community leaders and civil servants; and

**WHEREAS**, James Whigham will be sorely missed by his family members. He was the proud father of three children: James, Summer and Jonathan was the treasured brother of Joe, Patricia, Odeal, Janel, Janetta and Raquel.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Commissioners of Cook County, on behalf of the 5.2 million residents of Cook County commemorates the extraordinary life of James L. Whigham, and herewith expresses its sincere gratitude for the invaluable contributions he has made to the Citizens of Cook County, Illinois; and

#### PROPOSED RESOLUTION

## **RESOLUTION DECLARING JULY 17TH, 2014 AS BROADBAND ADOPTION DAY IN COOK** COUNTY.

**WHEREAS,** In today's digital world with the increasing utility and reliance upon internet based applications and information, ready access to an affordable, reliable broadband internet connection in the home connects families to numerous economic, educational, health and social benefits; and

**WHEREAS**, In a November, 2012 report titled *Broadband Adoption in Illinois: Who is online, who is not, and how to expand home high-speed adoption* conducted by the Partnership for a Connected Illinois 32% of residents did not have a broadband internet connection at home, an issue that disproportionately affected minorities with 44% of black and Hispanic households not having a broadband connection at home; and

**WHEREAS,** When asked to elaborate on why they have not adopted broadband in the home 65% of non-adopters indicated cost was a factor but the next two factors at 58% and 44% respectively, were lack of relevance and overall digital literacy; and

WHEREAS, A February 28, 2013 Pew Research Center report titled *How Teachers Are Using Technology at Home and in Their Classrooms* shows that while 79% of teachers reported having students access or download an assignment from an online site that only 18% reported that all or almost all of their students had access to the digital tools they need at home; and

**WHEREAS,** Significant infrastructure investments have moved our nation forward and shifted the focus from access to adoption as evidenced by Partnership for a Connected Illinois data dated June, 2012, Cook County has 0% unserved and 0% underserved occupied households. Broadband Illinois defines an area as being "underserved" as areas having the maximum advertised download speeds of less than 3 Mbps; and

**WHEREAS**, Across the county there are several non-profits that offer digital literacy training that exposes participants to the many uses of the internet including applying for jobs, seeking medical information, social networking, furthering education and accessing government services; and

**WHEREAS**, Effective and diligent cooperation by public leaders, civic organizations and private companies is an essential ingredient in the success of any program aimed at promoting greater broadband adoption; and

**WHEREAS,** An effective example of that diligent cooperation is Comcast's Internet Essentials program which addresses the main barriers to adoption by offering families with at least one child that qualifies for the National School Lunch Program and meets other program requirements the ability to receive broadband service at home for \$9.95 a month and to purchase a computer for under \$150 as well as to participate in digital literacy training.

**WHEREAS,** Internet Essentials is helping our communities compete in the 21st century; 98% of families with Internet Essentials are using the internet for schoolwork, 65% are using their internet access for healthcare and government services, 64% are using their internet access to pay bills and 58% are using their home based access to search for jobs.
