At the time of his departure, the organization encompassed three operating divisions with a total staff of approximately one hundred and seventy five. The various operating divisions include a housing development function, a property management organization and a marketing company, which engaged in both research and the implementation of marketing programs. In performing community planning and development activities all three groups worked as a team to provide a comprehensive approach to the problems.

During the twenty-two years of his leadership the organization developed over 3,400 units of all types of housing. The developments undertaken by the corporation during this period included both subsidized and market rate housing, new construction and rehabilitation, rental and for sale products and also a mix of family and elderly facilities. The company had a management portfolio in excess of 4,000 dwelling units of which approximately one third was for outside clients and the marketing company produced numerous research, relocation, planning and market studies for numerous third party clients as well as serving the needs of its sister corporations. And in all of its endeavors, the RESCORP companies earned a widely recognized reputation for excellence, integrity and professionalism. All of the corporation's affordable housing developments, including those created over twenty years ago, were operated successfully and most still remain as elements of strength, pride and stability in the communities where they are located.
