Thank you for your letter regarding V 14-54. I have clearly heard how alarming this proposal is to you, which is why we remanded it back to the ZBA for you to have a second opportunity to present your case.

The two appearances before the Zoning Board of Appeals provided the appropriate occasion to ensure that this variance has been thoroughly vetted and give your concerns every consideration.

The Zoning Board of Appeals and their decision making process is designed to safeguard full consideration regarding any proposed variance, by carefully following parliamentary and ethics rules, as well as zoning codes.

Prior to our last discussion, however, I was unaware of the architectural firm associated with the project. Mr. Heaney and I have been personal and professional friends for 35 years. He designed my home, my parents' home, my sister's home and hundreds of apartment and condominium units that my company has developed over the years. Although I have not talked to him about this project, (and in fact have not talked to him in the last year), because of this history, and to avoid even the appearance of impropriety, and after consultation with the Cook County Inspector General, I will be recusing myself from voting on this matter.

With respect to other commissioners, as has been my practice over 16 years, I simply do not make recommendations or lobby for their vote for a particular outcome in zoning matters.
