HONORING THE SERVICE OF HON. ABISHI C. CUNNINGHAM JR. AS PUBLIC DEFENDER OF COOK COUNTY

WHEREAS, after graduating from Fisk University with a Bachelor of Science in 1969; and the Northwestern University School of Law with a Juris Doctorate in 1972. The Honorable Abishi C. Cunningham Jr., a native of West Virginia, became a member of the Illinois Bar; and

WHEREAS, after a brief stint as legal advisor to the State Superintendent of Public Instruction he joined the Cook County State's Attorney's office as a felony trial assistant, Judge Cunningham would also serve as Chief of the Vertical Prosecutions Unit. Later in his career, he would rejoin the State's Attorney's office as a supervisor of all misdemeanor and quasi-criminal cases; and

WHEREAS, after leaving the State's Attorney's office in 1976, Judge Cunningham joined the Criminal Defense Consortium of Cook County as a Supervisor of that organization's Lawndale office; and

WHEREAS, Judge Cunningham joined the bench as a Cook County Circuit Court Judge in 1986. During his time on the bench, he presided over thousands of bench trials, hundreds of jury trials, and was appointed by the Chief Judge to mentor newly appointed and elected judges. His last judicial assignment was in the Law Division, where he presided over an array of civil matters; and

WHEREAS, on April 1, 2009, after being appointed by then County Board President, Todd Stroger, Judge Cunningham was sworn into the office of Public Defender of Cook County by his sister and Presiding Judge of the Sixth Municipal District, Hon. Marjorie Laws; and

WHEREAS, during his six-year term as Public Defender, Judge Cunningham has diligently carried out his mission to uphold the Constitutions of the United States of America and the State of Illinois; and protect the rights, liberties, and dignities of every person his office was appointed to represent.

WHEREAS, the American Indian College Fund's 25th anniversary events commenced in 2014 and will continue throughout the 2014-2015 academic year as an opportunity to educate others about the American Indian College Fund's mission while securing financial support for scholarships and tribal college support throughout major metropolitan areas across the United States, including Chicago, which enjoys a large Native American population; and

WHEREAS, the American Indian College Fund's 25th Anniversary Gala will be held Friday, May 8, from 6:30 p.m. - 10:00 p.m. at the historic Drake Hotel in Chicago.

PROPOSED RESOLUTION

RECOGNIZING MAY AS NATIONAL MENTAL HEALTH MONTH IN COOK COUNTY

WHEREAS, May is National Mental Health month, dedicated to raising awareness about mental illness and related issues in the United States; and

WHEREAS, according to the National Alliance on Mental Illness (NAMI), nearly 60 million Americans experience a mental health condition every year; mental illness impacts the lives of at least 1 in 4 adults and 1 in 10 children across the United States, regardless of race, age, religion or economic status; and

WHEREAS, mental health is an essential component of overall health and well-being and is tied to the balance that exists between our emotional, physical, spiritual and mental health; and

WHEREAS, negative attitudes, stereotypes and misunderstandings about mental illness create tremendous barriers for people with mental illness as well as their families; and

WHEREAS, promotion and prevention are effective ways to reduce the burden of mental health conditions and, with effective treatment, those individuals with mental health conditions can recover and lead full, productive lives; and

WHEREAS, over the past decade, governments have cut billions from their mental health budgets, shuttering clinics across the country including here in Illinois and Cook County, resulting in thousands of mentally ill people funneling in and out of our jails that are ill-equipped to handle them, effectively criminalizing mental illness; and

WHEREAS, in Cook County, it is estimated that up to 30% of inmates being held in the county jail have a mental illness on any given day, making the jail the nation's largest mental health facility; and

WHEREAS, it costs \$143 per day to house an inmate at the Cook County jail but due to the costs of medication and the extra supervision and care that are required to support inmates suffering from mental

illness, that number increases to upwards of \$200 per day; and

WHEREAS, each business, school, government agency, faith-based organization, health care provider, and citizen has a responsibility to promote mental wellness and support prevention efforts;

NOW THEREFORE BE IT RESOLVED, that the President and the Cook County Board of Commissioners does hereby declare the month of May as Mental Health Month in Cook County; and

BE IT FURTHER RESOLVED, that the Cook County Board of Commissioners urges citizens, government agencies, public and private institutions, businesses and schools in Cook County to recommit to increasing awareness and understanding of mental health, the steps our citizens can take to protect their mental health, and the need for appropriate and accessible services for all people with mental health conditions; and

PROPOSED RESOLUTION

RECOGNIZING MAY 1, 2015 AS NATIONAL LAW DAY

WHEREAS, Law Day is a national day set aside to celebrate the rule of law. Law Day underscores how law and the legal process contribute to the freedoms that all Americans share; and

WHEREAS, Law Day has its origin in 1957, when American Bar Association (ABA) President Charles S. Rhyne envisioned a special day for celebrating our legal system; and

WHEREAS, on February 3, 1958, President Dwight D. Eisenhower established Law Day by issuing a Proclamation proclaiming it "fitting that the people of this Nation should remember with pride and vigilantly guard the great heritage of liberty, justice, and equality under law which our forefathers bequeathed to us." Every President, since President Eisenhower, has issued an annual Law Day Proclamation; and

WHEREAS, on April 7, 1961, Congress passed a Joint Resolution, designating May 1 as Law Day. The theme of Law Day 2015 is "Magna Carta: Symbol of Freedom Under Law"; and

WHEREAS, this Law Day marks the 800th anniversary of Magna Carta, the "Great Charter" issued at Runnymede in England in 1215. Law Day also provides an opportunity to recognize that Magna Carta has come to embody a simple but enduring truth: No one, no matter how powerful, is above the law; and

WHEREAS, Magna Carta's most oft-cited provision, Chapter 39, declares, "No free man shall be seized or imprisoned, or stripped of his rights or possessions ... except by the lawful judgment of his equals or by the law of the land." In this provision, Americans can associate the early roots of our cherished due process rights with Magna Carta; and

WHEREAS, Magna Carta is an international symbol of freedom under the law and an inspiration for many basic rights revered by Americans, including due process, habeas corpus, trial by jury, and the right to travel; and

WHEREAS, Magna Carta has been cited in over 170 U.S. Supreme Court opinions most often in support of due process of law and trial by jury which are legal tenets at the heart of the American justice system; and

WHEREAS, Law Day, May 1, 2015, will provide an opportunity to commemorate this "Great Charter of Liberties," and rededicate ourselves to advancing the principle of rule of law.

NOW, THEREFORE, BE IT RESOLVED, that the President and the Cook County Board of Commissioners do hereby recognize May 1, 2015 as National Law Day and its theme of "Magna Carta: Symbol of Freedom Under Law"; and

BE IT FURTHER RESOLVED, that Cook County Law Library will be celebrating Law Day 2015 with outreach focused on advancing the principle of rule of law in the spirit of Magna Carta.

WHEREAS, YSP remains on course with their core value services, the at-risk youth of these communities will continue to benefit for years to come from programs such as: "To The Moon" Art program, Addiction Intervention, Transitional Living, Independent Living, Crisis Intervention, Clinical Services, Youth Leadership Academy, Career & Workforce Development, Girl Empowerment, Anti-Bullying, Teen Parenting Skills and Juvenile Justice Community Support.

PROPOSED RESOLUTION

COMMEMORATING THE EXCEPTIONAL LIFE AND LEGACY OF HIS HOLINESS KHANANIA MAR DINKHA IV CATHOLICOS-PATRIARCH OF THE ASSYRIAN CHURCH OF THE EAST

WHEREAS, beloved humanitarian, cleric and theologian Patriarch Khanania Mar Dinkha IV, who was the 111th Catholicos-Patriarch of the Holy Apostolic Catholic Assyrian Church of the East, died in exile from Assyria on March 26, 2015. His Holiness spent his last days as a citizen of Morton Grove and in exile was the spiritual leader of nearly half a million adherents from throughout parts of India, Iran, Syria, Turkey, Lebanon, Israel, United States, Canada, Australia, New Zealand, United Kingdom, France, Belgium, Austria, Germany, Russia, Denmark, Sweden, Switzerland, Italy, Georgia, Oceania; and

WHEREAS, Patriarch Khanania Mar Dinkha IV devoted himself to keeping the Assyrian faith community alive throughout the world and tirelessly worked to protect the customs and language of the world's first Christians; and

WHEREAS, Patriarch Khanania Mar Dinkha IV was consecrated as Patriarch on October 17, 1976, and served nearly 39 years as Patriarch; the tenth longest in church history. He moved the Holy See of the Church of the East to Morton Grove, shortly after his consecration because of political instability in Iraq; and

WHEREAS, Patriarch Dinkha promoted closer relations with the Catholic Church, both with the Vatican and the Chaldean Catholic Church; he first met Pope John Paul II immediately after the Pope's election in 1978 and made his first visit to the Vatican in 1984. The two continued to meet informally over the next decade. After a decision by the Holy Synod of the Assyrian Church of the East to have better relations with the Roman Catholic Church in 1994, Dinkha agreed to a Joint Christological Declaration with the Holy See; and

WHEREAS, Patriarch Dinkha is credited with rebuilding the church, which had neared the brink of destruction after the assassination of his predecessor. He translated portions of the liturgy from classical Assyrian to modern Assyrian and brought stability and peace to a church in turmoil; and

WHEREAS, Khanania Mar Dinkha IV was born and baptized in the Church of Mar Qaryaqos which is located in the village of his birth, Darbandokeh, Assyria; and

WHEREAS, on July, 15, 2007, Patriarch Khanania Mar Dinkha celebrated Fifty years of his priesthood. A ceremony was held at Saint George Cathedral in Chicago. In his honor a portion of Ashland Avenue was renamed "His Holiness Mar Dinkha IV Blvd." Later, in 2008, he received an honorary degree from the University of Chicago; and

WHEREAS, Patriarch Khanania Mar Dinkha IV's funeral service was held on April 8, 2015 at Saint George Church in Chicago; hundreds of thousands of the Assyrian diaspora throughout the world participated through a live broadcast by Assyrian National Broadcasting; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Cook County, on behalf of the 5.2 million residents of Cook County commemorates the extraordinary life of His Holiness Khanania Mar Dinkha IV, and herewith expresses its sincere gratitude for the invaluable and innumerable contributions he has made to the Citizens of Cook County, Illinois; and

BE IT FURTHER RESOLVED, that a suitable copy of this resolution be spread upon the official proceedings of this honorable body and that an official copy of the same be tendered to the Holy Apostolic Catholic Assyrian Church of the East to commemorate the extraordinary life and legacy of his Holiness Khanania Mar Dinkha IV.

WHEREAS Francis Cardinal George earned two doctorates, spoke Italian, Spanish, French and other languages, wrote several books, and was a member of the Missionary Oblates of Mary Immaculate, eventually helping lead the religious order as vicar general based in Rome, and

WHEREAS In 1990, Francis Cardinal George was appointed Bishop of Yakima, Washington and then Archbishop of Portland, Oregon, and

WHEREAS Francis Cardinal George will be remembered as a man of devout faith, courage, and unwavering leadership, and

RECOGNIZING APRIL 2015 AS AUTISM AWARENESS MONTH

WHEREAS, Nearly a quarter century ago, the Autism Society launched a nationwide effort to promote autism awareness, inclusion, and self-determination for all, and assure that each person with autism is provided the opportunity to achieve the highest possible quality of life, and

WHEREAS, Autism is a spectrum disorder, which means that no two people with autism are affected in the same way, and it is a complex developmental disability that usually appears during the first three years of life, and

WHEREAS, Autism results in a neurological disorder that affects how the brain functions as well as the development of social and communication abilities, and

WHEREAS, One in 68 children is diagnosed with this spectrum disorder and its prevalence has increased thirty percent since 2008, and

WHEREAS, It is estimated that 1,500,000 people live with autism spectrum disorder in the United States, and

WHERAS, the Autism Society estimates that the United States is facing almost \$90 billion annually in costs for autism, and

WHEREAS, while a single specific cause of autism is not yet known, current research links it to biological or neurological differences in the brain, and outdated theories and myths, such as autism being a mental illness, have been scientifically proven to be false, and

WHEREAS, with support and understanding, people with autism can live full lives and make meaningful contributions to society; and

NOW, THEREFORE, BE IT RESOLVED that the Cook County Board of Commissioners does hereby recognize April 2015 as Autism Awareness Month in Cook County; and

BE IT FURTHER RESOLVED that this text be spread upon the official proceedings of this Honorable Body, and an official copy of same be presented to the Autism Society of Illinois.
