PROPOSED RESOLUTION

PUERTO RICAN ARTS ALLIANCE

WHEREAS, founded in 1998, Puerto Rican Arts Alliance was created to increase awareness, knowledge and access to the arts by its immediate Puerto Rican community. Initially serving the Northwest Side of Chicago, PRAA's service area expanded to include Metropolitan Chicago. PRAA now draws legions of visitors and artists from the East to West coasts; and

WHEREAS, spearheaded by Carlos Hernandez, Founder and Executive Director, PRAA remains dedicated to preserving Puerto Rican culture by upholding their traditions, advocating their arts and administering educational opportunities in these arts, encouraging the cultivation of pride in the heritage of future generations to come; and

WHEREAS, guided by four core principles of: preserving and promoting the traditions, culture and art of Puerto Rico, advocacy of intercultural understanding and appreciation, reinforcement of Puerto Rican intergenerational understanding and instilling ethnic pride within the Puerto Rican community, PRAA remains dedicated to promoting the richness and diversity found in its native Taíno Indian, Spanish and West African roots; and

WHEREAS, now a major broker of Puerto Rican arts, through performances, art exhibits and other arts-related educational programs, PRAA has become a beacon to hundreds of thousands of Puerto Ricans in Chicago. PRAA strives to secure donations so that their high quality, impactful programs remain free to all underserved youth; and

WHEREAS, remaining true to their core principles, PRAA students may participate in the Latino Music Project, teaching students how to play violin, the cuatro or the Spanish guitar. Historical and cultural traditions are taught in the Taíno Project and The Three Kings Project. Experimentation with various types of media and art forms can be learned in the Studio Arts Program. An integral part of PRAA, Carlos Hernandez recently completed PRAA's \$2.5 million capital campaign drive to establish and expand the Puerto Rican/Latino Cultural Center in the Logan Square/Avondale community; and

WHEREAS, Carlos Hernandez remains a key leader in cultural programming, fundraising, office operations, board development and volunteer recruitment. He directs El Archivo, an archival effort aimed at documenting the historical migration contribution of the Puerto Rican community, guides its Taíno Project and the exhibition and studio arts programs as well as produces PRAA's annual Emmy Award Winning National Cuatro Festival; and

WHEREAS, PRAA strongly encourages and advocates cross cultural connections among other ethnic groups and diverse audiences throughout the city. Utilizing their ingenious and innovative programs as vehicles to do so, PRAA has partnered with Chicago Public Schools and Chicago Park Districts to offer their music program in 15 Chicago Public Schools and the Humboldt Park Field House. PRAA has

served over 5,000 CPS students to date. Other notable collaborations have also taken place with the National Museum of Mexican Art, DAMA International, The Field Museum and University of Illinois at Chicago.

WHEREAS, Cook County is committed to lending direct assistance to address food access inequalities; And

WHEREAS, as part of these efforts, the Cook County Health & Hospitals System (CCHHS) recognizes that the health of many of our patients are impacted by lack of access to healthy and nutritious foods; and

WHEREAS, CCHHS is working to address this need by piloting a food insecurity screening and connecting patients with food benefit programs and local resources; and

WHEREAS, the Cook County Board of Commissioners believes that no one should go hungry; and joins with the Greater Chicago Food Depository to support the fight to end hunger by wearing orange pins representing the official color of Hunger Action Month.

GLOBAL PULMONARY FIBROSIS MONTH

WHEREAS, Idiopathic pulmonary fibrosis, or simply pulmonary fibrosis, is a serious disorder that creates scarring in the delicate lung tissue of affected patients causing progressive, incurable lung disease; and,

WHEREAS, Pulmonary fibrosis progresses quickly, often causing limited quality of life, disability, and death within a few short years; and,

WHEREAS, In many cases, there is no identified cause of pulmonary fibrosis and approximately 200,000 people in the United States are estimated to be affected by the disease; and,

WHEREAS, Pulmonary fibrosis is often misdiagnosed and under-diagnosed, and a need has been identified to increase wide-ranging awareness and detection of this imperceptible disorder; and,

WHEREAS, the Pulmonary Fibrosis Foundation will unify patients, caregivers, medical professionals, and the general public, by sharing and providing the latest information and advancements alongside all of the work still to be done within the global pulmonary fibrosis community; and,

WHEREAS, established in 2000, the Pulmonary Fibrosis Foundation is a nonprofit organization that maintains a global mission to serve as the trusted resource for the pulmonary fibrosis community by raising awareness, providing disease education, and funding research; the Foundation works diligently to foster conversations and collaboration between everyone affected by pulmonary fibrosis, including those living with the disease, the medical and research community, and the pharmaceutical industry; and,

WHEREAS, the Illinois State Senate adopted an identical resolution on July 15, 2015; and,

NOW, THEREFORE, BE IT RESOLVED, that The Honorable Board President and the Cook County Board of Commissioners, joins the Senate of the Ninety-Ninth General Assembly of the State of Illinois and proclaim September of 2015 as Global Pulmonary Fibrosis Month in the County of Cook to increase awareness of this disease and encourage research into new treatments; and be it further; and,

PROPOSED RESOLUTION

COOK COUNTY RECOGNIZES SEPTEMBER 27, 2015 AS "PUPPY MILL AWARENESS DAY"

WHEREAS, September 27, 2015 is National Puppy Mill Awareness Day, where the National Puppy Mill Project and animal advocates around the country will join together to end puppy mills and their cruelty to animals; and

WHEREAS, pet stores selling live animals, both within the United States and abroad, have traditionally been a sales outlet for young dogs bred commercially in puppy mills; and

WHEREAS, according to the Humane Society of the United States, it is estimated that 10,000 puppy mills produce more than 2,400,000 puppies a year in the United States and that nearly all pet store puppies come from puppy mills; and

WHEREAS, puppy mills are mass-breeding facilities that churn out puppies with an emphasis on profit over welfare. These mills usually house dogs in overcrowded and unsanitary conditions without adequate veterinary care, food, water and socialization. Puppy mill dogs do not get to experience treats, toys, exercise or basic grooming; and

WHEREAS, the inhumane conditions in puppy mill facilities lead to health and behavioral issues as well as congenital and hereditary illness and disease. Puppy mill puppies often arrive in pet stores and their new homes with various diseases including giardia, parvovirus kennel cough, heartworm and distemper. These diseases can lead to excessive veterinary costs both upfront and down the line; and

WHEREAS, the lack of enforcement resources at local, state and federal levels allow many inhumane

puppy mills to operate with impunity. According to a spokesman from the United States Department of Agriculture, due to budget constraints, the Illinois Department of Agriculture employs only seven inspectors that are charged with overseeing more than 1,300 dog dealers, kennel operators and pet shop operators; and

WHEREAS, every year millions of cats and dogs are euthanized in our nation's animal shelters because there are more pets than there are responsible homes for them. Puppy mills contribute to pet overpopulation and cause countless animals lifetimes of suffering in squalid wire cages; and

WHEREAS, according to information obtained from the Illinois Department of Agriculture regarding publicly run animal care and control facilities located within Cook County, in 2011these facilities impounded 19,442 dogs and cats that were not reclaimed by the owner, and euthanized 6,618 of these animals (roughly 34% of total). In 2012 these facilities impounded 22,679 dogs and cats that were not reclaimed by the owner, and euthanized 8,035 of these animals (roughly 39% of total); and

WHEREAS, on April 9, 2014 the Cook County Board of Commissioners unanimously passed a law that limits the retail sale of puppies and kittens in Cook County pet stores to animals sourced from shelters, humane adoption centers and small-scale breeders; and

WHEREAS, across the country, thousands of independent pet stores as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats; many of these stores collaborate with local animal shelters and rescue organizations to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, Cook County residents are encouraged to 'adopt and not shop', because adopting homeless dogs from shelters and rescues helps put us closer to our goal of making Cook County a no-kill community and helps put bad breeders out of business.

NOW THEREFORE BE IT RESOLVED, by the Cook County Board of Commissioners that September 27, 2015 be recognized as "Puppy Mill Awareness Day" in Cook County.
