WHEREAS, God, in his infinite wisdom, saw fit to call Lorraine Jakes from our midst on October 29, 2015, at the age of 81; and

WHEREAS, Lorraine Jakes was born in Chicago to Hollis and Lovie Boggus on September 1, 1934; and

WHEREAS, Lorraine Jakes was the mother of two and enjoyed a career as a pre-school teacher in Chicago; and

WHEREAS, on June 16, 1957, Lorraine married the "love of her life," Paul L. Jakes, who nicknamed his wife "Sweet Lorraine"; and

WHEREAS, after a 25-year career in early childhood education, Mrs. Jakes went back to school along with her husband to study Christian education and graduated with a certificate of studies in Christian Education from the Garrett Evangelical Theological Seminary; and

WHEREAS, Mrs. Jakes, an accomplished pianist, played in the Baptist church for nearly 70 years; and

WHEREAS, Mrs. Jakes gave her life to Christ when she was just 12 years old and began playing for Mount Union Baptist Church, under the pastorate of Rev. Dr. C.W. Jones, at the age of 14. She played the piano at New Tabernacle of Faith for 48 years. The National Baptist Convention honored Mrs. Jakes for her longevity in the musical field; and

WHEREAS, Mrs. Jakes often shared her musical talents by also playing for church worship services, district associations, the Westside Minister's Conference and the National Baptist Congress of Christian Education where she played before an audience of more than 50,000 people. She also played for the evening radio broadcasts of the Mount Carmel Baptist Church; and

WHEREAS, Lorraine Jakes leaves to mourn two sons, Rev. Paul Jakes and Rev. Martin Jakes, and a number of friends and relatives;

WHEREAS, by all accounts, LaQuan McDonald, a resident of the West Side of Chicago and the 1st District of Cook County, was working hard to turn his life around; and

WHEREAS, over the summer of 2014 LaQuan McDonald successfully held down a job; and

WHEREAS, at the time of his death LaQuan McDonald was attending school and succeeding academically; and

WHEREAS, LaQuan McDonald was a young man with potential; and

WHEREAS, LaQuan McDonald's struggles, progress, and his fight to reclaim his future are emblematic of the same struggles faced by so many of the poorest, most vulnerable citizens of Cook County; and

WHEREAS, it is the poorest, most vulnerable citizens of Cook County for whom County government exists to provide a safety net; and

WHEREAS, it is fitting that this body should pause to take recognition of LaQuan McDonald's struggles, LaQuan McDonald's progress, and the single, overriding and incontrovertible truth that LaQuan McDonald's life mattered;

NOW THEREFORE BE IT RESOLVED by the President and the Cook County Board of Commissioners that the deepest sorrow and condolences of this body are extended to the family, friends and community of LaQuan McDonald.

WHEREAS, Wilbert Cook, Jr. also worked as an independent commodity broker and trader, and went on to start his own small business, WC Agency, which specialized in personal and business income taxes and accounting; and

WHEREAS, Wilbert Cook, Jr. later moved to Milwaukee, Wisconsin, where he remained until his passing on November 20, 2015; and

WHEREAS, Wilbert Cook, Jr. is survived and celebrated by his six children, Sheila, Wilbert III, Leonard, Lynette, Andre, and Saboris, his second wife, Katherine Susie, his stepdaughter, Sheila, his two brothers, Joseph and Torrence (Shirley), his devoted friend, Annette Dixon, and a host of grandchildren, great-grandchildren, godchildren, nieces, nephews, in-laws, cousins, and friends;

PROPOSED RESOLUTION

RECOGNIZING AND APPRECIATING THE CONTRIBUTIONS OF JOURNALIST BRANDON SMITH TO THE CAUSES OF TRANSPARENCY AND JUSTICE IN GOVERNMENT

WHEREAS, the Nov. 24 video release of LaQuan McDonald being fatally shot 16 times on Oct. 20, 2014, by a Chicago police officer focused the attention of the City, the State and the country on the need for comprehensive reform in the Chicago Police Department; and

WHEREAS, Brandon Smith, the journalist who filed the Freedom of Information Act request that led to the court-ordered release of the aforementioned video, fought for the video's release out of a commitment to transparency and justice; and

WHEREAS, Brandon Smith began his journalism career in 2007 working as an editorial assistant at the Washington Court House Record-Herald in Ohio where he reported and photographed breaking news stories; and

WHEREAS, in 2009, Brandon Smith moved to Chicago to study journalism at Columbia College, where he worked for The Columbia Chronicle as an assistant sports & health editor; and

WHEREAS, Brandon Smith is committed to the notion of journalism in the public interest, and a form of investigative journalism that fulfills the role of "watchdog" on the public's behalf; and

WHEREAS, Brandon Smith was first made aware through activist William Calloway, that a video existed depicting the shooting of 17-year-old LaQuan McDonald 16 times by Chicago Police Office Jason Van Dyke, and that Officer Van Dyke was unprovoked; and

WHEREAS, Brandon Smith and William Calloway determined the best course of action in order to bring the incident to the awareness of the public at large was to file a Freedom of Information Act (FOIA) request with the City of Chicago to seek the video's release; and

WHEREAS, the City of Chicago initially rejected Brandon Smith's FOIA request, which gave him standing to sue the City of Chicago in Cook County Circuit Court; and

WHEREAS, on November 19, 2015 Circuit Court Judge Franklin Valderrama held in favor of Brandon Smith and ordered the video released; and,

WHEREAS, the release of the dashcam video depicting the police shooting death of LaQuan McDonald has resulted in a necessary and long overdue public debate and movement to make the necessary reforms so that justice in Chicago is administered in a manner that is equal and constitutional, without regard to skin color; and

WHEREAS, if not for the tenacity and commitment of Brandon Smith, this video would not be released, and this difficult but necessary discussion would not be taking place;

NOW THEREFORE BE IT RESOLVED, by the President and the Cook County Board of Commissioners, that Brandon Smith is to be commended for his fierce commitment to justice and transparency, and that the gratitude of the President and the Cook County Board of Commissioners is to be extended to Brandon Smith for his contributions to the ongoing discussion and process of criminal justice reform.

PROPOSED RESOLUTION

RECOGNIZING THE HOUSING AUTHORITY OF COOK COUNTY FOR IMPLEMENTING SMOKE-FREE HOUSING THROUGHOUT ITS MULTI-UNIT HOUSING PROPERTIES

WHEREAS, tobacco use remains the single largest preventable cause of death and disease in the United States, killing more than 480,000 Americans each year with an estimated 42,000 of these deaths from exposure to second-hand smoke; and

WHEREAS, research indicates that there is no risk-free level of exposure to secondhand smoke and only 100% smoke-free environments protect from dangers of second-hand smoke; and

WHEREAS, in order to create 100% smoke free environments, we need to work together to create smoke-free campuses, parks, and homes; and

WHEREAS, Cook County has laws to protect the health of the residents of suburban Cook County, such as the Smoke Free Illinois Act and the Cook County Clean Indoor Air Ordinance (06-O-12) which prohibits smoking in all enclosed public places and places of employment within the County of Cook. This includes all hospital properties and campuses throughout the Cook County Health and Hospitals System, all of which are 100% smoke-free; and

WHEREAS, in an effort to mitigate the irritation and known health effects caused by secondhand smoke, reduce the maintenance, cleaning, and redecorating costs attributable to smoking, and decrease the risk of fire from smoking, all Housing Authority of Cook County developments are implementing smoke-free protections on December 1, 2015; and

WHEREAS, working together, the Housing Authority of Cook County and the Cook County Department of Public Health have educated tenants as to the risks of tobacco use and second-hand smoke, and have established supports for tenants who want to quit smoking; and

WHEREAS, the Housing Authority of Cook County has partnered with the Cook County Department of Public Health-led "Healthy HotSpot" initiative, which builds healthy places in suburban Cook County through community partnerships; and

WHEREAS, all Housing Authority of Cook County tenants will now live in smoke-free environments, including their individual units, all Housing Authority developments have been identified as Healthy HotSpots.

NOW THEREFORE, BE IT RESOLVED that the President and the Cook County Board of Commissioners do hereby applaud the Housing Authority of Cook County for their leadership in protecting the health of their tenants and for promoting smoke-free housing protections throughout suburban Cook County.
