PROPOSED RESOLUTION

CELEBRATING THE 800TH ANNIVERSARY OF THE DOMINICAN ORDER

WHEREAS, 800 years ago St. Dominic was inspired to raise up a new religious order to preach for the salvation of souls and to explore questions of the time that required a deeper understanding of the union between faith and reason; and

WHEREAS, the four pillars of Dominican life are preaching, prayer, study, and community; and

WHEREAS, over the course of eight centuries, the Dominican Order has encompassed theologians and philosophers, such as St. Albert and St. Thomas Aquinas; mystics, such as St. Catherine of Siena and Johannes (John) Tauler; artists, such as Fra Angelico and Michelangelo; humble saints, such as St. Martin de Porres and St. Agnes of Montepulciano; reformers, such as St. Antoninus and Pope Pius V; and prophetic preachers, such as St. Vincent Ferrer and Gustavo Gutierrez; and

WHEREAS, Dominican men and women have been on mission in the United States for more than two centuries. The initial move toward founding a Dominican province in the United States was made by Edward Dominic Fenwick, O.P., an American descendant of early Maryland colonists; and

WHEREAS, since its founding, the Order of Preachers has been associated with centers of learning. Dominican Sisters in the early 1900s attended colleges and universities in increasing numbers at home and abroad and began to establish colleges for young women. The Sinsinawa congregation opened St. Clara College in River Forest (later named Rosary College and then Dominican University), which granted its first bachelor's degree in 1904; and

WHEREAS, today more than 6,500 friars, 4,000 nuns, 35,000 active sisters, and 100,000 lay Dominicans are active in the Dominican Family, spanning more than 100 countries and 41 provinces and vicariates; and

WHEREAS, the twofold motto of the Order continues to be *Veritas*, in a world hungering for truth, and *Caritas*, the equally urgent need for human compassion and mercy; and

WHEREAS, in every age, Dominicans have tried to respond to the signs of the times, always conscious that every generation needs to hear afresh the message of God's love and friendship with humanity; and

WHEREAS, St. Vincent Ferrer Church in River Forest will join Dominican churches and shrines around the world in providing lectures and other special events throughout 2016 to commemorate the 800-year jubilee.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby honor the Dominican Order of Preachers as it celebrates its 800 years of service.

BE IT FURTHER RESOLVED, that a commemorative copy of this resolution be presented to St. Vincent Ferrer Church as it celebrates this momentous occasion.

CONGRATULATING THE PHILLIPS ACADEMY WILDCATS: 2015 IHSA CLASS 4A FOOTBALL STATE CHAMPIONS

WHEREAS, at 111 years old, Wendell Phillips Academy High School is one of the oldest high schools in the City of Chicago, and boasts alumni such as Sam Cooke, Nat King Cole, and Gwendolyn Brooks; and

WHEREAS, on October 27, 2015 the Wendell Phillips Academy Wildcats defeated the Althoff Crusaders (Belleville, IL) 51-7 to complete an undefeated 2015 season and clinch the Class 4A IHSA state football championship; and

WHEREAS, during their record setting run the Wildcats have only trailed once throughout their 2015 campaign, and outscored all opponents 543-87. They have beaten all of their opponents by an average of 35 points per game; and

WHEREAS, the Phillips Wildcats are the first team from the City of Chicago's Public School League to capture a state football championship; and

WHEREAS, the Wildcats are only the third Chicago public high school to reach a IHSA football state finals since the IHSA football playoffs were created in 1974; and

WHEREAS, the Wildcats offense amassed 4,393 rushing yards this season. They were led by junior running back Kamari Mosby (2,246 rushing yards, 18 TDs) and quarterback Quayvon Skanes (1,317 rushing yards, 32 touchdowns); and

WHEREAS, the Wildcats defense only allowed an average of 6.69 points per game. They were led by Chriss Elmore (146 tackles, 22 for loss, 11 sacks) and Amir Watts (128 Tackles, 31 for loss, 7 sacks); and

WHEREAS, all of the team's 19 seniors: Donald Gardner, David Munson, Qadeer Weatherly, Quayvon Skanes, Amani Jones, Chris Mabry, Amir Watts, Devin Jones, Tobias Nellum, Darnell Willis, Calvin Watkins, Christopher Stephens, Kentrell Johnson, Raiken Strong, Gabriel Tyson, Adisen Broughton, Marzeek Williams, Isaac Osei, and Roderick Clay, are on track to graduate; and

WHEREAS, the Wildcats are led by their head coach, Troy McAllister, who began his tenure at Phillips in the spring of 2009.

NOW, THEREFORE, BE IT RESOLVED by the President and the Cook County Board of Commissioners that we, along with the citizens of Cook County, congratulate the 2015 Wendell Phillips Academy Wildcats on their 2015 IHSA state championship and perfect season; and

WHEREAS, the quick thinking and focused response of the officers is particularly impressive given that it was police officer Picicci's first day on the job.

RECOGNIZING AND COMMENDING THE CONTRIBUTIONS OF COOK COUNTY RESIDENTS TO ALLEVIATING THE WATER CRISIS IN FLINT, MICHIGAN

WHEREAS, the drinking water of the City of Flint, Michigan became contaminated with lead in April 2014, during a period wherein the city was under the control of a state-appointed emergency manager; and,

WHEREAS, that state-appointed emergency manager, in an effort to cut costs, made a decision to temporarily draw Flint's water from the Flint River instead of Lake Huron; and,

WHEREAS, in drawing Flint's water from the Flint River, the Michigan Department of Environmental Quality has conceded that it failed to treat that water with the chemicals needed to ensure that water's safety, thereby causing lead to leach from pipes and fixtures into Flint's drinking water; and,

WHEREAS, the presence of lead in Flint's drinking water has led to a public health crisis, resulting in 8,657 children being exposed to lead; and,

WHEREAS, children are more susceptible to lead poisoning than adults; and,

WHEREAS, the People of Flint continue to deal with restrictions on access to water and health concerns, and the ongoing crisis has seized the attention of the nation; and,

WHEREAS, in Cook County, many residents have shown exemplary citizenship by stepping forward to assist the residents of Flint, Michigan in their hour of need; and,

WHEREAS, Chicago firefighter Eric Washington organized a team of friends to collect donations of bottled water for the people of Flint, Michigan; and,

WHEREAS, Firefighter Washington created a web page with the website GoFundMe hoping to raise some money in order to buy bottled water for residents of Flint, Michigan, and ultimately raised \$17,000.00; and,

WHEREAS, in addition to the money raised through GoFundMe, Firefighter Washington continued to collect bottled water in person for the people of Flint, Michigan; and,

WHEREAS, Firefighter Washington has stated that he views his service to the people of Flint as an extension of his public service as a firefighter, expressing the need to help others beyond just the hours

he spends on the job; and,

WHEREAS, on the West Side of Chicago and in the near West Cook suburbs, at least a dozen pastors and clergy joined to form the Water for Life campaign, collecting more than 1,000 cases of water to deliver to the people of Flint by truck; and,

WHEREAS, those pastors and clergy including Reverend Cy Fields of New Landmark Missionary Baptist Church, Reverend Ira Acree of Greater St. John Bible Church, Reverend Marshall Hatch of New Mt. Pilgrim Church, and Rabbi Max Weiss of Oak Park Temple, have committed to follow up their collection of water with continued and sustained outreach to the people of Flint, Michigan; and,

WHEREAS, on the South Side of Chicago, Sweet Holy Spirit Church, under the leadership of Bishop Larry Trotter, held a seven-day drive to collect bottled water for the people of Flint; and,

WHEREAS, members of Sweet Holy Spirit Church collected 160,000 bottles of water for the people of Flint; and,

WHEREAS, on February 3, 2016, the 160,000 bottles of water collected by the members of Sweet Holy Spirit Church were loaded onto two trucks donated by the Custom Companies Trucking Firm and transported to Flint, Michigan; and,

WHEREAS, officials with the Village of Maywood have led an effort to collect bottled water for the people of Flint, Michigan and have contributed bottled water to the residents of Flint; and,

WHEREAS, the acts of compassion and service undertaken by the aforementioned individuals and groups represent the very best of the people of Cook County;

NOW THEREFORE, BE IT RESOLVED by the Cook County Board of Commissioners and the Cook County Board President that the aforementioned residents of Cook County are to be commended for their compassion and their service to the people of Flint, Michigan; and,
