WHEREAS, Newton N. Minow served as Law Clerk to Chief Justice Fred M. Vinson of the U.S. Supreme Court in 1951 and then Assistant Counsel to Illinois Governor Adlai Stevenson in 1952; and

WHEREAS, Newton N. Minow was appointed by President John F. Kennedy as Chairman of Federal Communications Commission in 1961; and

WHEREAS, Newton N. Minow is the Walter Annenberg professor emeritus at Northwestern University and the Honorary Consul General of the Republic of Singapore; and

WHEREAS, Newton N. Minow is the author of four books and the recipient of 14 honorary degrees; and

WHEREAS, Newton N. Minow is the recipient of numerous awards including: the American Bar Association Silver Gavel Award, the Chicago Bar Association John Paul Stevens Award, the Federal Communications Bar Association Lifetime Achievement Award and the American Lawyer Lifetime Achievement Award;

WHEREAS, God, in his almighty wisdom, saw fit to call Philip J. Rock from our midst on January 28, 2016, at the age of 78; and,

WHEREAS, Philip J. "Phil" Rock was born "a Catholic, a Democrat and a Cubs fan-but not necessarily in that order" on May 4, 1937, to the late Joseph and Kathryn Rock in Chicago, Illinois; and,

WHEREAS, Phil Rock attended Quigley Preparatory Seminary followed by the University of St. Mary of the Lake in Mundelein, Illinois; and,

WHEREAS, Phil Rock received his law degree from Loyola University School of Law in Chicago; and,

WHEREAS, following his graduation from law school, Phil Rock began his legal career with the Office of the Illinois Attorney General as an Assistant Attorney General, working under the Honorable William G. Clark, and then for the Cook County State's Attorney as an Assistant State's Attorney; and,

WHEREAS, in 1970, Phil Rock was elected to the Illinois State Senate where he proudly served for twenty two years, the last fourteen of which were as President of the Senate; and,

WHEREAS, Phil Rock, the legislator, was a champion for the voiceless and the powerless, and this commitment to serving the downtrodden earned him a reputation among his colleagues as a true public servant and statesman; and,

WHEREAS, Phil Rock was most proud of the legislation that he sponsored to establish a school for the deaf and blind that is located in Glen Ellyn, Illinois and was dedicated in 1988 as the Philip J. Rock Center and School; and,

WHEREAS, Phil Rock was respected and admired by members of the General Assembly on both sides of the aisle and had a positive influence on the lives of the many people who served on his legislative staff; and,

WHEREAS, following his retirement from the Illinois General Assembly, Phil Rock returned to his private law practice with his best friend and law partner, Daniel R. Fusco, at Rock, Fusco & Connelly, LLC in Chicago; and,

WHEREAS, Phil Rock was a member of many professional and community organizations and served on numerous charitable and philanthropic boards; and,

WHEREAS, Phil Rock is survived by his devoted wife of fifty-one years, Sheila, as well as his children, Kathleen (Stephen) Snow, Meghan (Todd) Simmons, Colleen (John) Mueller, and John J. "Jay" (Lauren); and,

WHEREAS, Phil Rock was most proud to be a "Papa" to his grandchildren: Emily, Erin, Lily and Ellie Snow; Kyleigh, Connor and Maggie Simmons; Jack, Owen and Kate Mueller; and, Julia and Sarah Rock; and,

HONORING THE LIFE OF JOHN JOSEPH "JOHNNY" LATTNER

WHEREAS, Almighty God, in his infinite wisdom, saw fit to call John Joseph "Johnny" Lattner from our midst on February 13, 2016, at the age of 83; and,

WHEREAS, Johnny Lattner enjoyed the distinction of being the only Chicago native to win the Heisman Trophy; and,

WHEREAS, Johnny Lattner also enjoyed the distinction of being one of the greatest athletes ever to grace the halls at Fenwick High School in Oak Park, Illinois; and,

WHEREAS, John Joseph "Johnny" Lattner was born in Chicago on October 24, 1932; and,

WHEREAS, following his achievements as an all-state high school football player, Johnny Lattner received numerous athletic scholarship offers, finally deciding to play for Coach Frank Leahy at Notre Dame; and,

WHEREAS, during his football career at Notre Dame, Johnny Lattner made his mark as a versatile halfback, winning the Heisman Trophy in 1953 during a season in which the team went undefeated; and,

WHEREAS, Johnny Lattner was a two-time all-American and was inducted into the College Football Hall of Fame in 1979; and,

WHEREAS, Johnny Lattner played one season in the National Football League as a member of the Pittsburgh Steelers in 1954; and,

WHEREAS, Johnny Lattner's professional football career was cut short by his service in the United States Air Force; and,

WHEREAS, following his Air Force service Johnny Lattner coached high school football in Wisconsin and worked as an assistant football coach at the University of Denver; and,

WHEREAS, Johnny Lattner subsequently achieved success in the restaurant business as the owner of two establishments, Johnny Lattner's Steakhouse, and Johnny Lattner's Marina City; and,

WHEREAS, Johnny Lattner later became Vice President of Sales for Pal Graphics in Broadview, Illinois; and,

WHEREAS, Johnny Lattner was a frequent and beloved participant in Chicago's St. Patrick's Day parade, often donning a kilt and green stockings for the occasion; and,

WHEREAS, Johnny Lattner is survived by his wife, Peggy, his sons Jack, Bill, Tim and Mike, his daughters Kate, Maggie, Tricia and Gretchen, and many grandchildren;

NOW THEREFORE BE IT RESOLVED, by the Cook County Board of Commissioners and the County Board President that the deepest condolences of this body are extended to the family of Johnny Lattner; and.

PROPOSED RESOLUTION

HONORING THE 90th BIRTHDAY OF THE HONORABLE ABNER MIKVA

WHEREAS, on January 21, 2016 Abner Mikva celebrated his 90th birthday. Joining in the celebration were countless citizens of Cook County and the United States who have, over the years, honored his distinguished legal career and life-long commitment to social justice. Numerous admirers and well-wishers celebrated a man who has served with distinction in top positions in every branch of government; and

WHEREAS, Abner Mikva was born in Milwaukee, Wisconsin. Abner Mikva attended the University of Chicago Law School, from which he received his Juris Doctorate in 1951. After graduation he clerked for United States Supreme Court Justice Sherman Minton; and

WHEREAS, Abner Mikva spent ten years in the Illinois House of Representatives. While in Springfield he pushed for fair housing laws and for reforms of the state criminal code. Next, the voters elected him to the United States Congress. He first represented the 2nd District covering Hyde Park and later the 10th district covering the north suburbs of Chicago in the United States Congress; and

WHEREAS, Abner Mikva's sound wisdom and advise is regularly sought locally, nationally and globally. He was nominated by President Jimmy Carter to the D.C. Circuit Court of Appeals where he served until his retirement from the court as chief judge. As a judge on the D.C. Circuit, he ardently defended free speech and consumer rights in his opinions, and he was among the first to reject the discriminatory Justice Department policy of expelling openly gay service members, long before this view was politically popular. Throughout his career, Mikva consistently promoted issues concerning social justice and the public welfare; and

WHEREAS, Abner Mikva left the bench to become White House Counsel to President Bill Clinton; and

WHEREAS, Abner Mikva was selected to a special committee to investigate a tragic fire in 2003 at the Cook County Administration Building; six employees were trapped in smoke-filled stairwells by doors that locked behind them; and

WHEREAS, Abner Mikva was an international election monitor of Ukraine's contested presidential election and was named chair of the Illinois Human Rights Commission by the governor of Illinois; and

WHEREAS Abner Mikva helped shape the next generation of lawyers through teaching law at Northwestern University School of Law. He later returned to the University of Chicago Law School, where he served as the Schwarz Lecturer and the senior director of the Mandel Legal Aid Clinic; and

WHEREAS, Abner Mikva and his wife Zoe started a civic leadership program called Mikva Challenge, which challenges high school students throughout the Chicagoland area to be active participants in the political process through elections, community problem solving, and policy-making programs. Thousands of high school students get deeply involved in the democratic process working as election judges, volunteering on campaigns, advising city officials, and creating local activism projects to improve their schools and communities; and

WHEREAS, Abner Mikva and his wife Zoe are the proud parents of three extraordinarily accomplished daughters who have each continued the family's proud legacy of commitment to service. Laurie Mikva was nominated by President Obama to be a board member at the Legal Services Corporation and is Clinical Assistant Professor of Law at Northwestern University School of Law. Dr. Rachel Mikva is a congregational rabbi and is the Rabbi Herman E. Schaalman Associate Professor of Jewish Studies and Director of the Center for Jewish, Christian and Islamic Studies at the Chicago Theological Seminary; and

WHEREAS, Abner Mikva's accomplishments and recognitions are so numerous they would fill volumes and he is routinely singled out for distinction and honors. In addition to many others, he received the Chicago History Museum "Making History Award" for Distinction in Public Service. He received the Thurgood Marshall Award from the American Bar Association.
