PROPOSED RESOLUTION

HONORING THE OAK PARK-RIVER FOREST INFANT WELFARE SOCIETY AS IT CELEBRATES ITS 100TH ANNIVERSARY

WHEREAS, the Infant Welfare Society (IWS) was started in December of 1902 after a baby died from diphtheria in his father's arms on the streets of Chicago. For the next decade the IWS worked to distribute clean milk for free or below cost to infants; and

WHEREAS, the Oak Park-River Forest Infant Welfare Society began in 1916 as an association of Chicago-area women who support the IWS Children's Clinic in its mission to provide all children with unfettered access to quality health care; and

WHEREAS, since its inception, the IWS has been organized around "circles," which are small groups of women who join together to support the society's mission through fundraising and volunteering; and

WHEREAS, currently, the Oak Park-River Forest IWS consists of 150 members in eight circles, each with its own personality and traditions; and

WHEREAS, the society's work is powered by dedicated members and volunteers, a highly competent professional staff, generous donors, engaged partners, and enlightened communities who share the view that sustaining the health of our children is a critical investment in the future; and

WHEREAS, in addition to its recurring fundraising events, the Oak Park-River Forest IWS is taking on special centennial events, including a business luncheon in March at Dominican University, a block party for children and families in May, and a dinner in September.

NOW, THEREFORE, BE IT RESOLVED, that the Cook County Board of Commissioners does hereby honor the Oak Park-River Forest Infant Welfare Society as it celebrates its 100 years of dedicated service to the health of children.

BE IT FURTHER RESOLVED, that a commemorative copy of this resolution be distributed to the Oak Park-River Forest Infant Welfare Society on the occasion of its 100th Anniversary.

PROPOSED RESOLUTION

HONORING THE MEMORY OF HENRY RAYMOND STINSON

WHEREAS, Henry Raymond Stinson was born in Meridian, Mississippi on April 26, 1925 to Homer R. Stinson and Mary Savannah Blackwell Stinson; and

WHEREAS, he was the youngest of seven children, three sisters (Pearl, Lillian, and Louise) and three brothers (Leo, Frank, and Homer), all of whom preceded him in death; and

WHEREAS, soon after his birth, his family moved to Chicago and Henry Stinson attended Edmond Burke Elementary School and Du Sable High School; and

WHEREAS, he enlisted in the United States Army at the age of 17 and quickly attained the rank of sergeant; and

WHEREAS, Henry Stinson was a proud and outstanding member of the National Council of Meridianites, Inc., a social organization originally made up of individuals born in Meridian, Mississippi, since its inception in 1967; and

WHEREAS, Henry Stinson in admiration for his father's spirit for business, followed in his father's footsteps and established the Royal Answering Service, whose motto was "Where every customer is King" in the 1970s; and

WHEREAS, shortly after beginning his working career in the United States Post Office, he became a Chicago Police Officer; and

WHEREAS, he worked in several police districts and in various units including Neighborhood Relations, Human Relations, and Special Events; and

WHEREAS, he participated in yearly charitable events and organized the annual Chicago Police Picnic; and

WHEREAS, Henry Stinson's strong belief in being an honest individual and police officer endeared him to the local businesses and residents in the areas that he served; and

WHEREAS, Mr. Stinson's service to his community continued even after completing his work day by delivering baskets of food to those individuals less fortunate; and

WHEREAS, his dedication to serving the people of Chicago is well documented by the numerous awards and accommodations bestowed upon him during his 34 year career; and

WHEREAS, Mr. Stinson's enduring love and commitment to his Wife, his children and his grandchildren shall forever be remembered; and

NOW THEREFORE, BE IT RESOLVED, by the President and Members of the Cook County Board of Commissioners that Cook County shall recognize and honor Mr. Henry Raymond Stinson in celebration of his life and accomplishments; and

WHEREAS, Jean Esch was a leader who firmly supported efficiency in government. She had the unique ability to regularly achieve her goals without rancor and, as a result was genuinely admired and respected by her peers. Her wisdom and critical thinking made her an asset to the city, her pleasant demeanor and sense of humor made her a delightful colleague with whom to work; and

WHEREAS, Jean Esch and her late husband Wilbert moved to Evanston in 1944 and raised their family there; daughters Carol, Barbara, Deborah and Cynthia and sons Lawrence and Donald. She will be sorely missed by her 16 grandchildren, and many great grandchildren, nieces and nephews; and

WHEREAS, a memorial mass was held at St. Mary's Church in Evanston on Saturday, February 13, 2016. Many of the people whose lives she improved celebrated the life of a woman who had such a positive impact on the community; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Commissioners of Cook County, on behalf of the 5.2 million residents of Cook County commemorates the extraordinary life of Jean Esch and herewith expresses its sincere gratitude for the invaluable contributions she has made to the Citizens of Cook County, Illinois; and
