WHEREAS, Morgan F. Murphy Jr. was born on April 16, 1932, to Morgan F. Murphy and Anne Murphy Sr., dear bother of Mary Rita (Robert) Stump, Jane (the late Raymond) Holmes, Bernard (Virginia) Murphy, the late Reverend John Michael Murphy, and Sister Carol Ann Murphy, RSM; and

WHEREAS, Morgan F. Murphy Jr. was the adored husband of the late Charlene Diane (Jurgensen); loving father of Morgan III, Michelle (Dan Hebert), Constance (Larry Doody), father-in-law of the Honorable Lisa Ruble Murphy; grandfather to Morgan F. Murphy, IV, Brendan P. Murphy, Riley P. Doody, Brieanne E. Hebert, and

WHEREAS, Morgan F. Murphy Jr. attended Chicago parochial schools and later Northwestern University in 1955 and was a member of Sigma Chi Fraternity, and he received a Juris Doctorate degree from DePaul University School of Law in 1962, and

WHEREAS, Morgan F. Murphy Jr. proudly served his county as a 1st Lieutenant of the United States Marine Corps from 1955-1957, including a one-year tour of duty in the Far East, and

WHEREAS, Morgan F. Murphy Jr. was an administrative assistant to Clerk of the Circuit Court of Chicago from 1958-1961, and commenced practice in Chicago, and

WHEREAS, Morgan F. Murphy Jr. was a Special Attorney for the Board of Election Commissioners, for the 1964 at-large elections, and

WHEREAS, Morgan F. Murphy Jr. was an attorney for the Chicago Dairyman's Association during the 1968 milk strikes, and a trustee-management representative of the Milk Wagon Drivers Union, and

WHEREAS, Morgan F. Murphy Jr. as a member of the United States House of Representatives from 1970-1980, were he served on the Rules Committee, Permanent Select Committee on Intelligence, Select Committee on Narcotics and Drug Abuse Control, Foreign Affairs, and as Chairman of the Subcommittee on Legislation, and,

WHEREAS, Morgan F. Murphy Jr. was a hearing officer for Local Liquor Control Commission, 1969-1970 and delegate to the Democratic National Conventions in 1968 and 1972, and

WHEREAS, Morgan F. Murphy Jr. served as a Board Member of the Cook County Zoning Board of Appeals from 2005-2014, and

WHEREAS, Congressman Morgan F. Murphy Jr, received the Central Intelligence Agency Award from the Director, Admiral Stansfield Turner, for outstanding leadership in legislative work for the CIA and intelligence communities in 1979, and

WHEREAS, Congressman Morgan F. Murphy Jr, received many honors including the Chicago South Chamber of Commerce Annual Award for Midway Airport Reactivation in 1978, the Catholic Man of the Year Award in 1976, and Catholic Lawyers Guild of Chicago's Lawyer of the Year Award in 1977, and

WHEREAS, Morgan F. Murphy Jr. will be remembered for his generosity, kindness and larger than life personality, and

WHEREAS, Morgan F. Murphy Jr's enduring love and commitment to his wife, his children and his grandchildren shall forever be remembered; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Cook County that the Board does recognize and honor the life and accomplishments of Morgan F. Murphy Jr ; and

WHEREAS, Mr. English served as the treasurer of the Black Panther Party; and

WHEREAS, along with his family Mr. English briefly left Chicago, for New York, where he would study at Cornell University. He would later return to Chicago and take a job as a health-care executive; and

WHEREAS, Mr. English played key roles behind-the-scenes in efforts that included voter-registration initiatives that helped elect Harold Washington as mayor in 1983. He also worked to preserve the buildings at the South Shore Country Club and transform them into the South Shore Cultural Center; and

WHEREAS, in 1983 Mr. English founded the Black United Fund in Chicago. The Black United Fund raises charitable donations to provide grants and expertise to small not-for-profit groups and programs for job training; and

WHEREAS, Mr. English is survived by his wife, Denise; two sons: Nkrumah and Jummane; and two daughters: Kenya and Kamillah.

WHEREAS, in 2015 the Huskies edged Sandburg High School 39-16 to claim the 3A dual-team tourney title and also produced three individual state champions in Jason Renteria, Isaiah White, and Allen Stallings and 6 more top-six, All-State finishers and two additional state qualifiers; and

WHEREAS, the Huskies have won four state championships over the last eight years, including two undefeated teams (28-0 in 2015; 24-0 in 2009); and

WHEREAS, nationally, OPRF finished as the top-ranked team in the country in 2016, per high school wrestling website IllinoisMatMen; and

WHEREAS, Huskie student wrestler Isaiah White has gone 3-0 in addition to his program-best three individual state titles. Isaiah was also the first Huskie student wrestler to win a title at the Walsh Ironman in 2015; and

WHEREAS, the Huskies overcame significant challenges off the mat on the way to their 2016 title. Just days before the tournament, junior Deundre Garner tragically lost his older brother Diamond to gun violence. Despite this setback, Deundre attended the tournament and wrestled, beating his opponent 8-5; and

WHEREAS, after the tournament, Coach Paul Collins paid tribute to Deundre's courage and commitment, praising the young man for showing up and competing in the face of adversity; and,

WHEREAS, Oak Park and River Forest High School senior and Huskie student wrestler Allen Stallings captured the focus and inner strength necessary to succeed in the Huskie wrestling program when he said "It's 10 times better winning a team state title than individual. These are my brothers. These are the guys I work with all year. Even though wrestling is an individual sport, it's really all about the team at the end of the day";

WHEREAS, almighty God, in His infinite wisdom, has called a champion of civil rights and public health, Dr. Quentin Young from our midst; and

WHEREAS, Quentin Young, the son of immigrants, grew up on the South Side of Chicago and graduated from Hyde Park High School; and

WHEREAS, Quentin Young received a bachelor's degree from the University of Chicago in 1944, despite his studies being interrupted by his Army service during World War II. In 1947 Dr. Young received his medical degree from Northwestern University; and

WHEREAS, Dr. Young began his medical training at Cook County Hospital before leaving for Michael Reese Hospital in 1952; and

WHEREAS, Dr. Quentin Young eventually returned to Cook County Hospital as the "Chairman of Medicine" in 1972, a role he retained until 1981. There he worked tirelessly to improve the County's public healthcare system and its ability to help the poor and underserved; and

WHEREAS, in addition to leadership positions within Cook County-Dr. Young served as President of the Chicago Board of Health and the American Public Health Association, and he co-founded the Health and Medicine Policy Research Group; and

WHEREAS, Dr. Young was also busy agitating and fighting for social change. He volunteered to register black voters during Mississippi's Freedom Summer in 1964; and marched from Selma, Alabama to Montgomery, Alabama in 1965; and

WHEREAS, Dr. Young provided medical care to Martin Luther King Jr. during his stops in Chicago, as well as to campaign volunteers, civil rights workers, and anti-war protesters as founder of the Medical Committee for Human Rights; and

WHEREAS, Dr. Young is survived by two sons: Michael and Ethan; three daughters: Nancy, Polly, and Barbara; and two stepchildren: William and Karen Weaver. His wife, Ruth, passed away in 2007.

A RESOLUTION IN SUPPORT OF FRIENDS OF CHICAGO RIVER'S OVERFLOW ACTION DAYS

WHEREAS, the Chicago River system, including the Calumet River, is an important ecosystem that provides home to wildlife; a natural escape from urban pressure; and a corridor for fish, wildlife, and people to move through both urban and suburban neighborhoods, and

WHEREAS, Stormwater runoff and sewer overflows threaten the health of the Chicago River system; and

WHEREAS, As little as .3 inches of rainfall within the Chicago River sewershed can cause a sewer overflow, flushing harmful pollution such as untreated sewage and street debris directly into the Chicago River; and

WHEREAS, Heavy rains can also cause flooding and widespread property damage, and

HONORING PEPE VARGAS - FOUNDER & EXECUTIVE DIRECTOR OF THE CHICAGO LATINO FILM FESTIVAL & THE INTERNATIONAL LATINO CULTURAL CENTER OF CHICAGO

WHEREAS, Pepe Vargas grew up in a small town in Colombia and in 1976, received his degree in Law & Social Sciences from the National University of Buenos Aires in Argentina; and

WHEREAS Pepe Vargas arrived in Chicago in 1980 with only a few dollars in his pocket and without speaking much English earned a degree in Broadcast Journalism & Television/Film production from Columbia College Chicago in 1985; and

WHEREAS, Pepe Vargas founded the Chicago Latino Film Festival in 1985 with a budget of \$10,000, an audience of 500 and 14 films projected on a wall; and

WHEREAS, since 1986, the Chicago Latino Film Festival has evolved into the largest Latino film festival in the U.S. and is now Chicago's biggest International Latino cultural event; and

WHEREAS, after 32 years the Chicago Latino Film Festival has grown its audience to more than 70,000 people who enjoy the multinational, cross-cultural exchanges offered every year; and

WHEREAS, building on the success of the Film Festival, Pepe Vargas created the International Latino Cultural Center of Chicago to showcase the boundless multinational talent of Latino artists and the Center prides itself for its outstanding multidisciplinary and international cultural programming that includes a wide variety of art forms from Latin America, Spain, Portugal and the United States; and

WHEREAS, Pepe Vargas has served as a juror in various film festivals in Latin America and Spain, and as a media panelist for several institutions including the Illinois Arts Council and the Chicago Department of Cultural Affairs, amongst others and served as a trustee of the Illinois Humanities Council; and

WHEREAS, Pepe Vargas has received many recognitions and awards, including Chicago Tribune's Chicagoan of the Year 2003 and an Honorary Doctoral Degree from Lake Forest College and was one of the two winners of the Chicago Community Trust 2006/7 Fellowship for Community Leaders, which allowed him to travel extensively through Latin America, Spain, France, and the United States visiting other cultural institutions and in 2011, the Chicago Tribune named Pepe Vargas as a Remarkable Person, and in December of 2015 Crain's Chicago featured him in their "Take Away" column; and
