Budget and Management Services has received all requisite documents, and determined the fiscal impact on Cook County, if any.

Summary: Requesting authorization to renew a grant in the amount of \$927,784.00 from the Illinois Criminal Justice Information Authority for the Law Enforcement Prosecutor Based Victim Assistance Program. The grant will provide funding for a total of 13 victim specialists including two (2) Juvenile Court Specialists who are dedicated to serving victims of juvenile offenders, one (1) TAC Specialist who provides direct services to victims of high-risk domestic violence, seven (7) Victim Generalists who provide services to victims of all types of felony crimes, one (1) Polish-Speaking Specialist, and two (2) Spanish-Speaking Specialists who provide services to non-English speaking victims. In addition grant funds will support (1) part-time Law Clerk who will be inputting and maintaining data into the Victim Witness database.
