The recent uptick in Anti-Semitic actions here at home is beyond alarming. Last week, the JCC Association of North America reported that, since January, over 160 bomb threats were called into JCCs and Jewish Day Schools throughout the United States and Canada. This includes two JCCs in Chicago-land, one in Hyde Park and a second in Lake Zurich, and a bomb threat just yesterday called into the Chicago Jewish Day School in Edgewater.

Other recent attacks include a swastika carved into a bench at the Illinois Holocaust Museum in Skokie and the vandalism at the Loop Synagogue, right around the corner, where the window was broken and a swastika written on the front door.

The FBI reported 5,818 hate crimes in 2015, up about 6% from the previous year. Jews, who are just 1.7% of the US population, are the target of more than 50% of all religious hate crimes. The FBI also reported Anti-Muslim hate crimes increased by 67%.

As Jews, we take seriously our responsibility to speak out against hatred, not only because the security of our own community is intertwined with that of other minority communities, but also because our moral values, as Jews and as Americans, demand it.



Since 1975, the Jewish Federation has been the administrator of the Illinois Refugee Social Service Consortium and, through this work, have resettled over 125,000 refugees from all over the world fleeing persecution.

We are proud advocates that speak out against actions of hate, bigotry and Anti-Semitism.

I testify before you today to assure you that the Jewish Federation stands with all communities who are being targeted by hate and challenge those who seek to divide, demonize and intimidate our communities.

During the Holocaust, Jews lived through a time of fear-mongering, scapegoat-ing, and propaganda. As a Jewish people, we have a responsibility to resist efforts to push out religious and ethnic minorities' right here at home based on these very same principles.

For these reasons, we fully support and commend Cook County for taking a stand against hate and violent actions towards Jew and Muslims.

As the residents of Cook County are rich in ethnic, cultural, and religious diversity, we all have an obligation to stand up for one another, as neighbors, and push back against hate.
