In my opinion, the beverage tax fails to address the reason it was established: obesity in general and the health problems sugar causes in adults and children, because sweetened beverages are just a fraction of a host of products people choose to consume in excess on a daily basis that contribute to obesity and health problems. So imposing a beverage tax is as ineffective in addressing those issues as the current penalty for drug possession is in stemming drug abuse, because a person addicted to sugar will seek to acquire it whatever way they can just like any other addict, i.e.: by continuing to consume excessive amounts of cookies, cakes and candies. This makes it obvious that sweetened beverages are not the only things people rely on to satisfy the sugar cravings that contribute to their obesity and health problems. So the beverage tax comes off as nothing more than a deceptive means of gaining revenue, a prelude to the imposition of other consumer taxes, and an ineffective means of addressing obesity and the host of health issues specifically related to excess sugar consumption. Therefore the Cook County beverage tax should be repealed immediately.
