If I were to summarize my opposition to changes to the current sweetened beverage tax, it would be this statement: "If this tax is enough to upset you, you are drinking way (way) too many sweetened beverages." My family happily pays the few extra pennies for our grape sodas, fizzy sodas, Diet Cokes and root beer floats--which are all treats in our house--and we enjoy juice, fizzy water, and tap water the rest of the time. For our family of four, the sweetened beverage tax is a tiny expense, and we are pleased that these funds are invested in necessary programs for the people of Cook County. A cola company makes soda for next to nothing and charges us \$1.00, and, for our carbonated water, high fructose corn syrup, aspartame, and caramel color, we get nothing in return but health risks. Cook County charges us a few pennies more, and we get much needed services for our community and a slight incentive to make healthier choices for our beverages. Let's keep this healthy revenue source, encourage healthier drinks, and enjoy our beverages with a little funding coming back to our communities. Please do not repeal!
