Good Morning Commissioners. Thank you for the opportunity to provide testimony in support of the proposed Sweetened Beverage Tax.

My name is Marti Smith. I am a Registered Nurse and the Midwest Lead for National Nurses Organizing Committee/National Nurses United. I speak on behalf of the RNs at CCHHS, as well as 186,000 RNs nation wide.

As RNs, we see rising childhood obesity rates and troubling trends in diabetes and heart disease that normally afflicts those in their later years now affecting school aged children. We also see the costs of these diseases on our communities - in patients who too early become disabled or debilitated by preventable health problems these diseases cause.

Because sweetened beverages are inexpensive and widely available, beverages such as soda are consumed at very high rates. It makes sense - they taste good, they're cheap, and they're heavily marketed to children.

Why focus on soda and other sugary drinks?

Soda and other sugary drinks are the number one source of added sugar in the American diet.

According to the Consortium to Lower Obesity in Chicago Children, by 9th grade, 48.6% of Chicago children are overweight or obese.

In fact, Cook County Health and Hospitals System spent more than \$200 million treating diabetes, obesity, and other diseases caused in part by consumption of sweetened beverages.

In 2015, Berkeley California enacted a very successful Soda Tax, which has already shown positive health effects, including a 21% reduction in consumption - precisely where health officials had hoped to see the largest decrease.

The intent of Cook County Sweetened Beverage tax is to reduce sugary drink consumption by all, which will reduce incidence of diabetes and other negative health impacts.

I've heard what those opposing this tax say. By their logic, as a nurse, more patients would represent job security for us. By that logic, we should advocate to abolish seat belts, helmets, and smoke detectors. Instead, we support your decision which was based on sound health policy, for the good of our children and our community.

This short sighted lawsuit will eliminate \$74 million in revenue for our revenue-starved county, potentially leaving 100s of families without an income. These families support the retailer selling these beverages. But more importantly, the tax will have long-lasting positive impact upon the health of our communities.
