


Mission

The Department of Administrative Hearings was created to allow fair, efficient and impartial hearings of ordinance violations issued by County Departments, such as the Cook County Department of Revenue, the Cook County Forest Preserve, and the Cook County Sheriff.

Program Name: Administrative Hearings (9 FTE):

•Facilitate the adjudication of ordinance violations issued by County departments, agencies, boards and commissions of Cook County.

Program Services:

- •Provide an independent panel of adjudicators authorized to conduct administrative hearings for departments, boards and commissions of the County.
- •Operate in a fair and impartial manner that provides transparency with respect to the proceedings and decisions and to enter findings and orders which are consistent with due process laws and County Ordinances.
- •Conduct training for all departments who issue violation notices and conduct hearings at suburban locations to provide better access for citizens.
- •Identify new organizations whose citations may be heard by the Department of Administrative Hearings.

Department of Administrative Hearings Discussion of 2017 Department and Program Outcomes



- In FY2017, Administrative Hearings continued it's focus on working with the Cook County Department of Revenue (DoR) in adjudicating a backlog of Non-Retailer Use Tax (NRUT) cases.
- Accomplished the completion of the backlog of NRUT cases in July of FY2017 adjudicating approximately 92,956 DoR NRUT cases.
- Administrative Hearings will adjudicate approximately 140,000 cases by end of FY2017 meeting our FY2017 performance target.
- Efficiently adjudicated cases heard with an average cost per case of \$8.92 YTD in FY2017 exceeding our FY2017 performance target of \$10.00.
- Increased efficiencies in average cases disposed of per ALJ hour of 20 cases per ALJ hour YTD in FY2017 exceeding our FY2017 performance goal of 17 cases per ALJ hour.
- Metra Police citations went live in June of FY2017.
- In FY2017 Administrative Hearings entered into interagency agreements with Amtrak Police and BNSF Railway Police to adjudicate citations written under the County vehicle and compliance code.

Department of Administrative Hearings Budget, Cost Analysis, and 2018 Strategic Initiatives & Goals



- In FY2018, the Department of Administrative Hearings will continue to work with county departments, agencies, commissions and other forms of local government to adjudicate violations of the County Code.
- The Administrative Hearings expects to adjudicate approximately 120,000 cases in FY2018, as compared to 140,000 cases in FY2017.
- Projected number of cases heard in FY2018 has decreased due to the completion of the DoR NRUT cases and projected FY2018 budgetary restrictions.
- Administrative Hearings will begin hearing citations written by Amtrak Police and BNSF Railway Police in FY2018. It is anticipated that the Amtrak Police and BNSF Railway Police will issue approximately 150 citations per month.
- In FY2018, Administrative Hearing's strategic initiative will be to extend our services to Mayors and Managers of local municipalities throughout Cook County to form intergovernmental agreements to adjudicate their local municipal violations.
